#### Featured Speaker

Dr. Smith is president-elect of the American Association of Pro-Life Obstetricians and Gynecologists. She grew up in the ghetto on the west side of Chicago, graduated from Cornell University and the Yale University School of Medicine. She completed her residency at Mt. Sinai Hospital in Chicago where she is now on staff. She also works at the Lawndale Christian Health Center in the community of her birth. The Lawndale community has a 50% unemployment rate, a perinatal mortality rate of 29/1000, skyrocketing teenage pregnancy, and 40% of the people in the community live below the poverty line. She is currently pursuing her doctorate in public health at the University of Illinois. Dr. Smith testified in favor of the Partial-Birth Abortion Ban Act (HB 1833) before Congress.

#### **ACTION NOTES**

#### Be a hero

Fewer than 2,000 national delegates will determine the fate of the Republican Party's pro-life platform at the GOP national convention in San Diego this summer. The Planned Parenthood group—Republicans for Choice—will pull out all the stops in its effort to weaken or remove the pro-life plank. Whether the platform survives that assault depends in part on you.

There are a number of ways you can ensure that the GOP's platform, which supports a Human Life Amendment, remains intact. You can help elect delegates who will vote to re-adopt the pro-life platform. You can run for delegate yourself. Also, you can introduce and vote for a resolution supporting the language in the pro-life plank by participating in your local, county and state Republican conventions or caucuses.

The Republican National Coalition for Life (RNC for Life) can provide you with information about the rules in your state and put you in contact with veterans of the platform process. RNC for Life has created a "Pledge of Support" for the pro-life platform that you can circulate among pro-life voters at political and pro-life events and in churches and Bible study groups. The coalition's goal is to have hundreds of thousands of pledges submitted to the Platform Committee at the San Diego convention as a tangible sign of pro-life strength in the Republican Party.

#### Abortion training

The Accreditation Council for Graduate Medical Education (ACGME) has revised its rules governing accreditation of medical training facilities to state: "No program or resident with a religious or moral objection will be required to provide training in, or to perform, induced abortions. Otherwise, access to experience with induced abortion must be part of residency education. This education can be provided outside the institution."

Programs "must not impede residents in their program who do not have a religious or moral objection" and "must publicize such policy to all applicants." *All* residents must be provided "experience with management of complications of abortion."

The ACGME quoted the Catholic Health Association as saying it was pleased that "the revised language removes the burden of direct cooperation with abortion."

Write the Catholic Health Association and point out that indirect cooperation with the teaching of abortion techniques to ob/gyn residents is of equal concern. Why have they not flatly opposed the ACGME revision? Contact: Catholic Health Association, 4455 Woodson Rd., St. Louis, MO 63134.

# From the President's Desk

Finally, the secular news media is slowly beginning to pay attention to what is happening in China. If you have to ask what has been happening, you haven't been reading this or any other pro-life newsletter lately. China's strict enforcement of its one-child per family policy has resulted in forced abortions, mandatory sterilizations, female infanticide, illegal immigrants and abandoned baby girls.

It is the abandoned babies, over a million of them according to reports, that are beginning to garner the world's attention for two reasons. First, if you want to adopt a baby girl and have about \$12,000, the process is relatively easy. Thousands of Chinese daughters are now arriving in the United States and Canada. Secondly, the ones not so fortunate are living in intolerable conditions in substandard orphanages.

The world is looking askance at the treatment of these children. I even heard a commentary on national TV calling for trade sanctions against the Chinese. The closing line was "there isn't anyone who wouldn't break down a door to save a child." A comment some might find ironic coming from a pro-abort journalist.

How can these same media types look at the pictures of a partial-birth abortion and give it their misguided blessings, yet in the same breath condemn child abuse in China? When will they understand that ABORTION is the ultimate child abuse?

## **Hope for Spina Bifida Patient**

t all began on July 20, 1971, after giving birth to our second son. My husband, Wes, and I had never heard of "spina bifida" or any of the other names for the defect that we would soon hear over and over again. (Other names for spina bifida include "cleft spine," "open spine," "neural tube defect" and the one most commonly used, "myelomeningocele.") Then there was "hydrocephalus" and "hipdysplasia" which were related medical conditions.

The pediatrician assigned to our son's case, shared his opinion of Rob's future prognosis. "Your baby will NEVER have any control of his lower extremities and will have probable brain damage," he stated. I will never forget his words. I can still hear them as if they were spoken yesterday. This doctor did not give us any hope. He went on to say that we could choose surgery to close the baby's back or we could leave him alone and he would probably die within six months.

While this mortal physician gave us absolutely no hope, Wes and I knew there was hope through our Great Physician, Jesus Christ.

I often wonder how many infants are allowed to die because their parents were not given an ounce of hope by their doctors. Now, two decades later, I wonder how many babies are killed through abortion because modern technology can detect spina bifida during pregnancy? Those of us in the pro-life movement must educate others to the fact that ALL people have value and ALL people have a right to life.

Remember the prognosis we were given by our pediatrician when Rob was born? Well, let me share the outcome...twenty-four years later.

Rob went through his childhood with many challenges and many operations, some of which he still faces. He was mainstreamed into St. John Lutheran School in Rochester, Michigan. For his high school training, he attended Lutheran High School North in Mount Clemens, Michigan. He joined the Boy Scouts at the age of eight and remained with that organization through high school, achieving the highest award possible—Eagle Scout. Rob holds a full-time job and attends a local community college parttime. He has been much like our other three children to raise. (Sometimes he drove us nuts, but usually he was a joy.)

In conclusion, I have met other children and adults who have spina bifida as well as other birth defects. Some are confined to wheelchairs and some depend on leg braces and crutches. They are all "normal" people who have learned to live life with extra challenges. They all have love and smiles to share. They all have purpose. They all have value. They are all loved by our Lord and Redeemer, Jesus Christ.

(Author's note: We do not intend to offend physicians by writing this article. We have had many wonderful doctors caring for Rob over the years. This is strictly about our experience following Rob's birth and how that physician handled the situation. It was a matter of life or death.)

# **Sword of Imagination**

The Sword of Imagination —Memoirs of 1/2 Century of Literary Conflict, by Russell Kirk (1918-1994), William B. Eerdman's Publishing Co., Grand Rapids, Michigan, 1995.

e was born in Plymouth, Michigan, two doors from the railroad tracks that intersect Starkweather Rd. in what is frequently called "Lower Town." His railroad engineman father did not finish 6th grade, and his gentle, poetry-loving mother, he was certain, endowed him with his imagination. He is believed by some to have possessed the best conservative mind of this century.


Told in the third person, this is the autobiography of Russell Kirk. It was published the year following his death.

On Palm Sunday, 1971, when Lifespan was called People Taking Action Against Abortion (PTAAA) and was struggling to become recognized in southeastern Michigan as a pro-life entity, Dr. Kirk came as guest speaker in the pro-life cause to the Veteran's Memorial Building in Detroit. He drew 750 interested souls. At that time his fee was \$1000, but he charged PTAAA (Lifespan) nothing. He recalls that occasion toward the end of his book, including a portion of the remarks he made that day.

The occasion will not be forgotten by founding members of Lifespan because a world-renowned figure had stepped forth to give credence to a scorned, despised grassroots movement of little people who continue that struggle 25 years later.

Piety Hill—his ancestral home in Mecosta, Michigan—became certified

through his wife Annette's efforts, as a temporary refuge for unwed mothers. All classes of pregnant waifs enjoyed her hospitality there including her presence at delivery and help for adoption. One of the girls came accompanied by her unpregnant sister—a member of the oldest profession—but the sister was lonely for the street scene and departed suddenly, complaining the place was "too richey" for her.



New waves of the "flotsam and jetsam" of 20th century disorders landed helter-skelter in the U.S. from Vietnam, Ethiopia, India, Poland and all points east and west and they too found their way to Piety Hill. Here they were fed and housed for short or long stays. Children on long stays were entered in the Mecosta school system. Displaced scholars, poets, musicians, painters folk of several colors-joined the international guests, as well as elderly family members and took part in the annual gargantuan Halloween party. One self-styled hobo and prison alumnus served the Kirks intermittently as butler, child tender and raconteur for six years after which he died and was buried respectfully at Piety Hill. Some of the colorful assembly became principals in Kirk's short stories and

His three-year chaste, but determined, courtship of Annette Courtemanche

came to fruition in marriage when he was 44 and she 22. This romance breathes a poignant aura throughout the book. For although he wears no false humility about his own literary feats or philosophical wars with liberalism, he displays abject worship of the young beauty who encouraged and held sway over the awesome community at Piety Hill. This in addition to giving him four daughters who are pictures of herself and obviously inherited the intellectual genes of both parents. His entry into Catholicism came about through his own studies but was formalized just before his marriage to Catholic Annette.

In 1952 he had been awarded the D. Litt. degree from St. Andrews of Scotland which was then held by only one other living person. His dissertation had been published under the title "The Conservative Mind" and became a worldwide best-seller. In this Sword of Imagination, he examines America's politicians of this century and concludes that too many lack imagination, for though many try to solve the problems facing them, they set in motion an array of trouble to haunt the future.

And speaking of haunts, Kirk stubbornly insists that he believes in ghosts and introduces a few who lurked in the musty corridors of old Piety Hill which burned completely on Ash Wednesday, 1975. Kirk was at Olivet College at the time. A few witnesses claimed to have seen ghostly figures at the windows on the fiery scene...

The year before his death, he had come to realize he had sought three objects in his life: The first was to defend the Permanent Things (order, justice, freedom, a moral code, inheritance of culture); the second had been to live a life of decent independence that would leave him free to spread the truth; the third had been to marry for love and to rear children to know that the service of God is perfect freedom.

He had lived with his "one and only wife" for 30 years. It must have seemed to Annette that they were a swift 30 years.

# Partial-Birth Abortion

The Partial-Birth Abortion Ban Act, HR 1833, passed the House November 1 and the Senate December 7. It is anticipated that the House will accept small changes that the Senate made in the bill. Congress is expected to take up this matter late February. HR 1833 will then be sent to the President.

Presidential spokesman Michael McCurry has said President Clinton will veto the bill because he believes "it would represent an erosion of a woman's right to choose."

#### What Can Be Done?

- Write letters to the President and call the White House Comment Line urging Clinton to sign HR 1833.
- Write letters to the editor citing specific facts on partial-birth abortions and the President's yeto.
- Call local "talk radio" shows. Give host and listeners a few specific facts about the abortion procedure and the anticipated veto.
- Distribute factual information through your church and community.

#### **Clinton Care Alert**

Congress and President Clinton are negotiating the Balanced Budget Act, which includes a restructuring of Medicare. The plan the White House is now proposing has many features of the failed Clinton Health Care Rationing Plan. It would make it illegal for Americans over 65 to supplement government Medicare payments with their own money in order to get unrationed, unmanaged health insurance.

It is urgent that you contact your representative and two U.S. senators to voice your opposition to Clinton's plan. Don't let the President turn Medicare into rationed Clinton Care.

#### **Pro-Life Policies**

Of the seven regular appropriations bills that have become law, two restore important pro-life policies:

- 1. Treasury/Postal Appropriations, HR 2020. This bill prohibits federal employees health insurance programs from paying for abortions except to save the mother's life or in cases of rape or incest. Pro-life policy in effect from 1984-1993 is reinstated (with addition of exceptions for rape or incest). President Clinton signed HR 2020 into law November 19, 1995.
- 2. Defense Appropriations, HR 2126. This bill prohibits the performance of privately funded abortions in military hospitals overseas, except to save the mother's life or in cases of rape or incest. This bill restores a policy previously overturned by one of President Clinton's five January 22, 1993 executive orders. The former policy had an exception only for life of the mother; HR 2126 adds exceptions for rape or incest. This bill became law December 1, 1995 without the President's signature.

#### Women's Lives, Abortion's Lies

The Oakland County Chapter of Lifespan is sponsoring an educational program in recognition of Women's History Month, entitled Women's Lives, Abortion's Lies. It will be held on Thursday, March 14, from noon to 2:00 p.m. and from 6:00 to 8:00 p.m., at Oakland University's Oakland Center in Rochester, Michigan.



Oliva Gans

The featured speaker will be Oliva L. Gans. Ms. Gans is the director of Ameri-

can Victims of Abortion (AVA), an outreach project of the National Right to Life Committee. The purpose of AVA is to educate the public, legislators and the media about abortion's effects on women and their families.

In 1981, Ms. Gans was an unwed, unemployed 22-year-old part-time student when she submitted to the pressure of abortion advocates and her boyfriend to have an abortion. She underwent a suction aspiration abortion at approximately 12 weeks of her pregnancy.

After almost two years of struggling with an acute emotional reaction to her abortion experience, which included anxiety attacks, depression and other serious dysfunctional behavior, Ms. Gans helped to organize one of the nation's first peer-to-peer post-abortion support groups in the New York City area. She became AVA director in 1985, and since that time has spoken on post-abortion syndrome and other abortion related issues throughout the world.



#### Abortion-breast cancer link

A study being published in the Journal of the American Medical Association finds that there is a link between abortion and breast cancer. The study states:

After adjustment for parity, age at first birth, and other risk factors, pregnancy termination (induced or spontaneous) was associated with a relative risk of breast cancer...compared with the risk among women who had never had a termination.

In 1994, a study published by the Journal of the National Cancer Institute indicated that women under age 45 who have induced abortion are on average 50 percent more likely to develop breast cancer than other women their age.

In the past few decades, more than 20 studies have been published showing evidence of a potential link between abortion and breast cancer. Unfortunately, most of the studies linking abortion and breast cancer have received little or no attention in the media and have been virtually ignored by advocates of abortion.

# Early feminists' view on abortion

s the 75th anniversary year of women's suffrage comes to an end, I remain perplexed by how the modern 20th century women's movement has come to be synonymous with abortion on demand.

An historical examination of the connection between abortion and women's rights reveals that our early feminist foremothers were in outspoken opposition to it. What happened to change this direction? Were the early feminists just so oppressed by the patriarchal society that abortion was incomprehensible to their unliberated minds? Were they opposed because of health concerns about women, so the advancement of medicine helps to explain the change in feminists' position? Were they religiously motivated? Perhaps if we review our early sisters' ideas in their own words, we will appreciate their reasons:

- \*\*Elizabeth Cady Stanton opined that "When we consider that women are treated as property, it is degrading to women that we should treat our children as property to be disposed of as we see fit." (From a letter to Julia Ward Howe, Oct. 16, 1878)
- Susan B. Anthony declared "I deplore the horrible crime of child murder...No matter what the motive, love of ease, or a desire to save from suffering the unborn innocent, the woman is awfully guilty who commits the deed...but oh! thrice guilty is he who drove her to the

desperation which impelled her to the crime." (The Revolution, July 8, 1869)

- Mattie Brinkerhoff said "When a man steals to satisfy hunger, we may safely conclude that there is something wrong in society—so when a woman destroys the life of her unborn child, it is an evidence that...she has been greatly wronged." (The Revolution, Sept. 2, 1869)
- "Every woman knows that if she were free, she would never...think of murdering (a child) before its birth." (Wheeling, W. Va. Evening Standard, Nov. 17, 1875)
- Alice Paul, author of the original Equal Rights Amendment in 1932, said "Abortion is the ultimate exploitation of women."

It seems obvious that the unacceptance of abortion as a solution to unwanted pregnancy rose not from narrow religious tenets, nor women's health concerns. And far from male oppression impeding the ability to choose abortion, these revolutionary women concluded that abortion was the result of the tyranny of sexual inequality.

There is no doubt that their opposition was grounded from a deeply held moral belief that abortion was inconsistent with the feminist values of justice, non-violence and non-discrimination.

The central idea of their movement was the denunciation of the exploitation of the weak by the powerful, and they clearly saw the hypocrisy of demanding equality for themselves while denying life itself to their unborn children. How sadly ironic that modern feminist thought has strayed so far from its roots. Might our struggle for equal rights for all be further advanced had we not sacrificed the most vulnerable of all on the altar of women's rights?

# "Abortion is the ultimate exploitation of women."

Can we hold firm to our lofty principles and struggle with the hardships of unintended pregnancies? Aren't there choices to be made that affirm both the mother and her child? Isn't rejection of the child ultimately rejection of the mother? Is it conforming to a male standard to have to be "unpregnant" to be "OK"? Doesn'ta feminist, by very definition, have to reject abortion?

The answers to these questions may not be obvious, but one thing is: Elizabeth Cady Stanton, Susan B. Anthony, Mattie Brinkerhoff, Victoria Woodhull and Alice Paul would not be comfortable at our 1995 celebration of the 75th anniversary of women's suffrage.
