Mother's Day Dinner

Molly Kelly is a world-renowned lecturer on chastity and noted author of *Let's Talk to Teens About Chastity*. She annually reaches over 50,000 teens throughout the United States and Canada. She has appeared on ABC's *World News Tonight* and CBS's *This Morning*. A jampacked schedule kept her from accepting a guest spot on Oprah Winfrey. Molly was the only North American woman to speak to over 6,000 priests in Rome at the 1990 International Priests' Retreat where she met Pope John Paul II and Mother Teresa.

Connection

According to Steve Skinner, M.D., writing in the letters section of Journal of the American Medical Association (Oct. 12, 1992, p. 2033), "one could... conclude that Roe v. Wade was associated with an increased rate of infant homicide in the 2 to 12-month-old age group...Perhaps Roe v. Wade led parents to conclude that since it was legal to murder their children before birth, then homicide before kindergarten was also justifiable?"

In a concurring letter, Dr. Gus Slotman states: "...results suggest strongly that *Roe v. Wade* has resulted in a decline in the value of human life in the United States, manifested in increased homicide rates overall, increased homicide rates for small children, and a reversal of the declining newborn homicide rate that had been observed prior to 1973" [emphasis added].

Inconsistencies

A few months back, two Beluga whales at Shedd Aquarium in Chicago died under mysterious circumstances. The press was all over the place looking for answers. In a 1992 government study, female infanticide touched one out of two families.

One out of every 50 babies born in Detroit dies before its first birthday. The Parent-Infant Partners program was developed by the Michigan Catholic Health Systems to help reduce this serious infant mortality problem.

The Parent-Infant Partners program is made up of volunteers who provide education and support for parents on a number of topics.

Each volunteer will be a friend and a resource to the family. Parents will become more confident and comfortable with the birth and child-rearing process. They will be better able to care for their newborn, which will improve the baby's chances for a healthy future.

Volunteers are matched with expectant mothers who sign-up to participate in the program. The volunteer begins as early in the pregnancy as possible and continues helping through the baby's first year of life.

Volunteers are those men and women who have the time and desire to work with parents and their newborn. Classes for volunteers run eight weeks and are scheduled at Providence Hospital on Nine Mile Road in Southfield.

"Freedom of Choice"

As early as this spring, the U.S. Senate and House of Representatives could take up the proposed national abortion law, the so-called Freedom of Choice Act (FOCA) H.R. 25/S. 25.

FOCA would establish an entirely new, statutory federal "abortion right." This "right" would override all state and local laws and policies that would interfere with "access to abortion."

FOCA actually says that states "may not restrict" abortion. Any law or policy that in any way diminished "access" to abortion for any women is "a restriction" and is, therefore, impermissible.

While there are several "exceptions" which were supposedly added to preserve certain laws such as parental consent, the "exception" clauses are loaded with weasel words, loopholes and legal booby traps.

Certain legislators are responding to your letters that FOCA will not "overturn parental consent laws." Do not allow their double talk to fool you.

The FOCA exception reads: Nothing in this Act shall be construed to prevent a State from requiring a minor to involve a parent, guardian, or other responsible adult before terminating a pregnancy.

This "exception" was artfully crafted by pro-abortion attorneys to create the impression that the bill would permit parental consent. Actually, it invalidates any law that does not give the minor the option of consulting any "responsible adult" of her choosing. This could include the abortionist, a paid "counselor" at an abortion clinic, her 18-yearold boyfriend or just about anyone else.

You must write individually and call your senators, congressman and the White House, and then write again to refute any misinformation.

Voice your total rejection of the "Freedom of Choice Act." The mail and phones must be saturated on behalf of the unborn. (See page 11, FOCA strategy.)

National health plan

Hillary Rodham Clinton is head of a task force charged with developing the Administration's national health plan.

During his campaign, the President said he would propose an "innovative and comprehensive health care plan [that] would cover pregnancy-related medical procedures, including abortions."

The Experts Disagree

ne of the most important areas of disagreement between those who are pro-abortion is on the question of when human life begins.

Those who are prolife take the scientific position that we inherit our humanity from our parents through our genetic code and that when this code is formed and working, which is at conception, human life begins.

The pro-abortion position is simply that the experts disagree. The implication of this position is that because the experts disagree, no one can know for certain when human life begins. This bestows on "experts" a god-like aura. Belief in expertise becomes a kind of religion. Acceptance of the opinions of "experts" becomes mindless. But what is the meaning of disagreement among the experts? How should we interpret such disagreement?

Historically, experts in all periods of history have disagreed on one thing or another—the shape of the earth, the position of the earth relative to the sun, the causes of disease, etc., etc., etc.

Today, we look back on those periods of history and judge certain of the experts to be closed-minded. We can see that their opinions were formed not on an objective analysis of factual information but rather on a subjective egotistical need to believe in the positions they took.

But what of modern experts? Are they superior to their past counterparts? Are they the god-like creatures that pro-abortionists would have us believe? Can we not think or understand until they tell us what to think or understand?

Bob Mullan, in his book, Are Mothers Really Necessary? helps to answer these questions. In writing of psychologists working in the field of child development research, he states, "Investigators, in the way they go about their research and in the manner in which they attempt to prove their hypotheses, invariably find what they are looking for—in other words they will ensure that their world view is not contaminated by contrary facts."

He uses Sir Cyril Burt of "intelligence testing" fame (1883-1971), the first British educational psychologist, as an example of the lengths to which some experts will go in this regard. Although Sir Cyril Burt "...remained an influential figure to the end of his life, it now seems certain that in later life, from about 1950, he fabricated data on twin studies to support his views on intelligence."

Mullan further states that "researchers in the contentious area of child development invariably find what they are looking for because of the moral choices they have already made about what is important and what is 'right.'"³

He uses, as another example, Margaret Mead's studies in Samoa. She "found" that Samoans had a relaxed attitude toward sex and their sexuality and that, as a result, they were well adjusted in this regard. She also "found" that because of the social situations in which children were reared, "they never learned 'the meaning of a strong attachment to one person,' and because early childhood does not provide them with 'violent feelings,' there are no such feelings to be rediscovered through adolescence."4

But another researcher, Derek Freeman, questioned Mead's findings and set out to find the answer. In Samoa, he discovered "not a relaxed sexual adolescence, but rather, much rape, violence and incest." Freeman also tested Mead's

claim that in Samoa "filial affection is diffused among a large group of relatives." He had the women of an extended family gather in one place, and then he had them walk away one at a time from the children. Distress was shown only by the children of the woman who was

walking away. The obvious conclusion was that Samoan children did form "a strong attachment" to one person, contrary to Margaret Mead's claim.⁵

Another book which contributes to the evidence of the unreliability of some experts is Dr. Judith A. Reisman and Edward W. Eichel's book, Kinsey, Sex and Fraud: The Indoctrination of a People. The authors state in the introduction that "Kinsey demonstrated with numbers that 'normal' behavior was much more permissive than conventional wisdom had suspected." But they go on to say that "Few people realized that the data he presented were not, as claimed, scientific."

The authors observe that "Kinsey obscured certain information that would be damaging to the credibility of his results." They site early reviewers of the "Male Report," Sociologists Albert Hobbs and Richard Lambert of the Sociology Department of the University of Pennsylvania, who point out that "Kinsey's methods lent themselves to covering up 'selectivity' in his sample."

According to another authoritative review by statistical experts William G. Cochran, Frederick Mosteller and John

Tukey, "the inability to relate Kinsey's data accurately to the U.S. population was because of sampling deficiencies—'no use of randomization' and 'the absence of any orderly sampling plan.'" In his studies Kinsey used "the histories of persons with specifically sadistic or masochistic experience," prostitutes, pimps and exhibitionists. In his "Male Report," Kinsey used male prisoners "(including rapists and incest offenders)." 10

In support of their claim of fraud in Kinsey's research, the authors relate an incident that occurred between Kinsev and the well-respected and prominent psychologist, Abraham H. Maslow. There was a littleknown initial collaboration between Kinsey and Maslow on Kinsey's "Male Report." Because of the results of research Maslow had done five years prior to his collaboration with Kinsey, he "warned Kinsey about the probability of bias in the personality type and sexual behavior of his volunteers." That is, his volunteers would show a falsely high percentage of aberrant behavior in the population.

To test for volunteer bias in Kinsey's study, a joint project

between Kinsey and Maslow was initiated. Maslow had personality assessments for his students at Brooklyn College, and so it was agreed between the two men that Maslow would ask for volunteers from his classes at the college, and Kinsey would use them for his studies. And so, Kinsey subsequently obtained the sex-history data of the student-volunteers, and Maslow provided him with the matching personality assessment data. At this point Kinsev ceased to cooperate with Maslow, refused to give him the matching sex data and refused to continue their joint project to determine the exact extent of the bias in the Kinsey sample.

Eighteen years later and six weeks before his death, Maslow wrote a letter to a colleague in which he related the whole incident. In the letter Maslow said that Kinsey not only did not mention the incident in his books, but that he even refused to publish anything Maslow had written. Kinsey obviously had an agenda and thus, lacking in integrity, ignored any data that did not support his own personal biases.

The above two books clearly demonstrate the unreliability of some expert opinion. The experts discussed are not minor, little known individuals. Their works and names are

widely known and respected. A great deal of what we think we know about human behavior is based on their studies. University and college courses in sexology are contaminated by the errors contained in the studies. And thus, the degrees based on these courses lack validity which further erodes the credibility of experts in this field

But what is true of experts in the field of human behavior is also true of experts in every other field. Some are unreliable. They take a moral position on an issue and then close their minds to any evidence that does not support that position. This destroys the scientific basis of their work.

Thus, the pro-abortion contention that the experts disagree as to when human life begins, although true, is meaningless. It reveals the closed-mindedness of pro-abortionists. They refuse to examine the disagreement among experts to determine the validity of the various arguments.

Are they perhaps afraid of what they would find—that experts who support the proabortion position lack credibility?




