#### Europe is dying

The average woman in Europe now is bearing 1.48 children in her lifetime. In order to maintain a level population with replacement births, the average woman in her lifetime must bear 2.1 children. Malta, Ireland, Poland, and surprisingly Sweden, are the only countries reproducing themselves. Sweden does it mainly through births to immigrants and postponed births. In what had been Soviet Russia, now called the Commonwealth of Independent States, only the five Muslim countries are replacing themselves by natural increase.

Italy has the lowest birthrate in the western world with only 1.23 children per woman. Spain is next with 1.26, Germany and Austria with 1.3. The lowest country of all is Russia proper which is around 1.0 although exact figures are not available.

# **Distortions and Dangers** in the Euthanasia Debate

he cover story in the April 25 issue of *U.S. News and World Report* chronicles how a two-decades debate on euthanasia has led to Jack Kevorkian's "suicide machine." The news magazine also probes more deeply: "For many," writes Joseph P. Shapiro of *U.S. News*, "the public dialogue over death and dying has become badly distorted...too often, death is viewed as inevitably painful, suicide is seen as an act of logic and courage and euthanasia is treated as a civil right."

But Shapiro says "a growing number of doctors and bioethicists are challenging these attitudes" and promoting other ways to "take the pain and financial ruin out of most deaths." He quotes a medical specialist on aging and dying, Dr. Joanne Lynn: "It is an outrage for us to seriously discuss killing the sufferer rather than relieving the suffering."

The *U.S. News* feature story discusses five "dangers" in legalizing physician-assisted suicide:

#### "Danger 1: Losing Focus"

The media have focused attention on individual cases of extreme suffering and suicide among the seriously ill. At the recent Kevorkian trial, testimony emphasized the suffering which led Thomas Hyde, a patient with amyotrophic lateral sclerosis (ALS), to seek Jack Kevorkian's assistance in suicide. But "in a survey of 89 people with ALS even more advanced than Hyde's, Dr. John Bach of the New Jersey Medical School found that only two said they regretted being alive or dependent on a respirator." Similarly, "almost everybody who gets a terminal diagnosis goes through a momentary period where they think of suicide," according to hospice nurse Maggie Callinan, but very few request assistance in suicide; she fears this would change if suicide were readily available. Many wishes for death are due to poor pain control and other deficiencies in care that have their own solutionsaccording to specialists, "nearly 100 percent of cancer pain is controllable."

#### "Danger 2: Physicians as Killers"

Allowing healers to kill could undermine societal trust in physicians and open the door to involuntary euthanasia. "Physicians are always tired by patients slipping or not getting better," says Dr. Leon Kass of the University of Chicago. "Once they think of death as a treatment option, then physicians simply give in to their weaknesses." For evidence one might observe how euthanasia practice has developed in the Netherlands: "In slightly more than half of euthanasia cases," notes U. S. News, "doctors kill without the patients' knowledge or consent."

#### "Danger 3: The Slippery Slope"

While some euthanasia initiatives supposedly apply only to those expected to have six months or less to live, Kevorkian's own attorney Geoffrey Fieger notes that no doctor can make such a prediction with certainty. Dutch euthanasia has moved rather quickly from the terminally ill, to handicapped newborns, to physically healthy people in "unbearable emotional misery."

#### "Danger 4: Blurring Suicide's Line"

Researchers find that "new suicide options" popularized by groups like the


Hemlock Society "are mostly used not by the terminally ill but by the treatably depressed," including teenagers and the elderly. Experts in suicide discount the idea of "rational suicide," arguing that the terminally ill, like others, commit suicide only when suffering from clinical depression; depression in these patients is no less treatable than for anyone else.

#### "Danger 5: Making it a Duty to Die"

This fear was fueled by President Clinton's recent remark that promoting "living wills" may be one way to "weed out" excess health care costs. The concern that young Americans may pressure their parents or grandparents to die because of the economic burden of their care gains credence from opinion surveys: "Polls show it is the young and healthy—not the old and sick, as is widely assumed—who clamor for a right to die."

The report concludes by noting that euthanasia proposals in Washington and California gained broad support in early polling, but were ultimately rejected by the voters. "Americans there, as elsewhere, have found that the more they consider euthanasia, the more difficult it becomes to resolve its dangers."

mother had great "vision." When SIECUS or another sex education program was going to be implemented in the public school curriculum, mom had the courage to testify against the "experts" who thought it would be a good idea. This was in the late 60s, early 70s. Now more than twenty years later, and after the sexual revolution, her unheeded words of wisdom would make good advice.

She also went against the tide when she became involved with People Taking Action Against Abortion and introduced us to the cruel reality of abortion.

She took all of us to the Howard Johnson's Restaurant downtown to picket a Zero Population Growth convention being held there. We encountered hardened pro-abortion people who moved their protest lines so close to us that we were forced out into the busy road.

She picketed Jimmy Carter, who was then the Democratic pro-abortion candidate for president, at the Hyattin Dearborn.

She taught her children how to courageously stand up for what is right against all opposition.

Throughout all these years, for we are all now grown and married with children of our own, my mother was very proud of us, even the little accomplishments. She was and is our greatest fan!

In the *Reader's Digest* Family Word Finder, the origin of the word "mother" from the original Indo-European language is dated by experts as prior to the fifth millennium B.C. "Mother" has been with us in forms much like our modern-day English language form for the past 6000-7000 years, and possibly longer! These forms include using "mother" synonymously for "care for, rear, raise, tend, mind, nurse, nurture, protect, give birth to, bear, produce and conceive."

Mary Babcock, my mother, has probably never looked up the word "mother." No woman receives any more than onthe-job training from their own mom, or from their own experience to be a mother. Yet Mary Babcock raised six children and took in almost as many foster children, as if she were born to be a mother. Even children from the neighborhood or school

could find comfort or guidance from my mom.

In my teen years, our backyard abutted two other homes, each housing "broken" families. The one young man, Mike, was living with his grandparents while his divorced mother tried to put her life in order. The other family had suffered the loss of their mother due to cancer. One of the fellows from this household, and Mike, became regular visitors at our house. They came under the pretense of visiting one of us kids, but would tease Mom and say they couldn't live without her "sermons." Even though there was a comfortable atmosphere, they walked away with good advice on respecting themselves and others.

Mom was never content to just raise her own brood of six. After suffering her fourth miscarriage, she realized she probably wouldn't be blessed with any more babies. Through Catholic Social Services, she became a foster mother. She took in children who were hard to place due to age or race mixture. When the Social Services discovered how children flourished under Mary's care, they began to send specialneeds children, the last being a black child who had a club foot, cerebral palsy and a drooping eyelid. Even though she was 1-1/2 years old, she functioned like a newborn, not even able to hold up her head. She would cry non-stop day and night, her only way to communicate.

After six months, Penny was able to feed herself, crawl, sit up—all what you'd expect of a developing youngster. No miracle occurred, except the one brought about by constant, loving attention and care.

I remember as a 13-year-old, joining Mom and the local prolife group, picketing outside Howard Johnson's where a Zero Population Convention was being held, shortly before the Roe v. Wade decision. We would pass literature to voters at the polls. We learned the sanctity of life through Mom's commitment to making the public aware of the reality and horror of abortion; her commitment to us, foster children, religious education groups she taught, her sorrow each time she lost a baby through miscarriage. All this from a woman who had been told to never bear children due to a heart damaged by rheumatic fever. A woman who then bore ten children, birthed six, but mothered multitudes.

When it became necessary for her to have a radical hysterectomy due to a precancerous condition, she mourned the loss of the "first cradle that rocked (her) babies." She treasured our births and rejoiced in sharing the miracle of creating new life.

For me now, as an adult, my mom is there still to mother me and my children. She didn't cut the ties when I flew from her nest, but rather strengthened them by giving me my freedom, along with her example of selfless love. When I am in need, somehow she knows, even though we are separated by 1500 miles. She has come to my aid more times than I could ever hope to repay. Her example is a difficult one to emulate—it asks so much of the giver.

Sometimes I wonder if God had preordained that she should be named "Mary," for surely her life's effort has been patterned after the best Mother model of all—Blessed Mary.

Congress has never before considered a single piece of legislation that has such far-reaching ramifications for the continuum of right to life issues—from abortion to involuntary euthanasia—as are raised by the Clinton health bill and its spinoff bills as well as some of the alternative bills.

For the pro-abortion forces, passage of this legislation would achieve all of the same goals as enactment of the Freedom of Choice Act and repeal of the Hyde Amendment—and much more besides.

Our central message is this: any prolife complacency about the outcome of this imminent battle is entirely unwarranted. Never before have we faced anything approaching the money, media and political power that are lining up behind the abortion mandate.

Recently, President Clinton reiterated his commitment to the abortion mandate in a letter to Congresswoman Patricia Schroeder (D-Co.). The top Democratic leadership in both the House and Senate are committed to the abortion mandate. And so are a lot of people in Hollywood and the major news media.

The House Democratic leadership has urged the chairmen of the three key House committees to approve some version of the Clinton bill before the end of May: Energy & Commerce, Ways & Means, and Education & Labor.

If all goes according to plan, the same two National Right to Life-backed anti-abortion amendments will be offered in each of the three key House committees:

—"Amendment #1" would remove abortion from the mandatory benefits package (except to save the life of the mother, or in cases of rape or incest). Under this amendment, any person or group wanting abortion insurance would have to buy it separately on the private insurance market, and no health plan would be required to offer abortion coverage or set up abortion clinics. [Sponsors: Klink in Education, Tauzin in Energy, Bunning in Ways & Means]

—"Amendment #2" says that the bill would not nullify any "constitutionally permissible" state abortion regulations (parental consent, waiting periods, doctor-only laws, existing limits on third-trimester abortions, and so forth). [Sponsors: Klink-Armey in Education, Tauzin in Energy, Santorum in Ways and Means]

The Senate Finance Committee is not expected to conduct any formal votes until mid-June—but the negotiations are continuing daily.

#### **ACTION REQUEST**

Please redouble all efforts through letters, postcards, and phone calls asking members of Congress to support the above Amendments #1 and #2 and to oppose any health care legislation UNLESS it contains explicit and adequate anti-abortion and anti-rationing language.

# 1973 Was a Bad Year for Birthdays

Imagine a place without any children. Not a place filled with surreal landscapes of empty swingsets and sandboxes or sunbleached plastic dolls, but a place conspicuously devoid of kids. No happy playtime laughter or games of hopscotch. I have grown up in a world conspicuously absent of more children than I can imagine. The number "thirty million since 1973" doesn't really fit in my head any better than the enormity of the Jewish Holocaust; all I can really comprehend is the number "four thousand a day." I go to school with about four thousand other kids. And while I still can't imagine how I would feel if I was told that everyone in my school had been killed while I was away, I can tell you that four thousand kids a day for a week would overflow the senior high schools in Clay County. For a month, the junior highs as well. On and on until you realize that more kids than you will ever meet will die between oil changes on your car. And it's been going on for twenty-one years.

Twenty-one years is a long time for me. I wasn't even born twenty-one years ago; my sister had three years still to be an only child. She was born nine months after they began to kill her classmates. By the time I was born, there were less children at the playground and there was always an empty swing. There were many, many boys who would never have a secret crush on a girl, never hold a girl's hand. They never would play with a truck or dig a hole in the ground. I have many dead friends. Some of them are little girls who never have dressed a doll or passed a note. Some would have been tomboys who played rough games. I have some dead friends who should be teenagers now, growing up painfully and joyously. They should be going on dates and getting jobs. Instead, they tasted life inside a mother's womb until the world made it inconvenient to have her child. None of them were allowed to see the

Think back to that world empty of children. It has not one location, but many. The seat across from me in my science class. The seats next to me in my last class. It is a varied land, made of empty chairs and swings. Closets full of empty clothes hangers and cribs that went unbought, diapers unsold. This year, four thousand children a day will not come of age. Their parents will not weep for them. 1973 was a bad year for birthdays.

#### In memoriam

The International Right to Life movement suffered a great loss with the April 3 death of Professor Jerome Lejeune. The 67-year-old Lejeune was a giant among geneticists, a firm friend of those with disabilities, and an unbridled advocate for the unborn. The entire world has mourned his loss as a distinguished scientist, and justly so.

He was honored in many countries for his original research, most notably the *Prix Essec de Cancer*, the Kennedy Prize and the *Grand Prix Scientifique de la ville de Paris*. Hewas best known for his discovery of the extra chromosome which is present on the 21st pair in children with Down syndrome, hence the technical name for the condition "Trisomy 21." Most of his life was devoted to a search for a method to prevent Down syndrome or treat children born with this and associated genetic conditions.

Those of us in the prolife movement will feel his loss even more deeply than will his much loved patients. For a quarter of a century, Dr. Lejeune fought the evil of abortion. He traveled the world to preach on the importance of loving all of God's children, born and unborn.

# Population and Global Abortion

ith the upcoming
United Nations
Conference on Population and Development
already on a pro-abortion track, the
Clinton Administration is working both
publicly and privately to push the Cairo
conference to go even further—to
embrace the position that abortion on
demand should be available in every
nation. This from an Administration
whose chief executive insists he wants
abortion to be "rare."

In preparations for the September 5-13 conference in Egypt, a "Draft Programme for Action" was produced laden with overt and covert pro-abortion proclamations. However, according to a March 16 "action cable" sent by the U.S. State Department to all overseas diplomatic and consular posts, this didn't go far enough.

The cable called for "senior level diplomatic interventions" in support of U.S. priorities both at the Cairo conference and at a preparatory conference which took place in April in New York.

Posts are requested to approach host governments to outline USG [U.S. government] negotiating priorities for the final preparatory committee meeting for the International Conference on Population and Development to be held in New York from April 4-22. The priority issues for the U.S. include assuring...access to safe abortion.[...] 17. The United States believes that access to safe, legal and voluntary abortion is a fundamental right of all women. The current text...[of the proposed declaration by the Cairo conference] is inadequate as it only addresses abortion in cases of rape or incest...The United States delegation will also be working for stronger language on the importance of access to abortion.

But this "vision of a global abortion on demand village is at odds with the values, religious traditions, and laws that prevail in most developing nations," said Wanda Franz, Ph.D., National Right to Life president. "It's cultural imperialism."

The Clinton Administration's policies "also fly in the face of the recommendations that came out of the 1984 International Conference on Population which stated unequivocally that governments should 'take appropriate steps to help women avoid abortion, which in no case should be promoted as a method of family planning," Franz said.

Douglas Johnson, NRLC federal legislative director, said the Clinton Administration apparently intends to use the Cairo conference to pressure developing nations to repeal their protective abortion laws. "That is a goal long sought by private groups such as the London-based International Planned Parenthood Federation—recently the recipient of a \$75 million grant from the Clinton Administration," he said.

Congressman Chris Smith (R-NJ) said he'd spoken to many delegates, and "There is a very strong resentment building" against the Clinton Administration's "fixation on abortion" as a "solution" to world problems.

White House spokeswoman Dee Dee Myers has said that the Administration regards abortion as "part of the overall approach to population control," and the Administration has submitted to Congress a bill that would repeal all restrictions on the use of U.S. foreign aid for abortion. "In his health care bill and elsewhere, the President has preferred to advance abortion-on-demand policies behind a curtain of verbal obfuscations. The policies outlined in the 'action cable,'" Johnson said, are "part of an accelerating campaign by the Clinton Administration to legalize abortion on demand as a populationcontrol method in developing countries. This ideological crusade will collide with the laws of 95 nations that protect unborn children, including most of Latin America and Africa."

#### **Letters Needed: Stop Experiments**

ith almost no public notice, the Director of the National Institutes of Health, Dr. Harold

Varmus, has mounted a totally stacked "Ethics" Panel to decide which uses of human embryos should be federally funded. Although this is being done under the cover of aiding in vitro fertilization in service of infertile couples, many of the matters under discussion go far afield of that procedure. The result of legitimizing federal funding for these experiments would open the gate to a frontier of actual Brave New World proportions at taxpayer expense. It is also believed, by some, that the approval of such human embryo experi-

mentation would foreclose any hope of overturning abortion in the United States.

## Human Embryo Experiments Currently Under Discussion

Tiny human beings would be subjected, in part, to the following:

1) Using the eggs from aborted female babies for egg donation for *in vitro* fertilization and pure research.

2) Inducing a pregnancy by stimulating a female embryo's egg—also known as a "virgin birth."

3) Producing human embryos for ex-

6) Keeping only parts of embryos alive


in cell culture to provide organs for transplantation.

When the National Institutes of Health received 55,000 letters in 1979 regarding in vitro fertilization research, that research was cut off! We must make that happen again. Write a letter and protest the human experimentation presently under review experimentation that will be funded by your tax dollars if you do not protest now.
