



The Beginning

ight to Life - Lifespan was born on a frigid night in November 1970 at the Plymouth Grange Hall. Gloria Klein, a young housewife from Westland, chaired the meeting and became the founding president. About 100 concerned citizens who attended that first gathering formed the nucleus of the pro-life movement in southeastern Michigan. Originally called "People Taking Action Against Abortion" (PTAAA), the group adopted the name of its newsletter *Lifespan* in 1973. Even then it was obvious that infanticide and euthanasia were irrevocably joined together in philosophy with abortion. In the late 1970s "Right to Life" (RTL) was added to the beginning of Lifespan's name at the urging of the national organization. The idea was to have pro-life groups across the country easily identifiable by using the same prefix. Thus, the progression from PTAAA to Right to Life - Lifespan. However, whatever the name, the principles and goals have remained the same since that icy night in 1970.

In the words of Gloria Klein...

It was my issue, too

My fourth daughter was 9 months old when I began to worry about state laws against abortion that were tumbling down. The New York law, legalizing the procedure for 6 months, had touched off the sight of entrepreneurs providing jet services to that state and charging huge fees. The media told us that Michigan would be next, or so they had been coolly informed by the National Abortion Rights Action League (NARAL) which had been the architect of the law in New York.

I watched the scenario with mounting concern but knew of nothing happening in Michigan to oppose it. Then, of all

places, it was the Phil Donahue show that started me on the bumpy path I would follow—perhaps for the rest of my life.

Our children are indeed the "pearl of great price" for which we are expected to give everything we have to save. —Phyllis Sullivan

His guest was Juan Ryan, President of the National Right to Life Committee-then an adjunct to the United States Catholic Conference. I am a Presbyterian but I did not then, nor have I ever, considered this a "Catholic issue" as NARAL was calling it. It was my issue too. It is everyone's issue. So I wrote Juan Ryan, c/o the station, asking if he knew of anyone in Michigan who was "doing something" to stem the tide. He replied with the names of two women in Lansing who were trying to start a group there. I wrote to them and they supplied me with names of people in my area, and those names begat other names, but there was still no organization in S.E. Michigan.

One of the ladies whose name was given me seemed to be most aware of the political nature of the challenge. With her I called a meeting at my house where we chose the name "People Taking Action Against Abortion" (PTAAA). I was asked to act as its head and proceed with the necessary legalities.

In November 1970 we called our first meeting at the Plymouth Grange Hall. It was six degrees above zero and slippery under foot. About 100 people showed up who formed the nucleus of neophytes who would now embark on political action—for most, the first time in our lives.

We did have two resources which proved invaluable; we had people, the most dedicated people I have ever known; and we had faith. —Dr. Richard Jaynes

The attendees at the Plymouth meeting spread the word, and we were lucky enough to attract a number of professionals whose hearts were totally committed to the pro-life philosophy. They would go anywhere, talk to any number of people, large or small, to spell out the meaning and omen of permissive abortion. Usually, their crowds were small. The program chairman would present a panel of a doctor, a lawyer, perhaps a clergyman only to find a handful of listeners. One of them remarked wryly that there were more people on the stage than there were in the audience.

But the tide turned in April, 1971 when we rented the Veterans' Memorial Building in downtown Detroit for a Sunday afternoon and persuaded the well-known political writer, Dr. Russell Kirk, to be our guest speaker. He usually charged \$1,000 then per lecture, but he came to us free of charge—another illustrious professional with his heart in the cause. It drew 750 people and now we had an organization.

We have four adopted children. I could not begin to tell you how grateful I have been to the unselfish women...who have passed them into our arms.

Senate Bill #3 was brought to the statehouse again and again. It would have legalized abortion in Michigan for the early months, but it never passed. Giving up on the statehouse, a proabortion coalition resorted to a popular referendum for the November, '72 ballot and began circulating petitions. Their local forces included Planned Parenthood, Zero Population Growth, NOW and the ACLU as well as Michigan Clergy Counseling Service—which was already referring pregnant women to abortion facilities outside Michigan.

History will view our abortion battle as a classic civil rights struggle and an anomaly to the feminist movement. —Carol Smith

"Voice of the Unborn"

We were opposed to this ballot question, called Proposal B, which would have permitted abortion for 20 weeks because we didn't believe a class of people could be exterminated, with justice, by popular vote. Neither did a lot of people. By September of '72 a coalition of pro-life forces began to arise across the state which called itself "Voice of the Unborn." We met in

Lansing and about 10 campaign offices traversing the state were set up—the vast majority in the basement of private homes, as mine was.

My house became an

Both the electronic and paper media were aggressively pro-abortion and the rallying cry was "Reform!" The Executive Committee of Voice of the Unborn called in Richard Nixon's campaign adviser for counsel. He said we couldn't win because we were too far behind in the polls. The voters had already made up their minds. I told him

thousands, I have tried to represent Lifespan and the unborn in such a way that will help the listener to understand the importance of protecting human life. —Diane Trombley

Who were we to ignore such an expert? His advice was to keep a low profile, avoid confrontation with the opposition which spelled POWER, discover the undecided voters and our own strength, and send them our literature.

If we had followed all his advice we would have lost, hands down. Instead, we followed part of it, and listened to other strategists who advised us to hold our fire until the last two or three weeks before the election so the opposition wouldn't have time to respond.

In 1972, I became chairman for my parish to work on the referendum. I thought it was

Our media campaign consisted almost entirely of radio and TV spots. We focussed on the fact that 20 weeks meant 5

months and how advanced the unborn child was at 5 months gestation.

We also ran a telephone survey (with our willing vounteers) that reached 50,000 homes. We were too unsophisticated at the time to buy registration lists so we worked from the Bresser directory.

One time, I heard Gloria (Klein) say that Frank and I had spent our honeymoon in her basement. —Marie Gonzales

We thus discovered the undecided and pro-life voters. Our speakers went out to Sunday church services and collected money wherever they went. As word spread about the work, people swarmed to my basement in Westland. They brought money and asked for jobs. My basement walls were covered with precinct maps containing the names of chairmen who had volunteered to cover their areas with literature distribution. We would refer these people to chairmen in their area. The other campaign offices did the same.

Sometimes Gloria (Klein)
and I couldn't get a car
running for the ride to
Detroit, so we would climb
in my husband's ice cream
truck and away we went.

The independent local pro-life groups across the state purchased huge quantities of the Hiltz brochure "Life and Death" (which had been authored by Dr. John Willke) and carried it from door to door. Some took it to factories and passed it out to workers coming off shifts. We estimate that more than 500,000 copies were distributed throughout the state and paid for by the local pro-life groups.

When Proposal B came on the ballot in November of 1972, we were able to man the polls all through the rainy day...it was a freezing rain too, but our workers never flinched from their task of handing out cards advising, "Vote NO on Proposal B." —Patricia Holscher The final vote on the referendum showed 61.3% voting "NO" on Proposal B and, therefore, "YES" to life. The only counties lost were Washtenaw (home of the University of Michigan) and Oakland—one of the wealthiest counties. But we could not take comfort long because the Supreme Court ruled in *Roe v. Wade* two months later, tearing down all state abortion laws and making the procedure legal through all nine months of pregnancy.

On January 22, 1973...the 10 a.m. news came on the radio with headlines that the U.S. Supreme Court had ruled that abortion was legal in every state.
I...called Gloria Klein. She had not yet heard the news. We both cried as if our hearts were broken, as indeed they were.

Much of the country thought the matter had been settled, and we would all go home and be quiet. That has not happened.

"Life is like an arch"

There had been a chilling line in the Roe v. Wade decision of January 22. It was "the capability of meaningful life." No one had defined meaningful life, so we could see the immediate danger of euthanasia-both of the elderly and the handicapped. Recalling the Nazi phrase, "useless eaters," and how the mentally handicapped were the first to go to the gas chambers in Germany, we thought it was time to abandon the name, People Taking Action Against Abortion, and chose instead the name that had been used on our newsletters—Lifespan. We had been intrigued with the concept since one of our earliest speakers and activists, Dr. Richard Jaynes, had declared to an open hearing in Lansing in 1968, "Life is like an arch. If you discard one segment as worthless the span collapses—the value of all life brought low."

Standing room only by Bob Ervin

After Roe v. Wade, the Right to Life people in Michigan hosted the first large National Right to Life Conference in Detroit (June 1973). My job was Chairman of Arrangements and that turned out to be a strenuous experience. Whereas, we thought that, with luck, we might have 400 or 500 attend, 1500 participants arrived. We ran out of almost everything, had standing room only in the workshops and gave the hotel the terrible task of providing a banquet for more than twice the number of people we had expected.

This was a real shot in the arm for us since having defeated Proposal B, we were really depressed when *Roe v*. Wade followed soon after. It was particularly stimulating to know that people not only came from many states, but they came from Canada and other countries as well.

Soon after I retired in 1975, I became Chairman of Lifespan, Wayne West and became a member of the Boards of the state organization and Lifespan. In the years that have followed, it has been an almost continuous adventure made of meetings, pro-life speeches and stuffing, sealing and stamping.

U.S. House Votes to Ban Partial-Birth Abortions

The U.S. House of Representatives voted November 1 to place a national ban on the use of the partial-birth abortion procedure, except to save a mother's life.

Despite vehement opposition by the National Abortion Rights Action League (NARAL) and its congressional allies, the House passed the Partial-Birth Abortion Ban Act by a veto-proof vote of 288 to 139. This is the first time since the Supreme Court's 1973 *Roe v. Wade* decision that the House has voted to place any direct restrictions on abortion, even during the final months of pregnancy.

Reacting to the vote on behalf of the National Right to Life Committee (NRLC), the nation's largest pro-life organization, NRLC Legislative Director Douglas Johnson said, "The overwhelming House vote now poses this urgent question to every U.S. senator and to President Clinton: will you allow living babies to be pulled feet-first from the womb, then stabbed with a scissors, during the later months of pregnancy?"

The partial-birth abortion procedure is usually used 4½ months into pregnancy, often much later—even into the 9th month. The Los Angeles Times accurately summarized the procedure in a June 16 news story: "The procedure requires a physician to extract a fetus, feet first from the womb and through the birth canal until all but its head is exposed. Then the tips of surgical scissors are thrust into the base of the fetus' skull, and a suction catheter is inserted through the opening and the brain is removed."

NRLC's Johnson and congressional supporters of the bill have charged that opponents, and some organs of the media, have ignored readily available writings and public statements in which certain abortionists admitted to frequently using the partial-birth abortion technique in situations that have nothing to do with health problems in the mother or the baby. For example, in a tape-recorded interview with American Medical News, Dr. Martin Haskellwho has performed over 1,000 partialbirth abortions-said that in his practice, 80% of these procedures are "purely elective." In the same taperecorded interview, Dr. Haskell estimated that two-thirds of the "fetuses" are alive at the time he begins their "extraction" from the uterus.

On the House floor, pro-life lawmakers displayed a series of five postersized medical drawings depicting the partial-birth abortion procedure. The drawings are validated as accurate by eminent medical authorities, including Prof. Watson Bowes of the University of North Carolina, co-editor of the Obstetrical and Gynecological Survey. In a virtually unprecedented action, Congresswoman Patricia Schroeder (D-CO) made a motion to prohibit the display of the drawings on the House floor. By a vote of 331 to 87, the House rejected Schroeder's attempt to impose a "blindfold rule" that would prevent the American people from seeing the posters on C-SPAN.



We are, however, called, sometimes even unwillingly like Jonah, to speak for those unable to speak for themselves. The truth must be told.



Via the pen

At a meeting in 1971 I met Gloria Klein who had founded People Taking Action Against Abortion. She was utterly dedicated to the cause. She was seeking helpers for various tasks, and when she mentioned the need for a newsletter, I volunteered to be editor. My only qualifications were that I liked to write and that I wanted to educate via the pen. I had been a teacher, a college history major.

Having no journalism experience, the newsletter began for me as an attempt to reinvent the wheel. Unable to solicit much writing from my busy fellow activists, I did most of the writing myself. I named the paper *Lifespan*, inspired by the chalkboard visuals used by an ob/gyn, Dr. Richard Jaynes, prolife speaker. He noted that life is like a bridge (or span), and destroying one segment as worthless (either young or old) causes the span to collapse and the value of all life to be brought low.

The design to convey this thought for the newsletter was drawn by sister artists at the Monastery of the Blessed Sacrament in Farmington Hills and became our paper's banner. The title later replaced PTAAA as the organization's name especially as we knew we were facing euthanasia legislation.

The political bug

In 1980 the National Right to Life Committee called Gloria Klein, reminding her that the Republican Convention would meet in Detroit in July, and that it would be Michigan's responsibility to get some prolife language in the Republican platform. Gloria was pregnant with her sixth child, felt she couldn't do it, so she called me. I said "No" five or six times, and then gave in.

I had never been to a political convention—didn't watch them on TV (who has time to watch television?). It was March and the Convention was four months away. No one told me what to do. The National Committee gave me a few hundred dollars and I begged the rest.

I incorporated the effort as "The Pro-Life Impact Committee." We needed a downtown office in the worst way, but everything was taken. Someone found an old house in downtown Detroit—the front half of which was available. However, it turned out that the back half was a brothel. This would hardly do.

But then a lady (I don't know who she was) offered us a tiny office in the Book Building that she had rented but wasn't using. She also sent us a typist. The miracles were coming our way.

An aide of Jesse Helms wrote the language to go in the Republican platform. I called on 150 pro-life activists in the state for help. The job was to identify the attitudes of delegates coming to Detroit—especially those on the Platform Committee. Some of our workers polled the Michigan delegates. Then to one or two others I would assign a state to organize. We found one person in each state who was willing to carry the ball.

The secret was, don't give anyone a whole lot to do. Then they don't burn out, but they are playing a role in the

effort. By the time convention delegates arrived, we had one selected to introduce the language and another to second it

There was the problem of getting the proposed language type set and printed, and I remember how, suddenly, it had to be ready tomorrow morning. I got our Lifespan printers (Pat and Bob Holscher) out of bed at 2:30 a.m., and picked up the piece at 5:30 a.m., to rush it downtown. Senator Helms said, "Who are these elves that work in the middle of the night?"

There can be no doubt that the auestion of abortion. despite the complex nature of its various issues, is ultimately concerned with equality of rights under the law. While we recognize differing views on this question among Americans in general—and in our own Party—we affirm our support of a constitutional amendment to restore protection of the right to life for unborn children. We also support the Congressional efforts to restrict the use of taxpayers' dollars for abortion. We protest the Supreme Court's intrusion into the family structure through its denial of the parents' obligation and right to guide their minor children. We will work for the appointment of judges at all levels of the judiciary who respect traditional family values and the sanctity of innocent human life.

I was urged by my associates, and Dr. Willke of the National Committee, to drop the paragraph dealing with appointment of pro-life judges to the judiciary. They were afraid it would pull the rest down. I refused to drop it, and it passed. President Reagan stood on that platform plank and was faithful to it.

Look at the Vietnam Memorial, Gettysburg, Flanders Fields. And the right to life is not free any more. We must win it back every day.
