March for Life, Washington, D. C., January 22

The 19th Annual March for Life will be held on Wednesday, January 22, 1992 in Washington, D.C. This year's theme is "Ensure the Right to Life at the Federal Level."

Prolife Americans in multitudes must rally on Jan. 22 to give our strong, clear prolife message to abortionists and all of official Washington: "Stop the killing of our unborn brothers and sisters."

We will Rally in the Mall at 7th Street for the Program at 12:00 noon, then March for Life along Constitution Avenue to the Capitol and Supreme Court.

A live broadcast of the March program will be heard on Washington station WOL 1450 AM from noon to 1:00 p.m. You are urged to bring your portable radio with you to the March; though a very large sound system is in place, there are distractions with the large crowd.

Celebrate Life Rally


Sunday, January 19, 2 - 3 p.m., Kennedy Square, Detroit

The Horror Within Dr. Tiller's Clinic

A former employee describes the methods and ethics of Wichita's most notorious abortionist.

In a letter delivered July 9 to the Wichita City Council, Luhra Tivis described her experience as a former employee of Dr. George Tiller, the Wichita physician who aborts babies between six and nine months' gestation. Her horror over Tiller's practices led her to oppose late-term abortions.

The following is an excerpt from Tivis' letter.

Dear Gentlemen:

I am a former employee of Dr. Tiller. I worked for him for about seven months approximately four years ago.

My job involved typing report letters on all the abortions and handling patient medical records. After six weeks of working solely on the computer, I was trained in answering the phones in order to schedule patient appointments. It was at this time, coupled with my growing awareness of the medical significance of the patient medical records, that I began to realize the scope and intent of Dr. Tiller's late abortion practice.

I found that a very high percentage of the late-term abortions were done on healthy fetuses. I handled the records for every patient on whom Dr. Tiller performed an abortion for over six months. In every instance, the fact of the condition of the fetus was noted in the records, whether it suffered from some abnormality, such as spina bifida, or was normal.

Since I was there for a relatively representative time period, I can note that the number of late-term abortions performed each week averaged 10-20 per week. The financial return on such procedures was known to all employees, since all knew the prices which had to be quoted over the phone, and since sales figures in numbers of sales were posted in the office. Through that information, and by figuring a conservatively high cost-of-doing-business, I estimate that Dr. Tiller's entire practice, consisting primarily of the late-term abortions, brings in a net of \$500,000 per year, in addition to his investments and other ventures.

It is my personal feeling that Dr. Tiller doesn't care about women, that he exploits them in his medical practices and that he acts in an unprincipled and unethical manner in the pursuit and protection of his late-term abortion practice.

Since I could no longer respect Dr. Tiller, and could not in good conscience ignore the ramifications of his late-term abortion practice, I decided to give information about him to the governor and the media. It was a difficult decision for me, since I am not a person in a position of importance, have very little money, and felt myself to be vulnerable to possible retaliation. But I thought about the viable fetuses, living babies, that he was killing each and

every week, and I couldn't remain silent.

Please allow me to briefly inform you as to the methods Dr. Tiller uses in performing late-term abortions. Although many clinics who refer patients to him think that he performs tests for viability on the fetus, to my knowledge no such tests were ever performed while I worked there. The first day the procedure is initiated, a needle is inserted into the living heart of the fetus and a "foeticidal agent" as Dr. Tiller calls it, is injected to kill the fetus. Over the next couple of days, lamanaria packs are inserted into the cervix of the patient, and labor-inducing drugs are administered. Sonograms are done at various points in the procedure - and Dr. Tiller measures the BPD (bi-parietal diameter) at its narrowest point, instead of at the usually measured widest point, leading to a BPD reading by Dr. Tiller of, say, 24 weeks gestation, when the medically accepted norm might be 26 weeks gestation. This method is not illegal, but is currently just a matter of accepted practice.

Aided by the body's natural inclination to expel a dead fetus, labor commences on the fourth or fifth day, and the group of patients are kept in a room in the basement together, separated by only a few feet of space from each

Nevada — A 21-year-old Las Vegas woman is dead after an abortion which perforated her uterus, according to an article in the Las Vegas Review-Journal. Anjelica Duarte, about 19 weeks pregnant, sought an abortion at the Women's Place abortion clinic Oct. 30. She began hemorrhaging after the abortion, performed by Dr. Larry Thompson, and was taken to a nearby hospital. A hospital spokesman said she was dead on arrival, having lost 90 percent of her blood after hemorrhaging for about four hours. She leaves behind a husband and two daughters, ages 1 and 3.

Ann's choice: Score two for life

Dr. James Smith looked at his patient thoughtfully after the exam in his small office.

It was time for the 38-year-old mother of six to give up making babies. The objective medical conditions were clear — more than clear — and he minced no words as he explained the awful truth.

"You know, Ann, you might not survive another labor and delivery. This one might kill you," he said. The new child growing within her would be due only 17 months after Ann's twins had been born. "I know a doctor who will perform an abortion for you."

Not much was said for a few short, but seemingly eternal moments. Ann was a registered nurse who presumably knew all about these things.

"I don't see any alternative," he said plaintively.

Not much thought went into Ann's decision. There would be no abortion, she declared firmly. God willing, things would turn out OK. And if they didn't it was God's will anyway. It was tough to lose when applying those kinds of metaphysical principles. Or perhaps, in the eyes of the physician, superstitions.

John Walter was born in a terrible fury, blasting his way into the world with such force that Ann's insides were badly torn. The predicted complications set in and Ann was rushed to the intensive care unit with massive hemorrhaging that flowed unabated for days. Her husband was told to expect the very worst as she received pint after pint of blood.

The brothers and sisters of the newborn were shunted out to friends and family. It was reported that the Monroe IHM nuns, two of whom were Ann's sisters, were storming the heavens with prayers for Ann. And the baby, and the family. Informal discussions included deciding where the children would be sent if Ann died.

God and Mother Nature prevailed and Ann survived her closest call with the Grim Reaper.

But the story repeated itself five years later, with a less blissful outcome. Upon learning of the pregnancy, the same doctor declared there was little chance of survival for Ann. He explained it was a miracle — if there is such a thing to a doctor who prescribes abortions — that Ann had lived through her latest delivery. There was, he declared, no possible alternative to abortion this time.

Ann, at age 43, perhaps too dogmatically, too stubbornly, declined the offer

and went on with the pregnancy: God's will, simply.

It wasn't a showpiece delivery, but it wasn't bad. No complications. But several days later Ann suffered a stroke.

Maybe, some will argue, the doctor was right. Maybe Ann should have stopped at six children. Maybe the abortion — or the abortions — would have been best.

I've heard the story of Ann's last two deliveries hundreds, maybe thousands of times. I am John Walter, the little tyke who was the central figure in that first drama 39 years ago. Needless to say, I have strong opinions about what most in the medical community and the media today would cite as Ann's peculiar, unintelligent behavior.

And Clare, my younger sister, if she were so blessed as to be in the newspaper business, would share an opinion too.

The certainty with which the doctor decided my mother would die is

frightening, and I will go to my grave with one disappointment, which is probably just as well. I have not had the opportunity to meet my would-be executioner.

Tuesday, January 22, is the 18th anniversary of the notorious *Roe v*. Wade Supreme Court ruling that made abortion legal at any stage of pregnancy in America.

For nearly half of my life, January 22 has been a black day. It is a day of deep sadness for those who understand the

brutality of abortion and the depth of the abyss into which the United States is falling. After a generation of disposable babies, leaders in the medical and legal community in 1991 march lock-step in defense of easy disposal of the handicapped and elderly.

January 22 is a day I thank God that in a quiet room 39 years ago, my mother stood against the

world, against the supposedly best medical advice, and said simply, "no."

By her quiet example she taught me perhaps the greatest lesson: In the depths of despair there is always hope.

A final point about that stroke that seemed so awful 33 years ago. Ann recovered completely and has, by any standard, lived a full, rich life. These days she's enjoying her 15 grandchildren and anxiously awaiting number 16, Clare's third.

A dangerous new law

Starting December 1, any adults who enter a hospital or nursing home will now be told they have a right to have a living will or durable power of attorney for health care, and asked if they have one.

On that date, the federal "Danforth Amendment" — sometimes called the "Patient Self-Determination Act" — went into effect.

Long promoted by the Society for the Right to Die and medical organizations, the "living will" is a written legal document that directs that life-preserving medical treatment or care - and often food and fluids — be withheld from the document's author under certain conditions. A "durable power of attorney for health care" is a different written legal document that names another peson who will be authorized to make decisions about health care including the withholding of lifepreserving medical treatment or care, and often food and fluids — for the author if the author becomes incompetent (no longer able to make decisions for himself or herself). Both are considered "advance directives" because they give directions in advance for whether medical treatment or food and fluids should be provided, or who is to make such decisions.

Contrary to some misuderstandings, the federal law does not require patients to sign either a living will or a durable power of attorney. Indeed, the law [the key parts of which are found in 32 U.S.C. §1395 cc(f)] specifically forbids health care facilities from requiring an advance directive of

any kind as a condition of providing medical care.

These days, however, most of the push to cut off livesaving medical treatment, food, and fluids does not come from patients or family members pressuring health care providers still committed to the Hippocratic Oath. Instead, it comes from health care providers who have long ago repudiated Hippocratic principles and who try to bring about the death of patients with a "low quality of life."

In this context, the great danger as the Danforth Amendment goes into effect is that cost-conscious hospitals and nursing homes will use the admission interviews and the "community education" programs which it mandates to convince patients that they really ought to sign documents yielding up their right to live. By raising the spectre of "runaway medical technology" and the financial and emotional "burdens" on a patient's family, they may induce many out of fear or a sense of ethical obligation to sign documents not truly reflecting their wishes.

Instead of signing a form provided by a hospital — or the Society for the Right to Die — it appears increasingly necessary to prepare different documents directing that one receive food and fluids, and receive life-saving medical treatment in all but very clearly and narrowly defined circumstances.

Assisted suicide: Sanctity of life vs. quality of life

The controversy surrounding assisted suicide has been a major issue since last yea. when Dr. Jack Kevorkian used his "suicide machine" to assist Janet Atkins in ending her life. Dr. Kevorkian was cleared of any criminal wrongdoing due, in part, to Michigan's lack of a specific law to prohibit assisted suicide.

In response to this event, legislation sponsored by myself and Rep. Nick Ciaramitaro, D-Roseville, was introduced last fall. If enacted into law, the legislation would outlaw assisting another person in committing suicide or attempting to commit suicide. A person found guilty of assisting another in committing suicide could be punished by up to four years in prison and/or a \$2,000 fine.

Judge Alice Gilbert issued a permanent injunction prohibiting Dr.
Kevorkian from ever again using his "suicide machine." Judge Gilbert, in her written opinion, was very critical of Dr. Kevorkian and stated: "His arrogance coupled with unabashed disregard and disrespect for his profession and ethical standards reveal that his real goal is self-service rather than patient service." Despite this injunction, Kevorkian assisted two more women in committing suicide a few weeks ago. This time, however, the victims were not even terminally ill.

Assisted suicide and euthanasia are identical issues and the Legislature must, I believe, be very cautious as they open debate on these issues.

The long-term consequences of our tolerance of Jack Kevorkian and euthanasia are ominous. Unfortunately, this direction in social policy moves away from an ethic that recognizes the "sanctity of life." This "old" ethic placed intrinsic value on all human life regardless of the perceived quality of that life. The "sanctity of life" ethic is posed by a new ethic gaining favor among some philosophers and medical ethicists that moves society toward a new "quality of life" ethic that places relative value rather than intrinsic value on human life.

The potential results of this movement are frightening. When we begin to address human life based on the value of that life, we must ask, is it not only a matter ot time before the individual will no longer decide personally, but rather. society as a whole will decide, which life is valuable? Is it not only a matter of time before the money motive and cost-cutting policies will replace "death with dignity" and "mercy" as the motives for euthanasia? The elderly, handicapped and mentally impaired will never be safe in a society that puts a relative value on human life. Of course. in due time the acceptance of euthanasia and infanticide will greatly reduce the number of children born mentally impaired or otherwise handicapped and the number of very ill elderly. The potential of the elderly, invariably, being urged to consent to active euthanasia, as a form of service to their country, is a very real possibility (what better way to reduce health care, Medicare and Social Security costs?).

Do these statements seem unreasonable and unlikely? If so, then we only

Informed consent

The Informed Consent bill (SB 141) is still stalled in the Public Health Committee in the Michigan House.

As a minor concession, pro-abortion Chairman Bennane appointed a sub-committee for SB 141. Currently, the subcommittee is tied at four votes each, even though the full Committee has enough prolife votes to pass the bill onto a House vote.

Bennane now says he will develop his own version of informed consent legislation.

Informed Consent will require a 24-hour waiting period and the physician to give the patient information about the risks of abortion and a description and picture of the probable physical development of her unborn baby. The physician also will be required to inform the patient that public agencies are available to assist her during pregnancy and after birth, should she choose to give birth, and that help is available to place her child in an adoptive home, should she choose that option.

The members of this Public Health Committee from metro Detroit are Representatives Bennane (Chairman), Rocca, Barns, Gire, Gubow, Hertel, Hunter, Leland, Palamara, Stallworth, Wozniak, Yokich and Jaye.

other, and delivered of their dead infants. However, occasionally a labor begins at the motel where the patients are required to stay, so Dr. Tiller keeps a nurse there at night.

I feel that Dr. Tiller's late-term abortion practice is wrong and bad and should be made illegal. It is a blot on the record of the Kansas Legislature that they have allowed this nauseating business to continue.

Syndicated columnist Cal Thomas has reported that Peggy Jarman, spokeswoman for Tiller, acknowledged that Tivis once worked at the clinic and handled its medical records, but denies that the clinic performs 10 to 20 lateterm abortions every week. Jarman says the number was closer to 10 per year. Thomas said Jarman did not return two phone calls he made in an effort to clarify the discrepancy.

need to examine the experiment with euthanasia in the Netherlands where the government has found at least a thousand cases in which physicians killed patients without their explicit request!

The advocates of this movement were confident the people of the state of Washington would launch a nationwide movement with the passage of a euthanasia proposition at the ballot box. But the voters in Washington overwhelmingly said no after fully examining the ominous implications of such a policy.

It is vitally important that we address the question of ending a prolonged terminal illness with laws that are very carefully and very narrowly drawn. Michigan has passed the Durable Power of Attorney legislation that allows an individual to designate another person to make medical decisions if that individual becomes incapable of acting on his or her own behalf. Withdrawal or withholding of treatment for a terminally ill person to hasten an imminent death and to ease suffering is one thing. Euthanasia, the active destruction of a non-terminal life, is something completely different. In my opinion, we must proceed with extreme caution, always attentive to government's role in preserving and protecting life.

The events in Michigan, the various court rulings and the vagueness of our laws make it very clear that Michigan must develop responsible legislation dealing with this controversial issue.

Legislation has been introduced by Rep. Ted Wallace, D-Detroit, which would allow physicians to administer fatal injections to their patients who request it under certain guidelines.
