Kennedy Square Rally

The Detroit Chapter of Right to Life - Lifespan hosted the pro-life rally in Kennedy Square in downtown Detroit, Sunday, Jan. 20 from 2-3 p.m. This was to mark the 18th year since the infamous *Roe v. Wade* 1973 Supreme Court decision which legalized abortion through all nine months of pregnancy and has resulted in an estimated 1.5 million abortions per year. The bells tolled 27 times, each toll represented 1 million babies killed in this American holocaust at the hands of the abortionist.

About 250-300 men, women, youths and children braved the cold and leaden skies to listen to, to pray with, and to cheer our master of ceremonies, Ed Smith, and our speakers.


Rev. Rick Parker, Youth Pastor at Grace Chapel in Detroit, urged us to stand up and speak up for life because every life has great value. Even more, we must "put up" — must provide the spiritual, financial, social and perhaps even psychological assistance the expectant mother may need through our pregnancy counseling centers and Pregnancy Shelter programs.

Rev. Priscilla Tucker's, of St. Stevens A.M.E. Church and founder of "Praying Hands Around Detroit," message was "Give Life a Chance," stop the killing in our streets and in the womb.

Atlanta, Georgia — Those good pro-life folks at the Atlanta Constitution are having trouble counting when they run out of fingers and toes. Between 5,000 and 6,000 pro-life demonstrators lined both sides of a three mile stretch of Peach Street. The paper reported, and we quote, "About 300 members of Operation Rescue and other antiabortion groups, many holding signs saying 'Abortion Kills Children' lined Peachtree...from Midtown to Lenox Square."

Several letter writers advised the paper that it would be impossible to "line" that much of Peachtree with a measley 300 protestors. One writer estimated that it would have meant one protestor every 200 feet! He had counted 300 people in one four block stretch alone!

Whiteplains, New York —

Doctors can force-feed a man who has been on a hunger strike since his arrest 47 days ago during an anti-abortion protest, a judge ruled Tuesday.

"The court can't allow a form of protest that harms others or himself," Judge Matthew Coppola said, after a doctor testified that 25 year-old William Hamilton could die in a matter of weeks.

Said Hamilton: "It seems hypocritical that the court is so intent on what it assumes is a threat to my life while...punishing me for trying to save the lives of others."

Arlington, Texas — Students at the University of Texas at Arlington this week voted down a proposal to establish the first on-campus clinic that performs abortions at an American university. Students voted 1,430-746 against

allowing first-trimester abortions in the student health clinic.

Vancouver, British

Columbia — One Friday a month, Dr. John D. Stephens closes his California offices and heads for Blaine, Wash., a town of about 2,500 just inside the U.S. border with Canada.

It is there, in a two-story building, that Stephens has opened a clinic to do what Canadian authorities have denied him permission to do: ultrasound scans to tell women the sex of their unborn children.

What he does is ultrasound. The technique, which has been used for prenatal diagnosis for years, uses sound waves to provide a shadowy image of the fetus on a monitor. Doctors can see the heart beating, can determine whether the baby has all its limbs—and, after 16 to 18 weeks' gestation, can view its genitalia to determine whether it is male or female.

In the six months since he opened his Blaine office, Stephens has been aggressively marketing across the border to East Indians in particular, mass-mailing brochures to their homes and even handing out pamphlets outside Sikh temples on Sundays.

Although Stephens does not mention the word "abortion" in his ads — nor does he perform them — his actions have raised a massive controversy in Canada, with Asian groups accusing him of racism, and members of the medical establishment accusing him of unethical practices.

Now, he is considering opening another office in Niagara Falls, N.Y., or Buffalo, N.Y. He says he has heard there is a large Indian population in nearby Toronto.

Stephens is continuing to raise questions that make even abortion-rights advocates uncomfortable: How easy should it be for a woman to have an abortion just because she wants a child of a different sex?

The doctor, who charges about \$500 for an ultrasound examination, said he is offended by the controversy.

New York — The family of a 13-year old girl who died as a result of an abortion operation has received a \$1.2 million jury award, the largest wrongful-death abortion payment in state history.

The decision in the case of Dawn Ravengell, who died in 1985 at Eastern Women's Center in Manhattan, was reported Tuesday after the jury ruled medical personnel had not kept close enough watch on the girl, who was undergoing the abortion without her parents' knowledge, after complications developed during the surgery.

Nevada — Las Vegas officials are investigating the death of "Baby Adam," who was born alive after a 24-week abortion in September. Nurses at Humana Hospital Sunrise heard the one pound, four ounce baby's cries and rushed him to a specialized care unit, where he was connected to oxygen. But the nurses received "doctor's orders" to discontinue the treatment and return Adam to the room where he was delivered. Left unattended, he died within an hour.

- Salt Lake City One of the nation's most restrictive abortion bills seen as an across-the-country challenge to abortions-on-demand was signed into law Friday by Gov. Norm Bangerter.

- Warsaw, Poland Parliament created a commission Friday to consider whether abortion should be banned for the first time in 35 years and doctors performing the procedure subjected to prison terms.

The legislation, which would reverse a law enacted in 1956, was easily approved by the 100-member Senate. But the 460-member Sejm, the lower house, created a 46-member study commission, and a 45-day period was set aside to gauge public opinion.



A letter from "Sally"

Dear Right to Life - Lifespan,

Hello! How are all of you? We're doing better thanks to all of you! I would first like to thank all of you for your more than generous gifts of cards and money over the holiday season and since you have all heard of my "condition." I feel that I owe you all at least my real name. It is Lynda Sterlini Falkiewicz.

I would like to tell you all a little about myself. In November of 1989 I was blessed with becoming pregnant. I found out January 1st by morning sickness (thinking I had the flu going around) that I later found out about.

In February of 1990 I saw my doctor who did my biopsy and told me it was cancer. He encouraged me (at least tried) to have an abortion. I refused. No one would ever change my mind. My high-risk doctor (who was the best) decided that if that was my decision, he would stand by me. His name is Dr. Welch. He worked out of Hutzel in Detroit and is now getting out of that system and moving to Providence in Southfield. I would highly recommend him to anyone with a high-risk pregnancy.

Daniel was "brought on" six weeks early. John (my fiance) and I took 2 lamaze classes of two hours each and we were ready. We went in the next morning at 7:00 and the labor began at about 11:30. I finally delivered at 2:34 a.m. the following morning. I only had one hour of hard labor

and he was an easy delivery which meant my chemotherapy could be started immediately.

I went through losing my hair, up to 105.4 degree fevers. Now we know I may have only needed 6 weeks of radiation instead of at least 6 months of chemo with some radiation. Also the chemo is affecting me in ways that most doctors have never seen before. All I can say is I'm lucky to be alive.

I went to New York finally for another opinion. We then went to St. Joe's in Ann Arbor, and I have never felt better in my life with treatments and security. I can be trusting and informed of everything.

Now, Daniel is 6 months old and 17 pounds, 9-1/2 ounces. He is just getting over asthmatic bronchitis. He is 26" long. Also John and I are engaged to be married this summer if my health will allow it. I am finally able to get up and take care of myself a little better, but there is still a long road to follow. I would like to thank all of you for helping me down this long road. I hope to be able to respond to each and every one of you someday, but it will take time. I want to thank you for all of your letters. I would like you to know that they always come at the times when I really need to know that people care, when I'm not doing too well. Thank you all for caring about me! I will get in touch someday and I hope to be able to keep you all posted. Thank you!

ROLL CALL VOTES ON ABORTION: 1990

Published by the Federal Legislative Office of the National Right to Life Committee — December, 1990

There were three key abortion-related roll calls in the House of Representatives during 1990. The pro-life side won all three, albeit by narrow margins (ranging from 8 to 13 votes in the 435-member House).

In the 100-member Senate, the pro-abortion side commanded majorities on every issue which came to a vote during 1990, except parental notification for abortion, on which the pro-life side won two votes, the last on a 48 to 48 tie.

Despite the pro-abortion majority, however, pro-life senators prevailed on several issues by invoking their right, under Senate rules, to engage in unlimited debate unless 60 senators vote to curtail debate by "invoking cloture." Proabortion forces repeatedly failed to muster the 60 votes necessary, although they came close on several occasions.

The congressional elections of November 6, 1990, resulted in modest gains for the pro-abortion side; one or two seats in the Senate (depending on the issue), and about eight seats in the House. This increases the likelihood that some pro-abortion bills may reach President Bush's desk during the 102nd Congress, which convenes in January 1991. However, no such bill could be enacted over the President's veto unless two-thirds of each house votes to override—a formidable obstacle to pro-abortion forces.

U.S. CONGRESS "FREEDOM OF CHOICE ACT"

On October 4, 1990, a House subcommittee approved a bill which would effectively prohibit the states from restricting abortion at any stage of pregnancy—including even such peripheral regulations as laws requiring parental notification prior to performance of an abortion on a minor.

This bill, the so-called "Freedom of Choice Act" (FOCA), did not reach the floor of either house during the 1989-90 Congress. But pro-abortion groups are expected to push for action on the measure during the 1991-92 Congress.

The FOCA (HR 3700, S. 1912) was introduced on November 17, 1989, by pro-abortion leaders in Congress. By the end of 1990, it had been sponsored by 26 senators and 128 House members.

Press accounts sometimes misleadingly state that this bill would "put into Federal law the principles of *Roe v.Wade*," but in fact even the bill's sponsors admit that it would invalidate some laws which have been upheld under *Roe v. Wade* (for example, parental notification laws).

The bill says flatly that states "may not restrict" abortion prior to fetal "viability," the point at which the baby can survive independently of the mother. (With current medical knowledge, "viability" begins at about 22 or 23 weeks—but the bill does not define the term, and sponsors of the bill insist that the abortionist himself must be allowed to decide whether any given unborn child is "viable.")

The bill would also grant women an unlimited right to abortion even after viability for "health" reasons. As defined by the Supreme Court in Doe v. Bolton (1973) and later rulings, "health" includes all factors, including emotional factors, considered pertinent to a woman's "well being."

Thus, the FOCA would effectively bar the states from enforcing any real restrictions on abortion at any point during pregnancy.

Co-sponsors of this bill from the Metro Detroit area are John Conyers, Jr. (D-Detroit, District 1) and Sander Levin (D-Southfield, District 17).


Assisted Suicide

In the wake of Dr. Kevorkian's suicide machine, bills making assisted suicide a felony have been introduced in both the Michigan Senate (SB 31 and 32) and House (HB 4038 and 4039). The bills are exactly the same, but have been doubly introduced to facilitate passage. There are safeguards in the bills to protect doctors and caregivers administering pain medication, also excluded is withdrawal of treatment under the durable power of attorney legislation. However, this legislation will make it illegal if the intent is to actively assist a person to commit suicide. The felony is punishable by up to four years in prison and a \$2000 fine. Coercing a suicide would be first-degree murder, mandating a life sentence. Please write your legislators and ask them to support these bills.

Informed Consent

Informed consent bills should be introduced this month in the Michigan legislature. This legislation would require women seeking abortions to be told about the risks, alternatives, and fetal development. There will also be a 24-hour waiting period. Women have a right to know the facts before they have an abortion. Ask your legislators to support this legislation.


From the President's desk



Mother of the Year



Ann Thomas, President of Right to Life - Lifespan, Inc. and Carol Smith, Chairperson of the Detroit Chapter, reminded us of our 1990 pro-life victories, passage of the Parental Consent law and election of a pro-life governor, John Engler. Hopefully, 1991 will see us closer to achieving our goal to overturn the *Roe v. Wade* Supreme Court decision and restore legal protection to all life.

The wonderful sidewalk counselor, Joe Iskra, champion of love and life, reminded us of the enormous work to be done as 1 out of every 4 pregnancies is being destroyed — 3 babies per minute. He cited the enemies: Ignorance of the development of the preborn, Silence about the truth of abortion and its effects on our mothers and our society, and Hard-heartedness, which refuses to recognize the humanity of our preborn; as in past times we have refused to recognize the humanity of the red man, the black man and, in Germany, the Jew. His solution is love and sacrifice which ends ignorance. softens the hard-hearted, and proclaims the truth.

Joe introduced Edna Mullen, mother of five, whom he met outside an abortion mill during sidewalk counseling. She listened to Joe, decided to give birth to her child in the womb and about a month ago delivered Lashawnda. She gave a dramatic interpretation of Langstan Hughes' poem, The Negro Mother.

Music and song were provided by Ward Presbyterian Church of Livonia under the direction of Terry Smith. Very appropriate selections were "Children of the Heavenly Father" and "Jesus Loves the Little Children."







March for Life, Washington, D.C.

On Monday evening, January 21st, at 8 p.m., I boarded the bus bound for the 1991 March for Life in Washington, D.C. It was my first time to brave the January chills in D.C. to protest the infamous *Roe v. Wade* Supreme Court decision. Just as important as lobbying Congress and making our presence known, I was to discover, is the energy that comes from making contact with the really good people who constitute the backbone of the pro-life movement.

Nellie Gray, President of March for Life, estimated the crowd at 50,000 and attributed the lower crowd size than usual to the war in the Gulf and fears of terrorist attacks in the Capitol. She invited people to begin the March up around the Capitol Building to the Supreme Court building.

I hung back as the masses of people started on the March. I climbed on the base of a lightpost to get a better view and watched the flow of humanity surging past: A man in a wheel chair. Enthusiastic college students. A sea of senior citizens. Parents pushing strollers. Kids carrying signs as big as they were. Banners from Philadelphia, Michigan, Illinois, Florida, sunflowers with "KS" scrawled on them, signs in Spanish, and everywhere the yellow-and-black Knights of Columbus signs that proclaimed "The Natural Choice is Life!"...

One part of the March is up a hill, and it was an impressive sight to see the thousands of marchers ahead of me, and then

to turn around, and even though I thought I was near the tail end of the crowd, to see more and more people behind me.

And at the end of the March, the Supreme Court building looked imposing against the blue sky, like the scene out of so many movies and news reel clips. A cordon of policemen and yellow-and-black tape protected the approach to its pristine beauty, a seeming case of overkill against the swirling masses of people who were dispersing to lobby their legislators, and the high-spirited group of college students who took up and led the chant: "Hey, ho! Hey, ho! Roe v. Wade must go!"

How Did Becky Bell Die?

ro-abortion groups are saying that Becky Bell, a 17year-old Indianapolis girl who died two years ago, was the victim of an Indiana parental consent law. They say she died of an illegal, botched abortion because she was afraid to tell her parents she was pregnant, as required under Indiana's law. They have produced a video distorting the circumstances of her death and blaming it on the law. They have even recruited Becky's parents to help them in their opposition to parental involvement laws.

But medical evidence indicates that Becky Bell never had an induced abortion at all—legal or illegal! According to the coroner's report, there was no sign of damage to the cervix or infection of the uterus, both of which would have been present if she had had an illegal abortion. Instead, a careful reading of the report would suggest that she had a miscarriage or "spontaneous abortion." There was massive infection in her lungs, indicating that the real cause of death was pneumonia.

Moreover, Becky's best friend Heather Clark maintains that Becky never had an abortion. Heather was in Becky's confidence as she wavered between going to Kentucky to have an abortion or carrying the baby to term and giving it up for adoption, postponing a decision as long as possible. On the day before her death, Becky asked Heather to make an appointment for her at a Kentucky abortion clinic—an appointment which she never kept. Heather believes that her friend had a miscarriage.

Medical evidence indicates that Becky Bell never had an induced abortion at all — legal or illegal!

Abortion advocates have launched a massive campaign, taking their distorted video to high school and college campuses in an attempt to create a backlash against parental involvement laws, which are favored by a strong majority of Americans. Pro-lifers need to know the truth about Becky

Bell's death so that we can counter the false arguments that the pro-abortionists are spreading through the media.
