Washington, D. C. —

The pregnancy rate for teen-agers aged 15 to 19 in the District of Columbia soared nearly 20 percent in 1989, according to the Washington Post. At the same time, Family Planning Perspectives, a publication of the Planned Parenthood-affiliated Alan Guttmacher Institute, rated the public schools in our nation's capital as having one of the best, if not the best, sex education curriculums in the nation.

Washington State —

In November, Washington State voters will be faced with two initiatives, one of which would legalize lethal injection, while the other would mandate the killing of any baby who survives an abortion and require abortion funding equal to state expenditures for maternity and pre-natal care.

Washington is the first and only state to ever legalize abortion by direct vote of the people. In light of that fact, the Hemlock Society is optimistic that this same electorate will approve the first lethal injection legalization in the world.

Hemlock Society pro-euthanasia efforts have been concentrated in the states of Oregon and Washington for several years now because the area's population seems particularly receptive to anti-life measures. Recent surveys which show that region to have the lowest percentage of churchgoers in the nation may provide a clue to the root cause of this attitude.

Massachusetts —

A fetus has the right to sue for the loss of its father's companionship.

The unanimous ruling by the Massachusetts Supreme Judicial Court reversed a decision in Superior Court in Bristol County against Jeremy Michael Angelini, who was not yet born when his father, Leo LePage, was injured Sept. 29, 1985, in a car crash.

Colorado —

Betty Peterson, an 87-year-old woman described by nurses as alert and responsive, died July 20 after being denied food and water for 12 days. Her death followed an order by Judge Rebecca Bromley authorizing Mrs. Peterson's family to end her tube feeding. Apparently intending to help set a statewide pro-euthanasia precedent, Bromley also ordered the decision to be appealed, while refusing to issue a stay. By this action, said Colorado Right to Life president Tom Longua, "Judge Bromley guaranteed that Betty Peterson would be dead before the appeal was heard." Mrs. Peterson, a stroke victim who was NOT in a "persistent vegetative state," had never expressed a wish to be denied food and water. NRLC executive director David N. O'Steen, Ph.D., said, "The cynicism and utter disrespect for Mrs. Peterson is unprecedented, even in an era when helpless patients are often starved and dehydrated to death."

Romania —

Almost 1 million abortions were performed in Romania during 1990; that's three abortions for every live birth in the troubled country. By way of comparison, the United States with its 1.5 million annual abortions, has one abortion for every 2.8 births. Romanian health officials, searching for ways to reduce the number of abortions, are planning to raise the cost of the surgery from the equivalent of 50 cents to \$8.50.

Miami Beach -

The abortion issue was hotly debated at the National Education Association's annual convention in Miami Beach July 7, but the country's largest teacher's union kept its pro-abortion stand despite intense efforts by prolife teachers. Among other actions, the NEA prohibited distribution of prolife literature and buttons, called for the legalization of RU 486, and expressed "grave concern"

about the nomination of Judge Clarence Thomas to serve on the Supreme Court. — National Right to Life Chapter Newsletter, August 5, 1991

Euthanasia in the 90s

"Aid in dying is the last 'pro-choice frontier." So says Rita Marker who will be guest speaker of the Educational Center for Life Workshop on Saturday, November 9, 1991, 8:00 a.m. to 3 p.m. at the Botsford Inn, 28000 Grand River (corner of 8 Mile and Middlebelt).

Ms. Marker is co-director of the International Anti-Euthanasia Task Force at the Human Life Center, University of Steubenville, Steubenville, Ohio. In the statement above, she is quoting Derek Humphrey, founder of the Hemlock Society, who managed the death of his first wife by lacing her coffee with lethal drugs, but who admits he had two pillows handy to smother her in case the poison did not work.

Ms. Marker, who will discuss Assisted Suicide, Living Wills and Durable Power of Attorney, points out that the campaign for managed death

follows the outline of the campaign that resulted in *Roe v. Wade*:

 "The 'hard case' is used to show a need for change in the law.



- Slogans are based on 'rights' and 'choice.'
- Charges are hurled at those opposing change, accusing them of 'trying to impose their morality' by protecting

- outmoded laws.
- Assurances are given that needed law reform will 'not result in abuse.'

She points out that in Holland, euthanasia is practiced openly and lethal injection is described as "safe" since it must be reported. Yet only a small proportion is actually reporting, and many Dutch doctors list euthanasia killing as "death by natural causes" on death certificates.

Book Review

Third Time Around: A History of the Pro-Life Movement from the First Century to the Present, by George Grant. Brentwood, TN: Wolgemuth & Hyatt Publishers, Inc., 1991, 221 pp.

Feeling discouraged over the slow pace of prolife victories and the seemingly unbreakable grip the prodeath philosophy appears to have on our society?

Third Time Around is the perfect pick-me-up for battle-weary prolifers. George Grant explains that yes, Christianity has always "imposed its morality on society" — and without the work of committed prolifers over the centuries, we would have NO public hospitals, NO orphanages, NO protection of the handicapped; in other words, many of the basics of humane treatment that our society takes for granted are the result of hard-fought fights by prolifers throughout the ages.

Grant vividly portrays the circumstances of previous prolife challenges, starting from the abandonment of unwanted babies and the infirm as an accepted practice in most pre-Judaic cultures, right up to the current American legal and educational efforts to

combat abortion and euthanasia as "rights."

He profiles the personalities of each age so that we can learn from their strategies and take encouragement from their persistence. Did you know, for example, that St. Vincent de Paul, renowned worldwide for his work in clothing the naked and feeding the poor, began in 1652 to crusade against the illegal abortion guilds of his time? Time and time again, I was surprised by famous names from history who have taken up the prolife banner to dispel the pro-death forces of their age; George Grant encourages us to tap into this rich heritage.

I came away from reading this pageturning book feeling invigorated and inspired, ready to plunge into the fray once again. I highly recommend it to others as well.

It is our understanding that state funds will no longer be available for the 38 programs that presently come under this budget.





What Did Dr. Koop Really Say?

In July, 1987 at a briefing for Right to Life leaders, President Reagan directed his Surgeon General, Dr. C. Everett Koop, to prepare a report on the mental and physical health of women following abortion. The opposition has made hay out of the Koop reply. In fact, at a recent "Dayna" show on Channel 2 in Detroit, a representative of Michigan's chapter of the National Abortion Rights Action League stated that Koop said the mental post-abortion effects were "miniscule." We disagree.

But what did Dr. Koop really say? In both his cover letter to President Reagan on January 9, 1989 and his full report to the American people, he begins by stating that, in his past he had been "very outspoken against abortion." (In fact, he co-authored the book and video titled Whatever Happened to the Human Race?, the video portion of which has been shown widely to church and educational groups.)

In replying to the President, Dr. Koop felt obliged to take off his prolife hat and put on his Surgeon General's hat, adhering to a neutral stance and referring to the scientific evidence from both sides of the debate, while admitting that both sides are emotionally highly charged.

In his efforts to maintain neutrality, some curious aspects emerge: Under "Human Development," he says there is much controversy about when life begins and when that life becomes human,¹ continuing that it's a question that "cannot yet be answered with

scientific certainty." After saying that, he details conception — the egg and sperm uniting to form a single cell with its genetic wonders as set forth in the DNA, and concludes, "From conception until death, human growth is a continuing and maturing process — physically and, eventually mentally and emotionally." So that to our unpracticed eye, his description of conception neatly answers the question of when life begins.

He says that there are almost 250 studies reported in the scientific literature dealing with the psychological effects of abortion. He called on his staff in several agencies of the Public Health Service to evaluate them against "appropriate criteria and these were found to be flawed methodologically."3 In other words, were the findings of Study A or B or C compared with a similar control group of women who had carried to term? And, for instance, did the adverse effects stem directly from the abortion itself, or were they a composite effect of an abusive or unhappy past of which the abortion was the final blow?

50% of women who have had an abortion deny having had one.

Another interesting aspect of his neutrality is evident when he says, "Anecdotal evidence abounds on both sides." (This is true.) Then he adds, "When pregnancy, whether wanted or unwanted, comes to full term and delivery, there is a well-documented, low incidence of adverse mental effects."

His comments on abortion's physical effects tally with those widely reported: infertility, damaged cervix, premature birth, etc. and he says that these events are difficult to prove because a) half the abortions are done in free-standing clinics where helpful records have not

been kept, and b) because 50% of women who have had abortions deny having had an abortion. Further, many of the above physical problems may occur in women who carry to term or who have never been pregnant.

He calls on the government to do a study on a "cohort of women of child-bearing age on the variable outcomes of mating.⁵ This would include effects of failure to conceive as well as physical and mental outcomes of pregnancy, "planned or unplanned, wanted and unwanted, whether carried to term, miscarried or aborted." He estimates a 5-year study could be done for \$10 million or up to \$100 million, but says a major problem in designing the study is eliminating the gap between women who admit and those who deny having had the operation.

The report is a recognition that the entire abortion controversy has many faces and depths of understanding not yet penetrated. In discussing the woman who carries to term he suggests, "The sexual partners of such women should be held jointly responsible for the mother's and child's medical care and for child support."7 And more importantly, he says, "The public issue of abortion is not primarily about health but about morality and law." 8 This is a thoughtful document by a man concerned with our people. Nowhere does he say post-abortion syndrome is "miniscule." On the contrary, he wants to carry current studies much farther.

Congressional Abortion Battles Heat Up Congress Must Hear from ProLife Americans

President Bush vetoed a bill August 17 that would have allowed the District of Columbia to fund abortions. "From the outset of my administration, I have repeatedly stated my deep personal concern about the tragedy in America of abortion on demand," he told Congress. "As a nation, we must protect the unborn." This veto marks the third time Bush has vetoed the District's funding bill because of the abortion language.

The President's veto sent a message to pro-abortion leaders in Congress, who were unusually busy just before August recess promoting a flurry of abortion-related bills. Among other actions, prolife forces in the Senate August 1 narrowly defeated an amendment to the Department of Defense authorization bill, S. 1507, that would have required U.S. military hospitals overseas to perform abortion on demand. The measure, sponsored by pro-abortion Sen. Timothy Wirth (D-Co.), fell two votes short of the 60 votes necessary to "invoke cloture." a procedure used to limit debate. The House of Representatives had already passed a version of the defense bill which contains the pro-abortion language: the two versions now head to a conference committee where their differences will be resolved.

Separate bills have been passed in both House and Senate which would nullify the Bush Administration's prolife Title X regulations preventing federally-funded family-planning clinics from counseling or referring for abortion. The regulations were upheld

by the Supreme Court recently in *Rust* vs. Sullivan, but are the target of a multi-million dollar campaign by Planned Parenthood. Prolifers have responded with their own media campaign designed to educate Americans on Title X, which has met with a positive response.

National Right to Life Committee President Wanda Franz, Ph.D. makes it clear that grassroots prolifers need to raise hometown lobbying and letterwriting efforts to a higher pitch. "It is critical that prolifers meet with their congressman and senators to lobby in support of the prolife regulations and parental notification," she said.

They will be warned

Recently I received a letter that explains better than I can the need for the informed consent legislation (SB 141), which I introduced. The bill requires a physician, prior to performing an abortion, to inform the patient about the risks of abortion and show the patient a picture of an unborn baby at the same gestational age as the patient's. My only regret since introducing SB 141 is that it was not a law in time to prevent the tragedy described in a letter to me from a woman who had an abortion less than six weeks before the bill passed the Senate.

"... I was running one hour late when I finally arrived at the Highland Park Clinic," a woman named Cheryl wrote. "I walked in in shock and crying very heavy. The lady asked me for the money and I handed it to her. She then looked at me and asked if I was OK. I never replied. I was then taken into a room and within one minute they started an I.V. to put me under. I fully remember telling the nurse at that time to stop, that I did NOT want this done.

"When I came around I was fully dressed (I'd also like to say I never undressed myself). . . At that time the nurse said it was over. . . If someone would have given me one minute I would have never done what I did. I will pay for this the rest of my life. Physically I have paid also. I had a bad infection having to follow up with a D & C at the hospital. . . can't do anything to bring my child to life," she concluded, "but if I could save another girl from the pain I go through each and every day then I hope this will help."

Before SB 141 got to the Senate floor, my committee heard testimony from many women like Cheryl who bared their private lives in public testimony in an effort to protect other women from suffering at the hands of a deceptive abortion industry. They and many others who have written are the driving force behind the informed consent bill.

Critics claim that SB 141 is a state intrusion into the traditional doctor/patient relationship and an insult to women because it assumed they cannot make an abortion decision without state assistance. With abortion, however, a doctor/patient relationship seldom exists. Most abortions are performed in clinics where the patient's only contact with a doctor occurs when the abortion is being performed. Any counseling is usually given by people with a financial interest in killing the patient's unborn baby.

Had the abortion industry over the years been up-front with women about the reality of abortion, instead of giving them the impression that they were simply getting a "blob of tissue" removed in a procedure as safe as getting a tooth pulled, there would be no public clamor for informed consent legislation.

Even under abortion-supported Governor Blanchard's administration, the state health department acknowledged that the risks of abortion include perforation of the uterus, infection hemorrhaging, sterility and death. What have we got to lose by telling women of these risks?

I would rather risk insulting women who know the reality of abortion than risk having any woman learn the truth after it is too late.

This is not "shock" legislation meant to scare women. The bill "does not require disclosure of information beyond what a physician is required to possess to be licensed." The medical information, including the photos of

unborn babies, must be medically accurate.

Contrary to the claims of abortion advocates, SB 141 does not force women to receive anti-abortion counseling and messages. All referrals to services to assist the patient, whether or not she had the abortion, are to be made to "public agencies." I added the "public agency" wording so doctors could not refer patients to either a prolife agency or an abortion agency.

One of the most misunderstood aspects of SB 141 is the 24-hour waiting period. This does not apply if a delay would threaten the health or life of a woman. We give consumers three days to cancel most business contracts. What's wrong with giving women one day to think about a decision that will affect them the rest of their lives?

Informed consent is not a radical concept. Michigan already has an informed consent law, which I supported, regarding alternative methods of breast cancer treatment.

Government forces tobacco and alcohol companies to put warning labels on their products, and these warnings include the dangers their products pose to unborn babies. Nevertheless, people continue to smoke, drink, and women will continue to get abortions after the informed consent bill becomes law. However, at least they will have been warned of the risks involved — and I have more confidence in the wisdom of an informed woman than I do in the advice of an abortionist with a financial interest in killing that woman's unborn baby.

MICHIGAN ABORTION FACTS

The following statistics are from the 1990 Report on Abortions in Michigan, Office of the State Registrar and Center for Health Statistics, Michigan Department of Public Health.

- A total of 36,183 abortions were reported in 1990. The number of abortions declined 1 percent in 1990, with 36,557 reported in 1989.
- 44.7% of women procuring abortions in 1990 have had at least one previous abortion, while 16.6% have had two or more.
- 54.5% of abortions in 1990 were performed on women residing in Macomb, Oakland and Wayne Counties.
- 51.7% of the unborn babies killed were at a gestational age of 9 weeks or greater.
- 168 abortions were performed when the unborn child was over 20 weeks old. Nineteen of these showed "evidence of life."
- Table 3 of the report is reprinted below in its entirety.

"Instead of decreasing and aiming to eliminate the stocks that are most detrimental to the future of the race and the world it tends to render them to a menacing degree dominant."

In the late 1930s Sanger instituted the Negro Project, a program to gain the backing of black ministers, physicians and political leaders for birth control and sterilization in the black community. Sanger wrote, "The most successful education approach to the Negro is through a religious appeal. We do not want word to go out that we want to exterminate the Negro population and the minister is the man who can straighten out that idea if it ever occurs to any of their more rebellious members."

There are disturbing indications that this state of mind has not vanished. Even now, 70% of the clinics operated by Planned Parenthood — the operator of the largest chain of abortion facilities in the nation - are in black and Hispanic neighborhoods. The schools in which their school-based clinics are located are substantially non-white. In a March 1939 letter, Sanger explained why clinics had to be located where the "dysgenic" races lived: "The birth control clinics all over the country are doing their utmost to reach the lower strata of our population . . . but we must realize that there are hundreds of thousands of women who never leave their own vicinity."

Blacks must no longer keep silent on this issue. We cannot permit the public to continue to imagine that we are obediently following our national leaders in endorsing abortion on demand and we must resist the forces that drive black women to seek abortion. The black community in cities such as Baltimore, Chicago, Detroit and Washington, D.C. has started crisis pregnancy centers to help these women. We are already besieged by homicide, drugs, AIDS and an alarmingly high infant mortality rate. We do not need to re-enact the sterilization programs of the 1930s and 1940s.

Debunking the myths . . .

Abortion is Not a Civil Right

The battle around the abortion issue has raged for years with the understanding that the major combatants involved are either white liberals, white evangelical Protestants or white Catholics.

Meanwhile, black America — which is affected more profoundly by abortion than is any other group in society has experienced its own sharp internal division. While most black leaders have favored abortion rights, opinion surveys have found mainstream blacks to be among those most strongly opposed to abortion on demand.

Where does black America really stand on the issue? Statistics from the Department of Health and Human Services suggest that black women are more than twice as likely to abort their children as white women. For every three black babies born, two are aborted. Forty-three percent of all abortions in the U.S. are performed on black women. From figures supplied by the federal government and the Alan Guttmacher Institute, Richard D. Glasow of National Right to Life has estimated that some 400,000 black pregnancies are aborted each year. At the same time, according to a 1988 poll taken by the National Opinion Research Center, 62% of blacks said abortion should be illegal under all circumstances.

How can blacks consistently tell pollsters they oppose abortion while we exercise that right proportionately more than any other group in America? In part, black abortion rates reflect the pressure of social service and private welfare agencies in our communities. A black teen-ager told me she had asked Planned Parenthood in Detroit for help in carrying her baby to term and putting it up for adoption. But because the baby's father was white, a clinician advised her to abort the baby because, "No one wants to adopt a zebra." Better-educated black women are pushed toward abortion by different forces: the threat to educational hopes or aspirations to economic independence.

For every three black babies born, two are aborted.

As these women struggle with their profound moral choices, many national black leaders have ceased to look at abortion as a moral problem with moral consequences, and have come to see it instead as an opportunity for forging political alliances. At the March for Life rally in 1977 Jesse Jackson said, "The solution to a [crisis pregnancy] is not to kill the innocent baby but to deal with [the mother's] values and her attitudes

toward life." Twelve years later, he spoke to the enormous April 1989 abortion rights march in Washington.

The black leadership has succumbed to the temptation to present abortion as a civil rights issue. By this reasoning. abortion is to women in the 1980s what desegregation was to blacks in the 1960s. Any erosion of abortion rights would accelerate the "move to the right" that black leaders say threatens black progress. At a news conference earlier this year (1989) sponsored by Planned Parenthood, Jesse Jackson, Andrew Young and Julian Bond issued a statement denouncing Operation Rescue, comparing those who participate in abortion clinic sit-ins to "the segregationists who fought desperately to block black Americans from access to their rights."

But many blacks wonder whether black civil rights and abortion fit so neatly together. Black pregnancies have historically been the target of social engineers such as Margaret Sanger, founder of Planned Parenthood. Sanger was convinced that blacks, Jews, Eastern Europeans and other non-Aryan groups were detracting from the creative intellectual and social potential of America, and she wanted those groups' numbers reduced. In her first book, "Pivot of Civilization," she warned of free maternity care for the poor:
