

LEGISLATIVE NEWS



TWO OBJECTIONABLE BILLS DEBATED IN MICHIGAN HOUSE

Michigan H.B. 4176 (Rep. P. Bullard, Dem.) allows patients to refuse food and water. This dangerous proposal must be defeated. When this Newsletter was typed, the bill had not been voted upon. Please call the Main Office, 261-2757, to see if you should write or call your legislator to express your opinion. The bill may have already been decided when you read this in January.

Michigan H.B. 4647 (Rep. D. Hollister) is the old durable power of attorney bill. It was passed out of committee on Wednesday, December 9, without protection for unborn and prohibition for withdrawal of food and water. As it is, Lifespan does not support the bill.

Right to Life of Michigan strongly supports a provision entitled, "H-2, the Ciaramitaro Substitute." It is a pro-life alternative to, among other things, allow individuals to appoint a Patient Advocate to make medical treatment decisions for the patient during periods of incapacity. There are other significant safeguards, especially one which forbids withdrawal of food and water.

PLANNED PARENTHOOD, U.N. FUND LOSE BID FOR FOREIGN AID

WASHINGTON--Two major pro-abortion groups suffered sharp defeats when the Senate Appropriations Committee voted against restoring U.S. "population assistance" funds to the Planned Parenthood Federation of America (PPFA) and to the United Nations Fund for Population Activities (UNFPA).

The Committee rejected a proposal to overturn the "Mexico City Policy." The Mexico City Policy denies U.S. population-control funds to private organizations which promote abortion or campaign for the legalization of abortion in other nations.

Senator Daniel Inouye (D-HI) proposed language for the Fiscal Year 1988 Foreign Aid Appropriations Bill to overturn the Mexico City Policy. But the committee voted 14 to 11 to adopt an amendment by Senator Bob Kasten (R-WI) which preserved the Mexico City Policy.

The Mexico City Policy, announced by President Reagan in 1984, has resulted in removal of U.S. funds from the International Planned Parenthood Federation. In addition, the Planned Parenthood Federation of America (PPFA) has announced that it will not accept funds under the Mexico City conditions when its current contract with the Agency for International Development (A.I.D.) expires on December 31.

PPFA has spent a reported \$1.5 million this year on advertising and a legal campaign to overturn the Mexico City Policy. A U.S. District Court in New York rejected PPFA's legal challenge to the Policy on September 29.

SPLIT SUPREME COURT VOTE KEEPS ABORTION RIGHTS FOR MINORS

The Supreme Court, in a split decision that sets no national precedent, on Monday let stand a lower court ruling striking down an Illinois law that restricted minors'

The Court, one member short since Justice Lewis Powell retired in June, split 4-4 to affirm a lower court ruling declaring invalid portions of the law, which placed restrictions, including a 24-hour waiting period, on a minor's right to abortion.

The ruling, in a one-line order in the case Hartigan vs. Zbaraz, did not list the votes of the individual justices. It was an anti-climactic ending to a case that has

been before the Court for more than a year.

Groups on both sides of the abortion issue and members of the Senate were quick to note the impact Judge Anthony Kennedy, whose confirmation hearings began Monday before the Senate Judiciary Committee, could have on the next abortion case.

However, legal scholars also noted that the court's landmark 1973 decision, Roe vs. Wade, decided on a 7-2 vote with Justices William Rehnquist and Byron White in dissent, would not necessarily stand or fall on Kennedy's vote if the issue were to

come before the court again.

They said the Illinois case did not address the basic right to abortion and instead dealt with the extent of a minor's access to the procedure, a right the court already has said is not as extensive as that of adults. They said there is no evidence the court would be equally divided if the basic right to abortion were at issue. --Detroit Free Press, December 15, 1987

DOWNRIVER CHAPTER LEADS OPPOSITION TO SCHOOL BASED CLINIC

A very small news item in The Detroit Free Press, October 30 is headlined: "Taylor -- No Teen Health Clinic."

The article says: "The Board of Education voted 4-3 this week to rescind a June resolution approving a teen clinic at Taylor Center High School, which was to provide sports physicals, counseling, medical care and tests for sexually transmitted diseases."

The rest of the story, which was not printed, should congratulate this major victory by the Lifespan Downriver Chapter led by local pastors and many individuals whose opposition caused the Board of Education to rescind their previous decision. Part of the reason this prolife group opposed the clinic was that they did not trust the clinic's operators to abide by the law which prohibits school-based clinics from prescribing abortions.

MEA ADVISES MEMBERS ON ABORTION POLICY

The Voice, the local Michigan Education Association paper published an article November 16 to assist its membership in dealing with the new state policy which prohibits school employees from making referrals for abortions.

MEA attorneys say that the act applies to school employees acting within the

scope of their employment.

The article continues with MEA attorneys' recommendations for "avoiding problems with the section."

"If a student asks you where she can get an abortion, or if you feel that a student needs pregnancy counseling, refer that student to an organization or social service agency that presents all options that are available."

"Do not refer a student to an organization or physician who solely advocates

abortions or performs abortions," the article adds.

A SYMPOSIUM: OUR COUNTRY MOVES TOWARD EUTHANASIA

(Those who respect life should become increasingly aware of our country's tendency toward legalizing euthanasia. The following excerpts from three timely articles are an overview of the movement in that direction. Ed. Note)

DOCTOR SPECIALIZES IN MANAGING DEATH

There is a new medical specialty making its worldwide debut right here in Michigan. It is called obitiatry -- the medical management of death.

When practiced according to special principles, obitiatry would offer terminal patients the means to end their lives.

The specialty's founder and first practitioner, Jack Kevorkian, M.D. of Royal Oak says "obitratrists" would offer active euthanasia to people with terminal illnesses who wish to die without suffering. Right now he is waiting for his first patient. He will work for free.

Kevorkian says he fully expects to be arrested after supervising the death of his first patient, but says he welcomes prosecution because it will force government, the public and organized medicine to face the issue.

He will not actively take part in killing the terminal patient but will describe the method of death and advise the family of a procedure to use. This way he would only be charged with abetting suicide.

CALIFORNIA BAR ASSOC. SUPPORTS DOCTOR ASSISTED SUICIDE

"Legal Delegates OK Euthanasia for Terminally III in California." Such is the headline of a story in the <u>Lansing State Journal</u>, September 22, 1987 by Bob Egelko, an Associated Press writer.

The article says that the California Bar Association delegates have approved a resolution supporting "doctor-assisted suicide."

Such suicide would involve doctors giving terminally ill patients a prescription for a lethal dose of drugs.

After an intense debate, delegates to the C.B.A.'s annual meeting voted 282-239 to direct the organization's Board of Governors to back a euthanasia bill before the state legislature.

The law now allows a healthy person to authorize removal of life-saving measures in the event of future terminal illness. Courts have also authorized doctors to withhold food and water at the request of an incurably ill patient.

This measure would go further by allowing a doctor to give the patient a prescription-drug dose at the patient's request that would cause instant death.

Opponents have said that the proposal was a perversion of medical practice and would lead to pressures on patients to die for the convenience of others.

EFFECTS OF WITHHOLDING FOOD AND WATER DESCRIBED

In an article entitled, "Come Sweet Death," by Nat Hentoff published in the NRLC News, September 15, 1987, Mr. Hentoff writes about the trial to determine whether it would be legal to remove a feeding tube from Paul Brophy to allow him to die by withholding food and water.

In his finding of fact, according to Hentoff, the trial judge, David Kopelman, listed the effects a person's body would be likely to experience if he were to be

deprived of all nutrition and hydration.

(a) His mouth would dry out and become caked or coated with thick material.

(b) His lips would become parched and cracked or fissured.

(c) His tongue would become swollen and might crack.

(d) His eyes would sink back into their orbits.

(e) His cheeks would become hollow.

(f) The mucosa (lining) of his nose might crack and cause his nose to bleed.

(g) His skin would hang loose on his body and become dry and scaly.

(h) His urine would become highly concentrated, causing burning of the bladder.(i) The lining of his stomach would dry out, causing dry heaves and vomiting.

(J) He would develop hyperthermia, a very high body temperature.(k) His brain cells would begin drying out, causing convulsions.

(1) His respiratory tract would dry out, giving rise to very thick secretions, which could plug his lungs and cause death.

(m) Eventually his major organs would fail, including his lungs, heart, and brain. This information disturbed the judge. So did testimony by Dr. Richard Field, the Chief of Staff at New England Sinai Hospital, where Paul Brophy was a patient. Dr. Field was asked if he had ever seen a person dehydrate and starve to death. Yes, he had. When? During World War II, Dr. Field explained, he had been attached to an infantry division, and it was his division that liberated Dachau. The courtroom became very quiet. "I saw," Dr. Field said, "literally thousands of people who had been subject to both dehydration and starvation -- both dead and dying...Bringing about death through dehydration and starvation is a barbaric and savage way to induce death, and as such is cruel and abusive and not conscionable."

SEX-SELECTIVE ABORTIONS CHALLENGED

"Any woman in the United States can legally get an abortion because she doesn't like the sex of her baby." So states an Americans United for Life letter dated Nov. 16.

The American Civil Liberties Union (ACLU) and other representatives of the abortion industry are challenging some Illinois legislation which specifically prohibits the practice of aborting children for sex selection.

"Any case that points out the personhood of an unborn child can fracture the illusion that the Constitution protects a mother's right to abort her baby.

"It would lead to the reversal of Roe v. Wade and the restoration of legal

protection of unborn children," the letter continues.

Since sex-selective abortions take place in the fourth to ninth month of pregnancy after the baby's sex is determined, all such abortions are late-term abortions.

The AUL Legal Defense Fund is raising money to defend this case entitled, Keith vs. Daley.

To have the ACLU--the self-proclaimed legal protector of all of our rights--

supporting this suit just adds to the drama.
