# PRO-ABORTION GROUP FILES PETITIONS

A group that wants Michigan to continue paying for abortions for the poor filed nearly 230,000 signatures with the State, Tues. March 1 to allow voters to decide the question in November.

Judith Frey, spokesperson for the People's Campaign for Choice which wants the State to continue paying \$5.8 million yearly for 18,500 abortions, said her supporters could spend as much as \$3 million this fall.

Right to Life of Michigan collected 400,000 signatures last year to end state-paid abortions. The courts ruled that the ban would not take effect until March 29 or 30 which is 90 days after the end of last year's legislative session. It appears that the state will not be able to review all the pro-abortion petition signatures by March 30 so there may be a suspension of payments for abortions until the signatures are validated.

"In a close election, that confusion could spell the margin of victory -- or defeat," the article says.

# MEA'S \$30,000 SUPPORTS ABORTION BACKERS

The Committee for the Protection of Michigan Lives (pro-abortion petition drive) raised \$307,000 spearheaded by contributions from the Michigan Education Association (\$30,000), Chapters of Planned Parenthood (\$3,832), Michigan NOW (\$12,584), and the ACLU of Michigan (\$4,761).

It is most interesting that not all MEA members are in agreement with the pro-abortion approach to abortion but their money nevertheless is contributed to this effort.

Barbara Listing, President of Right to Life of Michigan, said that both sides would spend between \$2 million and \$3 million on the fall campaign. Most of the money raised by Right to Life forces came from mail solicitations within Michigan, Listing said.

The largest donor to RLM has been Word Investments of Grand Rapids (\$10,000).

Other 'notable' donors to the pro-abortion campaign include Free Press Editor Joe Stroud (\$100), Ms. magazine publisher Gloria Steinem (\$1000), State Sen. Lana Pollock of Ann Arbor (\$500), and the National Abortion Rights Action League (\$6,000).

# BILLS WOULD RESTORE TITLE X FUNDING FOR ABORTION

Planned Parenthood's top legislative priority for 1988 is enactment of bills, sponsored by Senator Edward Kennedy (D-Mass) and Congressman Henry Waxman (D-GA), which would make radical pro-abortion changes in the major federal

"family planning" program, Title X.
Planned Parenthood receives about \$30 million a year from the \$140 million a year Title X appropriation. Although the program was originally intended to provide only "preventative family planning services," such as contraception, in recent years Title X clinics have treated

abortion as simply another birth control "option."

The Reagan Administration has attempted to restore the original character of Title X through new regulations which will prohibit Title X funded clinics from counseling or referring for abortion. (These regulations will be tied up in Federal Courts for years.)

An immediate grass roots response is required in order to prevent

rapid movement of these bills through Congress.

Please write today to your two U.S. Senators. Urge them to oppose passage of the Kennedy Bill (S. 1366) unless prolife amendments offered

by Senator Gordon Humphrey (R-NH) are adopted.

Letters should also be sent to House members referring to Waxman's Bill (HR 3769). Urge support for prolife amendments offered by Congressman Chris Smith (R-NJ) and others.

# THOUGHTS FROM A PROLIFE FEMINIST TEEN Nicole Smith

Unlike most of the population I have been fortunate enough to grow up with open and honest information about abortion. As a child I always went to the Michigan State Fair with my parents while they spoke at great length at the Right to Life booth. For the past several years I have followed in their footsteps and made solo trips to the booth.

This summer, I experienced something there which not only baffled me but completely horrified me. Two young girls came skipping to the great child attraction, the fetal models. Children, naturally curious about the creation of life, always come to see this display. These girls, however, were suddenly pulled away from the sight. Their father, a reasonable looking man, was attempting to, as he put it, "shield them from preconceived ideas or notions." When I told him these were anatomically correct models of unborn babies in progressive stages of development and were completely without bias save that of the scientific community, he said that his daughters have to grow up to make a "free and unclouded choice." He then led them quickly away.


It seems so obvious to me, a science student taking Advanced Placement Biology and Physics, that it is impossible to make a knowledgeable or intelligent choice without knowing the facts. The man's hypocrisy angered me, for here we are in the Twentieth Century, priding ourselves on our advanced technology while we are still involved in primitive power struggles. That man's power over his daughters! He denied them information about facts directly pertaining to their bodies and to their lives in the same way society lies to the female population by telling them that abortion is nothing more than a procedure.

If the girls' father truly wanted them to grow up to be liberated feminists he would see that he must teach them the true meaning of feminism — absolute respect for the female body and its functions. He would not be trying to condition them to become more like males. By taking away the positive knowledge of what lovemaking creates, he teaches his daughters that their bodies are truly only for sex. Thus, in this day, women's bodies are still ogled, abused and treated with the ultimate injustice, abortion, by men who will never personally experience it or understand. And to add to the injury, women's fathers are perpetuating their own torture.

Many people live their lives in accordance with what is popular and what is not — fad diets, fad clothes, fad hairstyles, even fad cars. But there is no excuse for fad morals. Right now it is considered "liberal" to protest U.S. intervention in Central America, to ban any companies still involved in South Africa, to oppose nuclear weapons and in general to protect and defend human rights. I have demonstrated against all of those injustices. I am no more right—wing or conservative than any socialist in West Germany, but I refuse to ignore what is right and what is wrong in order to adhere to what society tells me is "liberal." I will always be the ultimate humanitarian and defend every person's rights and that includes those of the unborn.

#### JUST A MINUTE!

The following response to a Channel 4 news editorial was aired on February 15-16. The speaker was Detroit Chapter Co-chairperson Carol Smith.

Michigan is shamefully one of the few states that are still in the abortion business. Even though our state lawmakers have year after year voted to end Medicaid abortions, vetoes by the governors have allowed tax-paid abortions to continue.

Thankfully, Right to Life has successfully collected the signatures necessary to end this state-funded violence which victimizes poor women and their unborn children.

Medicaid abortions have been found to be discriminatory. Women of color are being convinced at twice the rate of white women that their babies have no value.

The Center for Disease Control in Atlanta reports no increase in illegal abortions and no increase in abortion complications as a result of the cutting off of Medicaid abortions. It has been the experience in other states that ending of tax-funded abortions substantially decreased the pregnancy rate and women made the choice not to become pregnant. The monies now spent on abortions will be available to be used on much needed services to support positive life-sustaining programs for the poor.

Congratulations, citizens of Michigan. You have spoken and we are about to get out of the business of using our tax monies to fund the ultimate child abuse.

# RACHEL WEEPING: SEQUELAE

In greatest part, this book is both an inquiry into abortion and an examination of a campaign of persuasion on its behalf, a campaign that would have us believe abortion is a necessary and therefore appropriate remedy for certain urgent problems, personal and social. The more I studied that campaign, its premises and arguments and backwash, the more I saw it as a work of dishonesty and death. Just as wife-killing would surely curb the incidence of wife-battering in America, abortion would surely curb some almost unbearable human miseries. Yet somehow each remedy,

though it works, is wrong.

Nowhere in these many pages do I set forth an argument against abortion. Before embarking on this study it would not have occurred to me as necessary: why would one need to argue that mothers and fathers and healers should not destroy their unborn young? At the end of this study I doubt that an argument against abortion is decisive, for one sets one's direction in this great matter more by the will than by the mind. In this life we acknowledge and respect those whom we are willing to accommodate. Our basic attitude towards abortion matches our readiness either to address ourselves to others' needs or to eliminate others when their needs burden us too heavily. I sense an obligation to make some simple exposition of my own understanding about abortion, but it will be more an appeal than an argument. Those who do not wish to rearrange their lives to accommodate a child will not readily be brought to see their unborn as endued with rights or as an envoy of joy--at least not by any argument. Those who know that they have nothing more satisfying to do with their lives than to give others life and its hospitality hardly need to have it explained to them that the stranger appearing unbidden at life's entryway must, before all, be bidden welcome.

I hold that the life of every fellow human must be respected, preserved, and even protected. We must defer to others' lives, not simply to gain and repay a like protection from others, nor just to avoid the penalities of the law, nor merely because every human being has a right to his or her life, a right which deserves priority over every other human right, need, or desire. We must defer for still another reason: if we deal unjust injury or violent death to others, we shall bring upon ourselves a death of the spirit—a violent death. Those who

kill, die. And they die when they slay, not later.

I hold that, so far as we best can tell, a human person's life begins at conception. Neither birth nor any transition leading up to it serves as a true beginning, unless we talk biological nonsense. Of course an unborn child does not speak or work or give her or his love to others (nor does a newborn child; nor, for that matter, some people long since born). But it is terribly important that we give the basic protection of life-loyalty to all fellow humans, not only to those who suit us as valuable contributors to society. My position is that no one should have the right or power to decide what qualities or what usefulness others must have to avoid being killed. It is enough to be any human being, no matter how burdensome or troublesome, to merit the right to life.

Abortion, then—the willful and violent killing of an unborn human being—is homicide. By this neutral term I mean simply the killing of a human. We talk of accidental and deliberate and justifiable homicides. Is there such a thing as a justifiable abortion? Here I would argue that if we claim any honesty we must hew to the same principles in evaluating abortion as govern our judgments on any other

form of homicide.

Some maintain that all deliberate killing is wrong. Better, they argue, to accept violence at the hands of others than to take up weapons and end ourselves as death-dealers. Others, likewise committed to life, would say that homicide could be justified under certain conditions, e.g., to protect oneself or some innocent third party from mortal, undeserved attack. On the latter view it might be justifiable to destroy a child were that clearly the only way to save his or her mother's life. But there is no consistent, responsible moral way, from either point of view, to justify the killing of innocent offspring to relieve his or her elders of any inconvenience, no matter how severe the distress.

It is no less savage to abort a deformed child than to exterminate a retarded adult. It is no more justifiable to abort a child in order to conceal adultery than to murder a witness about to give evidence in a trial. One cannot fairly allow a child to be destroyed because he or she was conceived by rape or incest, without

also allowing the elimination of illegitimate children.

My argument is straightforward. Abortion is homicide: the destruction of a child. Save for the rare, rare instance when it is a mortal threat to a mother's life to carry her child to birth, there is no abortion that is not the unjust taking of another's life because it is a burden to one's own.

Someone has reckoned that a high percentage of the murders in this country find close family or business associates as victims. We have in us this strange and desperate ability, this selfish madness, to blind our mind's eye towards those nearest us, to see them as insignificant, as nothing really human. We depersonalize

our victims before killing them. So with abortion.

In opposing it I am in <u>no way</u> insensitive to the plight of mothers who are frightened thirteen-year-olds, or are supporting six children on welfare, or are having to drop out of college because of one night's foolishness. I simply say that these are not misfortunes that justify anyone in raising his or her hand to kill. They are not trivial miseries. But to allege them as cause for abortion reminds me too much of the excuses for the massacre at My Lai, and for the bondage of the slave

trade, and for the industrial poisoning at Minamata.

I do not wish to donate on Tuesday to the March of Dimes for medical research on the health of the unborn, and on Thursday to Planned Parenthood to keep crippled children from ever surviving till birth. I want no part of the insanity that sends police into the privacy of homes to stop parents from battering and scalding their four-month-old babies to death, and then uses the same force of law to guarantee the "privacy" of parents to dismember their babies four months before birth. I have no stomach for a society which sees that in many of its homes children are unwanted, and would rather exterminate the children than heal the parents. And though I try to be patient, I do become exasperated when told that since I am a Catholic I have somehow lost my civil right to make public and legal appeal for the lives of the young marked down for death, or that I am imposing my private religious notions on the majority of my fellow citizens, when it is clear to anyone willing to inquire that it is the minority of citizens that presently uses the law to kill.

Women have a right to reproductive freedom, I hear it argued, and I agree: all women, even little girls yet unborn who have the right to be free to grow to the age when they in their turn can make love and have babies. Women should have control over their own bodies, it is said, and I agree; but not life-and-death control over the bodies of their children (and in the case of male children, who ever heard of a male part of a female body?) Make abortions illegal, we hear it said, and they will still go on, but in the back streets, and I agree. Yet rape goes on despite our laws; should it no longer be a crime? And if the day came when the nation was no longer willing to go on record that rape was criminal, would there not be more of it? Can anyone who knows that we record 1,500,000 abortions a year in America imagine that

most of these would have occurred without the legal protections of 1973? Drive abortion underground, it is said, and young women will die by the septic coathanger. Yes, just as the young women of the Weather Underground who blew themselves up making bombs. I mourn them all, but I mourn more their innocent victims—and differently. Make abortion a criminal act, we hear it said, and only the rich will be able to afford it. Yes, but then the rich have always been better able to afford their vices. I would as soon buy abortions for the poor as buy them heroin. Abortions will go on! Why not at least see that they be done cleanly and safely? Yes, say I, and so shall hatred and murder go on, but I shall not use the tax moneys to give sniper-scopes to the Klan or dumdum bullets to the Mafia.

But back to the point, the chief point, the much-avoided point, the only point

at issue: to abort is to destroy one's son or daughter.
