

Never call them "pro-choice"

Those involved in the struggle for the lives of the unborn have long known the power of a catchy slogan. With clever use of rhetoric and ridicule, pro-abortionists have successfully shifted the focus of the abortion debate. Never is the unborn child mentioned. Even the word 'abortion' is used infrequently. No, today the issue is "who decides?" Sadly, this catch phrase may even give many prolifers pause. Don't we all cherish our personal freedoms? Don't we all fear the "Big Brother" style of government?

1984 aside, abortion is one 'personal freedom' we can never sanction no matter how oppressive the government, because it snuffs out the life of another human being. This little person will never be able to exercise his own personal freedoms. Just as you may not decide to take the life of your two-year-old child, so you should not be able to choose to take the life of your 2-month-old child, still inside. Prolifers must be bold and forceful in their denunciation of this rallying cry of the anti-life movement. The following quotes from both sides of the life issue further expose the "who decides, pro-choice" myth for what it is.

"The shrewd PR operation that changed proabortion into "pro-choice" has belched forth once again with "Who decides?" which is just as good as "Where's the beef?" and shorter. This is a masterful (though completely dishones¹) campaign that obliterates the moral issue and turns it into a fable about old males from church and state trying to enter a woman's bedroom. It is one of the great propaganda triumphs of our age. It is very hard to outline a moral argument when someone is deeply satisfied with a two-word bumper sticker."

"Remember that their smokescreen is intended not only to obscure the crux of the debate itself - the issue of 'who decides' - but also to misrepresent the boundaries of public opinion....They will promote the idea that those who are prochoice are advocating the use of 'abortion as birth control'. There's no mystery as to why this is their first priority - for it makes abortion the

issue instead of 'who decides,' and attempts to undo NARAL's success by redefining the issue in *their* terms."

It doesn't take a very astute observer to see that the reason for their recent success has been their almost total triumph in framing the question in the public arena in terms of the right of a woman to choose."



Become a precinct delegate

Petitions must be submitted by May 8

Some of you are probably familiar with the role precinct delegates play in helping the Republican and Democratic parties take a stand against abortion and euthanasia. If you are not, please read on and discover an EASY way you can make a difference.

What's a precinct delegate? All cities are divided into precincts - your precinct number is on your voting card (or check with city hall). Each precinct elects one or more Republicans and Democrats to represent their precinct at district meetings in their area twice a year. Abortion and euthanasia platforms as well as election of prolife party leadership are some decisions made by precinct delegates. A precinct delegate can even represent his party at the national party conventions in election years. Since 1980, the Republican platform has opposed abortion thanks to people like you and me acting as precinct delegates.

It doesn't take money. It doesn't take much time. Just write or call your Right to Life- Lifespan office to get a precinct delegate petition. (All Lifespan offices have answering machines for evening calls.) Then get at least 3 registered voters in your precinct to sign your petition (family members can also sign. It's recommended you get a few more signatures in case any of the 3 signers isn't registered at his correct address, if names have changed from marriage, or he or she fails to write his correct legal name, etc.). Next, send your petition to the county election clerk - to be received by May 8. Your name will then appear on your precinct's August primary election ballot.

Only voters who identify themselves as belonging to your party, whether Republican or Democrat, can vote for you. Sometimes other people will run as precinct delegate too, but often no one will be opposing you. You must be re-elected every 2 years.

Update

"Freedom of Choice" Act

(HR 3700, S1912)

This bill would prohibit any restrictions on abortion prior to fetal viability (around 23 weeks). After viability, the bill would grant women an abortion for "health" reasons (the Supreme Court has ruled that "health" includes any factor pertinent to a woman's "well being"). Thus, in practical terms, the bill would bar states from placing restrictions on abortion at any point during pregnancy.

The initial hearing on this bill was held in March, with Shari Richard from our Educational Center for Life testifying. The bill is not scheduled for action until the summer. (From NRLC legislative Company)

(S110, HR 930)

Although Lifespan takes no position on contraception, we do oppose federal funding of organizations which promote abortion as a family planning option. Planned Parenthood affiliates currently receive about \$30 million a year under Title X of the Public Health Service Act. These bills would extend the Title X program for 4 more years at increased funding levels. \$110 has not yet been scheduled for Senate floor action (NRLC legislative office).

Urge your Congressional representative to oppose these bills unless they are amended to protect the prolife Title X regulations, and to prohibit the use of Title X funds for school-based clinics and for research on abortifacients (such as RU 486).

"Citizens for Parents' Rights"

The campaign to restore to parents and teenagers the appropriate protections and rights they deserve will take the form of an initiative drive similar to the successful effort in 1987 that ultimately stopped tax-funded abortions in Michigan. Such a drive requires that a total of 191,726 registered voters sign the petition bringing the Parental Rights Restoration Act back to the state legislature. The signatures must be collected within 180 days.

After the signatures are validated by the State Elections Bureau, the measure goes to the Michigan legislature for final approval. Both the House and Senate must then vote on the bill within 40 days. If passed by a simple majority vote, the measure automatically becomes law. If rejected, it will be voted on by the general public. The Governor is afforded no chance for a veto.

Dr. Jack Willke, president of the National Right to Life Committee, commented on the need for this legislation during his recent visit to Detroit. "I've counseled... thousands of [pregnant teenagers] over the years, and in my total 40 years of experience I have never had...a girl who went to her parents for this kind of counsel who has ever repeated another pregnancy out of wedlock. Never. The girls who have snuck off in private and gotten abortions and not told their parents, repeat pregnancies are almost the rule. So it is a devastating thing for a teenager to not tell their parents... Blanchard is tragically, devastatingly wrong in [vetoing this bill], and he must be overridden."

"Americans with Disabilities" Act


(S933, HR 2273)

This bill would prohibit discrimination in employment against persons with disabilities, and require thet new public and private facilities be accessible. The bill was approved by the House Committee on Energy and Commerce, headed by Rep. John Dingell (D-Dearborn), and awaits approval by the public works and judiciary committees before being considered by the full House.

Urge your Representative to SUPPORT this bill as it stands.

Abortion clinic owner's remarks

15 members from the Wayne West Chapter carpooled to Lansing, March 28, to hear Carol Everett, a former abortion clinic owner tell the inside story on one of the biggest money-making businesses in the US today. She explained that abortion is a skillfully marketed product sold to a woman at a crisis time in her life. 5% of abortions are done on un-pregnant women. Her clinic gave low dosage birth control pills to patients after their abortions and they had a 42.9% rate of repeat abortions. She is for informed consent laws because women are lied to in order to sell abortions.

In Minnesota, where there are

parental consent laws, teen abortions have dropped 31% and teen pregnancy has dropped 27%. Her youngest client was 11 years old, and she stressed the need for parental consent laws in Michigan.

"Except for you, she wouldn't be here"

Dr. Jack Willke talks about the prolife struggle

Dr. Jack Willke is the president of the National Right to Life Committee (NRLC), which has 50 state and almost 3000 local chapters. He was the featured speaker at Right to Life - Lifespan's annual dinner dance last month. This interview was conducted Saturday afternoon before the dance.

Do you feel that Roe v.
Wade will be overturned?

Roe v Wade will be overturned in one of two ways. It either will simply be officially overruled, which is the way we'd prefer, but the court has another way of doing it. They call it sub-silencio . . . and what they do with that is to slowly gut the thing until officially it no longer exists, in de facto, even though the words are still out there.

Now it is amazing how much it has ruled in that direction already. . . . Let's think back a year ago before Webster. Could we have in our wildest imagination thought that a legislative body would pass a law forbidding all abortions except those few percentage [as was recently done in Idaho]? Of course we wouldn't have dreamt of doing it because it would have been a total exercise in futility. Everyone knew it would have been just struck

down savagely. Now, even though the court in Webster didn't go very far, it didn't go very far at all, it would seem as if the whole door has opened.

Is there hope for a human life amendment?

Not in the near future.
... What's gonna have to happen is, I think, a slow re-education of our nation. Let's take Michigan, for instance. Parental consent for minors. Gee, that's not a huge percentage of the abortion problem. It's a piece of it. Look at the blood, sweat, money and tears that are going to go in to putting that into law in Michigan.

Okay, let's say you're successful. Now let's go for one or two or three years and collect state statistics and experience parental consent. And the common knowledge then will be. "Hey, that was a good thing. We aren't having all kinds of teenage chaos because of this. Yes, the incest thing has a way around it. she can go to the judge. Yes, it was a good thing to report that incest thing, because we didn't want it to happen again." And several years down the road, this won't be an arguable position in MI anymore. It will have shown itself to have been wisdom.

All right, let's say the next year Michigan then goes for informed consent. Maybe spousal notification. And let's say maybe the next year Michigan goes for tight clinic regulations. . . . A few more years, now everybody recognizes that this was a good thing. What you're gonna do is narrow it, narrow it,

The whole mood of the country's going to have to change a bit. And we're going to be pushing that. Then, then maybe, we can go the rest of the way. But I'm afraid that's the psychology of it at this point, and I certainly wasn't saying that 10 years ago. But 10 years ago we weren't where we are now.

How can we more effectively educate the public about the life issue?

Four words: aggressively back to basics.
Back to basics. . . . We must go back and teach fetal development, fetal development. We do it with models, we do it with color photos, we do it with ultrasound photos. And that's where it's at.

We have to go back, aggressively find places to talk to go out and talk to people. We

must have speakers bureaus that are scrounging to speak anywhere. You get me 6 people together and we'll come. Any kind of a church group, any kind of a social party or community group, any classroom, anywhere, anytime. Have pictures, will come. Here's what you look like at 18, at 16, at 14 weeks. And when you were 12 weeks along, here is what function there was, and so forth. Now we get down to 10, now we're down to 6, listen to the heartbeat. Here is a 3-D model. . . . There was a heartbeat starting when lyour mother] was 4 days late for her first period. You planted at one day of life. You began at day one.

This is the message that everybody has to know. And that should be taught in grade school, it should be taught in Sunday school, it should be taught in secondary school. It simply has to be out there. And when everybody knows that, then we have 80% of the people in this country on our side.

How important is the Rally for Life in April?

Of overwhelming importance. Henry Hyde came to me a year ago, and it was right after the first NOW march. They only had 150 thou, but they were given credit for 300. That's what's out there - 300. He said, "We have to beat them and beat 'em big." said,"Some of my colleagues are very worried." Pretty obvious; later in the year it showed that. We were losing votes. He said, "We need a massive march, Jack. And yours is the only group that's big enough to coordinate that."

Now I think it's evident to anyone and everyone that this is the one of a kind, the BIG one. It will be looked upon as THE test of strength and it will be used to



Dr. Jack Willke viewing "Ultrasound: A Window to the Womb" with producer Shari Richard


match numbers with the others. We would like to see a busload of people from every prolife school and every prolife church east of the Mississippi into Washington that day.

Even those who come...late and they can't even get to the mall.... Let me tell them ahead of time, "You have done your part." If you, unfortunately, were one of those in that traffic jam 10 blocks away that absolutely couldn't move and you couldn't get any farther, and that's where you sat, offer it up. The fact that you were part of gridlocking downtown Washington will not be lost on the Congress. And if you were bumper to bumper on the interstates leaving and thought you'd be out at 7:00 and didn't get out 'til 10:30 or 11 because the entire beltway was bumper to bumper and parked shut, good! That's why you came. And if because of you and your tie-up the Congressmen couldn't get to where they wanted to go, and a lot of receptions and so forth that night had to be cancelled because nobody could move, good. That's why vou came.

This will be an historic event. People who go are going to be able to tell their kids they went. This will be, I'm convinced now, the largest gathering of people to ever come to Washington DC in its history. This will be bigger than Martin Luther King's "I Have a Dream." This will be more than the pope brought to the mall. And this will be more than the feminist, lesbian coalition brought to the mall. This will be BIG.

What motivates you to stick with it?

Well . . . I can't say that the things that buck us up would necessarily be available to a person who's a little more down in the trenches. We're constantly running into people who bring their child up and introduce this little child or this teenager and with tears in their eyes say, "Except for you. she wouldn't be here." Stories like, "For 25 cents she bought a handbook on abortion [at a used bookstore], mostly because she was pregnant, thinking about getting an abortion and she saw the word. She picked the book up, read it, and decided not to abort. I mean things like that we keep getting feedback on makes us want to continue.

Debunking the myths . . .

Is the National Right to Life Committee compromising on abortions for rape and incest?

Last month, the Idaho state legislature passed a bill which would have restricted abortion as a means of birth control. If it had not been vetoed by the governor, this bill would have eliminated 95% of all abortions currently performed in Idaho. A woman could still obtain an abortion in cases where she was pregnant as a result of rape, if the rape were reported to authorities within seven days; incest, if reported to authorities before the abortion; to save the life of the mother; or for severe fetal deformity.

The National Right to Life Committee played an instrumental role in getting this legislation passed. At the invitation of Idaho Right to Life, three people from the national office went to Idaho to help draft and pass the bill. The bill was specifically designed to provide the direct challenge to Roe v. Wade that the U.S. Supreme Court seemed to invite in their Webster decision last July.

Several prolife groups were opposed to this bill, going so far as to testify against it at state committee hearings. They felt that the NRLC knuckled under by allowing the exclusions for abortion;

that they should have drafted a bill restricting all abortions. The following is NRLC President Dr. Jack Willke's response.

We'll stop
the killing
as much as we can
when we can
and go back later
and stop some more

"Our overall strategy [is] to incrementally restrict abortion and expand fetal rights as the possibility exists. If we have a state that can only stop abortions for sex selections, we'll help them do that. If we have a state that can only pass a parental consent law, or maybe can only pass an informed consent law, and nothing more, we'll help them do that. If we have a state that can go, probably as far as any state can go right now,

which would be to restrict and stop all abortions used as a method of birth control, we'll help them. When the day comes that we can go further than that, we'll go further yet. In other words, we are the pragmatists. We will stop the killing as much as we can when we can, and we'll go back later and stop some more.

"Now there is some feeling out there by certain individuals and groups, that would say that that's not what you should do. That what you should do is hold fast and don't go part way, go for it all. Stop everything. We feel that that is a guaranteed recipe for stopping nothing. And we couldn't live with our consciences if we knew that we could stop 10% or 50% or 90% of the killing and we didn't do it. That doesn't mean that we are accepting of or giving permission in any way for the ones we can't stop. It merely means we're going as far as we can go. And every state is going to be different."
