

### Life Chain comes to Metro Detroit!

"In the largest display of unity in Michigan history, thousands of people are lining miles of sidewalk along Woodward Avenue holding up signs which proclaim, "Abortion Kills Children." There is a joyful, buoyant spirit among the participants as thousands place themselves on record as being prolife. This is something new. Organizers call it a Life Chain and you can tell from the feeling in the air that something good will come from this..."


At least this is how we hope the news broadcasts will sound on the afternoon of October 21, between 2:00 - 3:30 pm, as Right to Life - Lifespan of Metro Detroit and the Christian Activist Network co-sponsor Metro Detroit's first Life Chain!

A Life Chain is hundreds and thousands of individuals standing 6 to 8 feet apart from each other along a pre-determined route for an hour-and-a-half on a Sunday afternoon after. The task: to hold up signs bearing the solitary message "Abortion Kills Children." It is that simple. It is also quite effective at generating enthusiastic participation which fosters ongoing prolife activism.

Consider the phenomenal numbers who have turned out for the initial Life Chains, all held in California:

- 28,000 came out March 18 for the second San Diego Life Chain, which stretched 15 miles. 20,000 people had turned out one month earlier for the first one.
- 17,000 people stretched across several Orange County, Cal. communities in a Jan. 21 Life Chain. Fresno reported 10,000 in their Life Chain on the same day.
- Half the churches in Yuba and Sutter counties in California sent 2500 participants to the first Life Chain, held in Yuba City. The Life Chain and comprehensive distribution of prolife literature helped reduce Yuba-Sutter abortions by 60%!

The first Metro Detroit Life Chain will take place along Woodward Avenue, stretching from McNichols (6 Mile Road) in Detroit to 13 Mile Road in Royal Oak. Groups and

individuals will be assigned specific sections of Woodward to man on the day of the Chain.

Some things Life Chain is *not*: It is not illegal. No laws are broken. Life Chain participants do not go to jail. It is not a political gathering. And it does not burn up a lot of time or energy.

#### Giving babies a chance

"I think this is a great opportunity for all prolife organizations, churches and people to come together to make a visual statement of solidarity that we are opposed to the killing of unborn children," said Ann Thomas, president of Right to Life - Lifespan of Metro Detroit, a co-sponsor of the event. "And we are especially hopeful that the Life Chain will actually save babies' lives!"

Indeed. A man told members of a counseling group at his church how he had planned to have his illegitimate child aborted. But then he drove past the Fresno Life Chain on

Sunday afternoon, January 21. After that, he just couldn't get out of his mind the image of all those thousands and thousands of people holding signs saying, "Abortion Kills Children." And he did not go through with his plan to have his child killed.

A woman drove by a Life Chain in California, rolled down her car window and told Life Chainers she was thankful they were out there. Six weeks previous she had been about to have an abortion when she drove by the San Diego chain. But seeing the signs had an impact and she changed her mind. She said, "It just hit me that I was going to kill my baby," and then she drove off.

Jan Opris of the Christian Activist Network, co-sponsors of the event, said, "Some think since abortion is legal, it's right. We believe the Life Chain's message is a call to repentance for killing children in Metro Detroit."

An estimated 25,000 babies are killed annually by Metro Detroit abortionists. A powerful Life Chain on October 21st offers strong encouragement and hope for reducing that number. With your firm support, we are confident of reaching our goal of 10,000 Life defenders.

Please plan to stand with us on Sunday afternoon, October 21st. Won't you invest one hour to save a lifetime?

### AFL-CIO remains neutral on abortion

With only three dissents, the AFL-CIO's 35-member Executive Council overwhelmingly voted to remain neutral on the abortion issue.

"Our position remains as it has been for time immemorial, which is to say that we take no position on the issue of reproduction choices," AFL-CIO president Lane Kirkland told reporters at an August 1 press conference. "The overwhelming view of the Council was that this was a matter of deep personal conviction, conscience and religion, and one's individual moral views are not likely to be influenced by any stand that the trade union movement at large would take."

This was a tremendous win for the prolife cause. But keeping the AFL-CIO and other unions neutral will be an ongoing struggle. "We must be vigilant - particularly at the local level and within international unions - to ensure that pro-abortionists are unable to get pro-abortion resolutions adopted," said Dr. Jack Willke, president of the National Right to Life Committee. "I encourage all prolifers who are members of union households to write NRL News to be placed on a special action list so that they can be kept up to date on the latest ploys of pro-abortionists to win tomorrow what they lost today."

## American Bar Association rescinds pro-abortion resolution

Less than six months after adopting a pro-abortion resolution, the American Bar Association has reversed itself.

By a vote of 200-188, the ABA's House of Delegates passed a new resolution which stated that abortion is so "extremely divisive" that the ABA should take no position on it.

Attorney General Dick Thornburgh had advised the ABA that its pro-abortion platform, adopted in February, jeopardized the Association's privilege of screening federal judges. This, along with the fact that nearly all of the ABA's leadership opposed the pro-abortion resolution and supported neutrality, led to the eventual turn-around.

### **About Planned Parenthood**

Part 3 of an ongoing series on the Planned Parenthood Federation of America. Past articles discussed the life of Margaret Sanger, PPFA founder.

"What's so bad about Planned Parenthood? Don't they just provide birth control information to those who need it?"

This question, from an active Lifespan volunteer, echoes the sentiments of many. Isn't Planned Parenthood the group which advocates low-cost, counseling and health care services for women? Don't they provide social services for the needy, and sex education programs? What's all the fuss about that?

Indeed, Planned Parenthood's participation in the multi-million dollar abortion business, in coercive population control, in harmful curriculum development and more, seems to be a well-kept secret to all but the most committed prolifers. When a Lifespan member phoned a Meijer's official this spring to protest Meijer's financial gift to a local Planned Parenthood group, the official was surprised anyone would object to this. "Oh no, Planned Parenthood does not perform abortions. It is purely an educational organization." (Meijer has since discontinued giving financially to Planned Parenthood.)

An even bigger secret is that Planned Parenthood's activities are funded by our tax dollars. In 1986 and 1987, Planned Parenthood publicly reported receiving \$106 million and \$111 million respectively of government support. Yet during a recent radio talk show on Detroit's WMUZ, a woman claiming to have worked for years at a Planned Parenthood clinic called the open line. "Planned Parenthood does not receive a dime of tax money," she claimed. "They are funded entirely by the fees charged for services rendered."

What and who is Planned Parenthood exactly? These excerpts from George

Grant's book, Grand Illusions: The Legacy of Planned Parenthood, provide the answer.

"Planned Parenthood is the world's oldest, largest, and best-organized provider of abortion and birth control services. From its humble beginnings around the turn of the century... it has expanded dramatically into a multibillion dollar international conglomerate with programs and activities in one hundred twenty nations on every continent. In the United States alone, it employs more than twenty thousand staff personnel and volunteers in over eight hundred clinics, nearly two hundred affiliates, and more than fifty chapters in every major metropolitan area, coast to coast.

"Utilizing this considerable wealth, manpower, and influence, Planned Parenthood has muscled its way into virtually every facet of modern life. It now plays a strategic role in the health and social services community. It is actively involved in both advertising and programming in the mass media. It exerts a major influence on public and private education. It carries considerable political clout through lobbying, legislation, advocacy, campaigning, and litigation. It is involved in publishing, research, medical technology, judicial activism, public relations, foreign affairs, psychological counseling, sociological planning, demographic investigation, curriculum development, pharmacological distribution, theological reorientation, and public legal service provision."

Because of this incredible intrusion into family, church, state and culture, prolifers must continue to learn the truth about Planned Parenthood. #### Immediate Action Needed

Dayton-Hudson, a longtime corporate supporter of Planned Parenthood, recently announced its decision to end funding for the controversial organization. Since this announcement, however, they have received so many boycott threats from abortion supporters that they are reconsidering their decision.

They are taking a poll about the funding decision. Prolife response is needed immediately. In an internal memo to employees, Dayton-Hudson stated they are renegotiating with Planned Parenthood to reach "mutually agreed upon solutions." Prolifers should ask Dayton-Hudson to also meet with prolifers to discuss the issue.





I hope you all had a good summersuch as it was with so many cool and rainy days. I always hate to see the summer end and the kids go back to school. Why can't the winter pass by as quickly as the summer always does? My two youngest children went back to school yesterday. While this is of no considerable interest to you, one important fact should be. One out of every three unborn children is killed by abortion.

Which means that for every two children who went back to school there is one child missing. One child who had NO CHOICE. ## NRLC urges campaign activity over lobbying until November

The U.S. Congress as well as the Michigan state legislature will be in session for only about 4 weeks until each adjourns in mid-October to allow members to campaign for re-election. The 1990 elections are now less than two months away. On November 6, voters across the nation will choose 35 U.S. senators, 435 U.S. House members, 36 governors, and thousands of state legislators. This election will have an unprecedented impact on the future prospects for prolife policies at both the federal and state levels.

Pro-abortion groups plan to turn up the political heat in Washington during the next few weeks, in an attempt to force as many votes on abortion as possible. If any pro-abortion amendments do pass, however, Administration officials have indicated that President Bush is prepared to again use his veto power to protect unborn children. (Last year, the President vetoed four bills which would have weakened existing prolife policies.)

For this reason, the National Right to Life Committee has issued the following recommendation to prolifers for the most effective use of their time and energy at this time.

"The first priority for prolife activists during the next two months is to assist in the election of prolife candidates, and the defeat of pro-abortion candidates, at the state and federal level. For the time being, election-related activities must take priority over letter writing and grassroots lobbying of incumbent members of Congress. However, we do encourage grassroots lobbying where this will not drain energy from election-related activities. Letters should urge members of Congress to support President Bush in opposing federal funding of abortion, federal funding of pro-abortion organizations such as the UNFPA, and federal funding of fetal-tissue transplantation."

## Update

#### **National News**

#### Freedom of Choice Act (HR 3700, S1912)

This bill would essentially write the principles of the Roe v. Wade decision into law, making abortion legal at any time throughout pregnancy. This bill would bar states from placing restrictions on abortion at any point during pregnancy. Dozens of state legislators have asked Congress to support the "Freedom of Choice Act" so that they will not have to deal with abortion legislation. It is not expected to come up for a vote during this session.

Co-sponsors of the bill from the metro-Detroit area are John Conyers, Jr. (D-Detroit, District 1), George Crockett, Jr. (D-Detroit, District 13), Sander Levin (D-Southfield, District 17).

ACTION: Write or call your Congressional representatives in Washington urging them to OPPOSE this bill.

#### Family Planning Act (S110, HR 930)

Although Lifespan takes no position on contraception, we do oppose federal funding of organizations which promote abortion as a family planning option. Planned Parenthood affiliates currently receive about \$30 million a year under Title X of the Public Health Service Act. These bills would extend the Title X program for 4 more years at increased funding levels.

ACTION: Urge your Congressional representative in Washington to oppose these bills unless they are amended to protect the prolife Title X regulations, and to prohibit the use of Title X funds for school-based clinics and for research on abortifacients (such as RU 486).



#### Michigan News

#### Patient Advocate Bill (HB 4016)

Due to extensive media coverage on the "right-to die" this summer, this bill is expected to see vigorous floor action during the four weeks the state legislature is in session this fall. A version of the bill has already passed the state house.

ACTION: Urge your state senator to add the prolife protections for food and fluids for incompetent patients, as well as protection of inborn children of incompetent patients. Medication for existing situations (such as insulin for diabetics) should not be withheld from incompetent patients.

### Citizens for Parents' Rights GOOD NEWS!

On September 8, 1990, the state Board of Canvassers completed verification of the thousands of signatures on the petitions which were distributed throughout the first half of 1990. The initiative, which requires that a minor obtain the consent of one parent before an abortion can be performed on that minor, was sent to the legislature.

Lawmakers had 40 days to act on the bill. But members of both the House and the Senate moved quickly to pass the measure on September 12, 1990. It is expected to go into effect in April of 1991.

ACTION: If appropriate, write or call your state legislators in Lansing, thanking them for acting quickly in support of this bill. Call your local Lifespan office for the roll call of the vote.

#### Who can foretell the future?

A Living Will is, by nature, a very general document. It must be, for it cannot possibly provide specific instructions about an unknown future condition or situation. Consider Ida Wikberg's case. Sixteen years ago, Ida signed a Living Will asking that no "heroic means" be used to save her life. This July, only nine days after she lost consciousness due to a stroke, her family interpreted "heroic means" to include food and asked officials at her nursing home to stop feeding her. She died 10 days later.

Would Ida have considered 9 days a reasonable amount of time to allow for recovery from a stroke? Did she consider the delivery of food and water to be a "heroic means" of caring for her? We'll never know.

#### Change is inevitable

Secondly, a Living Will cannot reflect an individual's changing situation and attitudes. Perhaps now, to a completely healthy individual, the thought of being dependent on a respirator is unbearable. But were the individual ever to be placed in the situation in which he were dependent on a respirator for life, he might feel very differently about the matter. "Resilience is one of the great qualities of the human being. Life often requires changes in attitudes and thinking," reminded the National Legal Center for the Medically Dependent and Disabled, Inc. A Living Will would not allow an individual to rethink his former position, since the once-dreaded care would have been withheld.

Carrie Coons is a case in point here. Mrs. Coons was 86, and had been in an "irreversible coma" for 4-1/2 months. Her sister petitioned the court to have Carrie's feeding tube removed, saying Carrie had indicated during her lifetime that she would not have wanted to be kept alive in this way. The court accepted her testimony as proof of Mrs. Coons' wishes, and ruled that the tube could be removed. Several days after the judge's ruling, however, Mrs. Coons woke up and began speaking and eating. When questioned about removal of the tube, Mrs. Coons responded, "These are difficult decisions." To her lawyer she said she'd

"like to wait." If indeed Mrs. Coons had ever dreaded the thought of being kept alive by machines, once actually in that position, she changed her mind.

Similarly, a recent Detroit Free Press poll found that those least likely to support 'right to die' measures were those already in poor health. Surely they have come to appreciate medical procedures once thought to be intrusive.

#### Hope for the future

Additionally, a Living Will signed today completely disregards the medical alternatives which may be available in the future. As reported in the July 1990 issue of Lifespan News, a man who had been in a coma for 8 years regained consciousness after receiving valium for routine dental work. What if his Living Will had read "No heroic measures?" He would have starved to death only 7-10 days after his initial injury, long before his body had had a chance to recover. Even if his Living Will had had the foresight to provide for 6 months or even a year of extraordinary care before terminating it, it still wouldn't have been enough time for him to recover. Who can say what knowledge about the brain and strategies for its recovery following injury will be discovered in the days ahead? A Living Will exterminates all hope for the future.

#### Compelled to die?

Finally, will the day come when people are compelled to refuse treatment as well as nutrition and hydration, actually forced to call for measures which would lead to the end of their own lives? That day is not so far away. Legislation is pending which would require that states have Living Will legislation as a requirement for Medicaid and Medicare participation. Can a requirement that each individual have a Living Will be far behind? With the rising costs of Medicare and Medicaid lawmakers are struggling to find ways to curb medical expenses. Former Colorado Governor Richard Lamm stated that certain individuals have "a duty to die and get out of the way." How many senior citizens, nursing home residents and incapacitated patients including those with AIDS will receive that very message?

"We have to go stage by stage, with the living will, with the power of attorney, with the withdrawal of this; we have to go stage by stage. Your side would call that the 'slippery slope,'" said Derek Humphry, executive director of the Hemlock Society, whose goal is to legalize euthanasia. Perhaps the current push toward Living Wills is not intended so much to ensure death with dignity, but merely to ensure death. □

#### Debunking the myths

#### Will a living will ensure death with dignity?

Try to picture this scene: an unconscious patient lies motionless in a hospital bed. Clear fluids flow continuously into his body through tubes. The room is quiet save for the rhythmic pulsing of a respirator which breathes for the patient. The days turn into months, the months years. Still, there is no obvious change in the patient's condition, and he lives on, a mere shell of his former self.

It wasn't too difficult to bring that image to mind, was it? In fact, this scenario has become all too familiar. Since the Supreme Court's June ruling on the Nancy Cruzan case, the media has pelted us with these case studies, the only significant difference in each being the identity of the main character. "Here lies Jack," we are told. "The 83-year old comatose woman," begins the next story. "Nancy, a young woman in a coma for 7 years," another continues. Masterful strokes in a carefully painted campaign to influence public opinion, to convince us that we not only have a 'right-to-die,' but an obligation to assist in the deaths of those whose lives are deemed to be not worth living.

William B. Smith, dean at St. Joseph's Seminary in Yonkers, New York, describes the strategy. "As with abortion, the anti-lifers have made their case gradually. Their

first step was to confuse the terminology. They refer to mercy killing as the 'right to die' in the same way killing unborn babies is passed off as a woman's 'right to choose'. Then they make sure the public, through a sympathetic media, is bombarded with hardship cases to establish a disposition to accept mercy killing ... Finally, after this gradual buildup of

support comes the push to solve the hardship cases by legalizing killing, while making opponents of euthanasia look like cold, compassionless people."

It is precisely at this place which we in Michigan find ourselves. State representative David Hollister is pushing hard for 'right to die' legislation which would include allowing removal of an incompetent patient's nutrition and hydration, causing them to starve to death.

"My hope is that now that public opinion has built to this point, legislators will be confronted with the issue..." he recently told the Detroit Free Press.

Indeed, many courts have appealed to the legislatures to provide them with some guidance when faced with these cases. Living Will legislation has been one response. Although Michigan does not yet have such legislation, local 'Right to Die' offices report a run on Living Wills since the Cruzan decision, in which the U.S. Supreme Court would not allow removal of an incompetent patient's feeding tube since there was no convincing evidence that the patient would have wanted this. Many have become convinced that a Living Will is their key to 'death with dignity.'

What exactly is a Living Will? It is a written statement in which you inform doctors and family members what type of medical care you wish to receive should you become terminally ill or permanently unconscious, and unable to make or communicate decisions about your continued care. Sounds straightforward enough. But before joining the rush of humanity on the way to a "Right to Die" office, a few additional points ought to be considered.
