## **VOTE "YES" FOR LIFE**

At last, the Medicaid abortion referendum has been assigned its place on the November ballot. The Board of Electors has designated the referendum PROPOSAL A, so our issue will be the first proposal listed on the ballot.

In order to comply with Michigan election laws governing ballot questions, Lifespan has formed a ballot question committee. It is called THE COMMITTEE OF JUSTICE FOR THE UNBORN. All funds donated in order to "influence an election" must be deposited in this committee account. Therefore, you will notice that the fliers printed this month for the Detroit News ad require checks to be made payable to our committee. All money given so far for the ad has been transferred to the committee account.

Speaking of the ad, we are doing very nicely in collecting names and funds for this tremendous effort, but we will be unable to run a full-page ad unless many more names are sent in. As of the end of August, we have about 1,000 names and about \$7,000 which will pay for a half-page ad. Please make one more huge attempt at securing the needed amount of \$16,000.00 by early October so a full-page ad may be purchased. SEND IN YOUR APPLICATION (see enclosed) TODAY if you haven't already done so.

THE COMMITTEE OF JUSTICE FOR THE UNBORN has also made a VHS video about the Medicaid abortion issue. The video, running about 20 minutes, was originally commissioned for use at our booth at the Michigan State Fair, where it ran for all 11 days. Produced by Sunrise Communications, it refutes the pro-abortion myths concerning Medicaid abortion and includes some very moving testimony by women who underwent the procedure and have lived to regret it.

In addition to the State Fair, we expect to play the video on TV in October. It will also be available for members to show friends and neighbors.

# **BUSH ENDORSED BY NATIONAL RTL**

George Bush and Dan Quayle have received the overwhelming endorsement of the National Right to Life Committee.

At the NRLC Convention in July leaders of the group predicted the abortion issue would prove to be the "achilles heel" for the Democrats' Dukakis/Bentsen ticket. "This is the most pro-abortion presidential ticket in history," declared NRLC President John C. Willke, M.D. "Both Governor Dukakis and Senator Bentsen have demonstrated time and time again a staunch commitment to legal abortion-on-demand, and to federal funding of abortion. These men are bad news for unborn babies."

"Prolife voters can provide the margin of victory in an election," said NRL PAC Director Sandra Faucher. "Millions of prolife Democrats have been abandoned by their party again."

....Bush is prolife. Bush favors overturning the Roe v. Wade abortion-on-demand decision and opposes abortion funding," said Faucher.

### THE DUKAKIS RECORD ON ABORTION

Michael Dukakis is the most pro-abortion candidate to ever run for the U.S. Presidency. His record as a state legislator and Governor of Massachusetts has been clear and consistent, and until recently his remarks have been vehemently pro-abortion.

The following is a summary of the Dukakis record on abortion.

In 1970, three years before the <u>Roe v. Wade</u> decision legalized abortion on demand, Michael Dukakis as a state legislator introduced a bill to legalize abortion on demand in Massachusetts. This was done at the request of one of the nation's most radical pro-abortionists, Bill Baird. The bill stated simply, "Abortion may be performed by any physician who has first obtained the consent of the female upon whom said abortion is to be performed." (Mass. House of Reps. bill number H 3756, 1970.)

In his first term as governor in 1977, Dukakis vetoed a bill that would have cut off state funding of abortions (Sept. 13, 1977). Two months later (on Nov. 10, 1977), he vetoed an amendment to the state's supplemental budget which restricted abortion funding and stated, "If the Supreme Judicial Court says I can veto the antiabortion amendment that is part of this supplemental budget containing the pay raises, I will smile broadly and sign the rest of it with relish. If not, I will veto the entire \$26.7 million budget." (Message to Massachusetts legislature, November 10, 1977).

Likewise, on April 24, 1978, Governor Dukakis vetoed an amendment to another supplemental budget that would have eliminated abortion coverage from state employee health plans. On July 7, 1978, he vetoed the annual budget because it contained abortion-funding restrictions.

Governor Dukakis addressed a Coalition for Choice rally on January 22, 1986, celebrating the legalization of abortion. He stated: "I don't know when life begins. I'm not sure I ever will." (Speech at the Church of the Covenant, Boston, Mass., January 22, 1986.)

A 1988 National Abortion Rights Action League booklet calls Dukakis "a consistent and firm supporter of reproductive rights. He fully supports funding for abortion services."

## HARTFORD ARCHBISHOP LEAVES DEMOCRATIC PARTY

In a related story, Hartford Archbishop John F. Whealon announced Thursday, August 25 that he was "unable in conscience to remain a registered Democrat" because of the Democratic Party's support of legalized and government-financed abortions.

"I believe the Democratic Party is officially in favor of executing unborn babies whose only crime is that they temporarily occupy their mother's womb," Archbishop Whealon wrote in his weekly column in the Roman Catholic paper in Hartford, The Catholic Transcript.

"In my childhood home, God and Jesus Christ were first, the Catholic Church second, and the Democratic Party was third," he wrote asserting that the party and Catholicism had been linked historically by "ethnicity, social class issues and shared morality."

"But that link has been severed," he said. "By its repeated stances in favor of abortion, the Democratic Party has abandoned the Catholic Church."



Fr. John Powell, S.J. is currently a professor of Theology at Loyola University in Chicago. He has taught at Jesuit Seminaries and has also been a guest professor at the Catholic University of America, the University of Notre Dame and the University of San Francisco.

Fr. Powell has developed audio visual publications, video series and radio and television programs. He has published many books including *Abortion: The Silent Holocaust*. He is at present the second best-selling Christian author in the history of the United States, ranking just behind one of his personal heroes, C.S. Lewis.

### HYDE Amendment !

Write to US Congressman Carl Pursell of the 2nd Congressional District (134 N. Main Street, Plymouth, MI 48170) or call his office in Plymouth 455-8830 and remind him that he should support his fellow GOP Congressman Henry Hyde's Amendment which prohibits the US government from funding abortions in all cases except where the life of the mother is in peril. This has been US policy since 1981 and should continue to be our government's policy. Encourage Mr. Pursell to either embrace the GOP Platform or join Senator Riegle as a former GOP member.

Congressman William Ford represents our 15th Congressional District people. He is a staunch supporter of his party's platform and thereby exhibits strong antilife sentiments. He may need much assistance to support the HYDE amendment, so call his Wayne, MI office (722-1411) and also write to him at 3716 Newberry Street, Wayne, MI 48184.

In the 17th Congressional District we have the pro-abortion Congressman Sander Levin. He probably will not support the HYDE Amendment but every PROLIFE voter in the 17th should write to him

(17117 W. Nine Mile, Suite 1120, Southfield, MI 48075) and also call his Southfield office (559-4444). In your phone call (call often) be sure to remind his office that because of his proabortion stance you find supporting him between extremely difficult and IMPOSSIBLE.

# Senate Amendment on Tax Exempt Abortion Clinics

Both Senator Levin and Senator Riegle continue to persist in their contra-life position, however both need to receive letters and phone calls concerning Senator Gordon Humphrey's amendment that will deny exempt status to organization which receives that 1% of its gross profits from abortions. Legitimate hospitals will not be affected since they gain less than 1% of profit abortion. It will affect 30% to 50% of all abortion clinics that are now tax exempt.

Riegle, who is running for reelection, should surely hear from us, but Carl Levin also needs to be prodded toward a PROLIFE position. Both have offices in Detroit at 477 Michigan Avenue, ZIP 48226. Carl Levin's office is 1860 McNamara Building (phone 226-6020) and Donald Riegle's office is 1850 McNamara Building (phone 226-3188). They should get both phone calls and letters insisting that Gordon Humphrey's amendment be supported.

### MORE FEDERAL FUNDING OF ABORTION DEBATED

Your urgent help is needed to prevent the annual Hyde Amendment (which bans federal funding of abortions) from being changed to include abortion payments for rape and incest pregnancy. Pregnancy from rape or incest is extremely rare and even in these cases the value of human life - the child in the womb - should be saved. Please write to your Senators and Congressman and ask their vote for the Hyde Amendment

(House Bill 4783) if it allows federal funds for abortion "to save the life of the mother" as the only exception.

Also ask your Senators and Congressman to vote for the Humphrey Amendment which will end allowing many (30% to 50%) abortion clinics (abortuaries) to be tax free.

### CHINESE GOVERNMENT SEEKS TO FORCE ABORTION IN U.S.

Abort or else! said Chinese authorities to a couple expecting their second child while living and studying in the United States. An article in the August 1988 issue of the <u>Reader's Digest</u> outlines the travails of Li Quan Bang's story - his wife was seven month's pregnant and the Chinese government was attempting to force her to have an abortion. According to Chinese technical policy on birth control, regulations call for the insertion of an IUD after one birth, sterilization after two, and abortion for women pregnant without official permission.

Sanctions threatened by the Chinese government, if the pregnant woman, Ping Hong, did not have an abortion, included punishing all the workers at the factories where the two Chinese nationals worked before coming to the United States to study - including no salary increases plus the factory would be disqualified from production contests - and nightly visits to Ping Hong's elderly mother warning of terrible consequences for the whole family should there not be an abortion.

Fortunately, on February 1, Ping Hong gave birth to a healthy baby girl. The Lis have named her Mahwae which means beautiful and smart but also stands for America, the land of her birth.

Shortly before leaving office, Attorney General Ed Meese announced on August 5th that the couple had been granted political asylum in our country.
