What Pro-lifers Stand For and Against

very human being matters, and we ought to act accordingly. The media often use the label "antiabortion" to describe pro-life advocates. It's true that we opposed abortion - and infanticide, euthanasia and embryo-destructive research. But we are only against those things because we are for something else.

What are we for

What are we for? We are for the proposition that human life is good, that it is worth living, that it deserves respect and protection. We are for the proposition that every human being has an equal worth and dignity that every human being has a right to live.

The pro-life position rejects all attempts to divide humanity into those who have rights and those who don't. Our society now recognizes that past discrimination on the basis of race, gender, ethnicity and social status was deeply unjust. We recognize that the worth of a human being does not depend on such characteristics.

Nor, however, does the worth of a human being depend on age, size, ability, dependency, state of development or the desires and decisions of others. The big are not more valuable than the small. The strong do not have more rights than the weak. The independent do not matter more than the vulnerable and needy.

No, we have value and a right to life simply because we are human - not because of what we can do, but because of what (the kind of being) we are. That's why everyone matters. Everyone counts.

What we are against

It is because we support equal human dignity that we oppose the intentional killing of innocent human beings. And that means we oppose abortion, infanticide, euthanasia, and embryo-destructive research.

Pro-lifers oppose abortion because it takes the life of a human being before he or she is born. The scientific facts of embryology and developmental biology make clear that the unborn (the human embryo or fetus) is a distinct and living human organism, a full-fledged (though immature) member of the species Homo sapiens. Each of us was once an embryo and a fetus, just as we were once infants, toddlers and adolescents.

And all human beings, at all stages, have a right to life, whether or not they are "wanted" or "convenient."

We oppose euthanasia and assisted suicide because killing is never the answer to the difficulties of life. All human beings should receive our compassion and care, irrespective of disease, disability or perceived "quality of life."

We oppose embryonic stem cell research (but not adult or non-embryonic stem cell research) and human cloning because they require the destruction of human embryos. Human embryos are human beings in the embryonic phase of life. And all human beings, regardless of appearance and location (e.g., a petri dish), ought to be treated with respect and not as mere raw materials to use for the hypothetical benefit of others.

Living our conviction

But being pro-life is about more than just holding an ethical position. To be truly pro-life means to live and act accordingly.

It means treating other people with dignity and respect - even those with whom we disagree. It means helping pregnant women in need.

It means recognizing the moral gravity and scale of abortion - the premier injustice and leading cause of death in American society today - and taking action to save lives. Educating ourselves, talking to others, persuading them. Supporting pro-life educational and legislative efforts through pro-life organizations.

Being pro-life, ultimately, is about loving others, especially the most vulnerable. It is about loving our neighbors as we love ourselves. And love isn't just a feeling. It is a commitment.

Conscientious Objection and the Duty to Refer

hen the Trump administration announced a new department of Conscience and Religious Freedom, the pushback from abortion and assisted suicide proponents like Planned Parenthood and Compassion & Choices was immediate and accompanied by apocalyptic predictions of harm to patients.

Now the term "conscientious objection" is increasingly being used rather than "conscience rights" when it comes to health care professionals. I believe this is not accidental. The term "conscience rights" is a powerful and accepted term about individual right while "conscientious objection" is associated with the traditional definition of "A person who **refuse to serve in the military due to religious or strong philosophical views against war or killing**" and who "may be required to perform some **nonviolent work like driving an ambulance.**" (Emphasis added)

Nevertheless, in a March 30, 2018 Medscape article titled "Should Clinicians With Conscientious Objections Be Protected?", well-known ethicist Arthur L. Caplan, PhD criticizes the new Conscience and Religious Freedom Division as an expensive "overreaction" that can be mediated by allowing health care professionals to refuse to provide a legal act (like abortion or assisted suicide in certain areas) but requiring them "to tell patients where they can go and how they can go about getting it."

This echoes last year's New England Journal of Medicine article "Physicians, No Conscripts - Conscientious Objection in Health Care" by Dr. Ezekiel Emanuel (one of the architects of Obamacare) and Ronit Y. Stahl, PhD who insists that medical professionals "cannot completely absent themselves from providing these services" and are still required to convey "accurate information" and provide "timely referrals to ensure patients receive care."

The authors even state that:

"Health Care professional who are unwilling to accept these limits have **two choices: select an area of medicine, such as radiology, that will not put them in situations with their personal moral ity or, if there is no such area, leave the profess sion**." (Emphasis added)

Their rationale for this extreme position is that "the patient comes first, which means the **patient's conscience and autonomy receive priority over those of the physician**." (Emphasis added)

However, this could now conflict with the recently amended federal Affordable Care Act (aka Obamacare) that states: "No qualified health plan offered through an Ex change may discriminate against any individual health care provider or health care facility because of its unwillingness to provide, pay for, provide coverage of, or **refer for abortion**."

and

"The Federal Government, and any State or local government or health care provider that receives Federal financial assistance under this Act (or un der an amendment made by this Act) or any health plan created under this Act (or under an amendment made by this Act), **may not subject** an individual or institutional health care entity to discrimination on the basis that the entity does not provide any health care item or service furnished for the purpose of causing, or for the purpose of assisting in causing, the death of any individual, such as by assisted suicide, euthana sia, or mercy killing." (All emphasis added).

The Duty to "Convey Accurate Information" and "Refer"

I ronically, do groups like Planned Parenthood and Compassion & Choices **really** want to require a medical professional opposed to abortion and/or assisted suicide to convey accurate information?


First of all, medical referrals require a measure of trust. For example. No doctor or nurse would knowingly refer a patient to another doctor or organization that he/she considers incompetent or unethical or for a procedure the medical professional considers harmful to the patient. When a patient asks for procedures like abortion or assisted suicide, the medical professional should be free to refer the patient to support services like crisis pregnancy centers, etc. or to an ethical palliative care specialist, mental health expert, etc. The medical professional should also be free to convey accurate information regarding abortion such as how abortions are performed, potential physical and emotional complications, fetal development, etc. With assisted suicide, the medical professional should be free to discuss such issues as the potential complications of a lethal overdoes, the potential effects of family and friends, the criminal/civil immunity of the assisted suicide doctor if the assisted suicide goes awry, etc.

Medical professionals should also have the right to be honest and tell patients if they personally don't know any doctor or organization that they would recommend to provide a referral for abortion of assisted suicide.

Patients, especially those in distress, need a wellinformed medical professional who really listens to their concerns and responds with facts and helpful options rather than one who just hands out a "politically correct" referral.

Conclusion

The so-called duty to perform/participate in a lifeending procedure or refer for one is not really about conscience rights but rather another way to extinguish resistance to abortion and assisted suicide, normalize such procedures into standard medical practice and discourage/bully ethical health care professionals into leaving or never entering the medical professions.

Those of us who believe in medical ethics as, first and foremost, doing no harm to patients must actively fight this for the sake of our professions and for the safety of the public that puts their lives in our hands.



The State of Abortion in the United States: A Critical Report



The State of Abortion in the United

States is a report issued by the National Right to Life Committee (NRLC). Founded in 1968, National Right to Life, the federation of 50 state right-to-life affiliates and more than 3,000 local chapters, is the nation's oldest and largest national grassroots pro-life organization. Recognized as the flagship of the pro-life movement, National Right to Life works through legislation and education to protect innocent human life from abortion, infanticide, assisted suicide and euthanasia.

Abortion Numbers: CDC Data Analysis (Continued from April LIFESPAN News)

Types and Timing of Abortions

Over two-thirds (67%) of abortions were performed at eight or fewer weeks gestation. The advent of chemical abortions has meant that more and more abortions are performed at earlier gestations. Thus, it is not surprising that just over four in ten (41.1%) were actually performed at six weeks or less in 2015. CDC data show that the number of abortions at 6 weeks or less has risen steadily since 2005.

About a quarter (24.5%) of the abortions occurred between nine and 13 weeks. The remaining 8.5% were performed in the second trimester or later: 3.3% at 14-15 weeks, 2% at 16-17 weeks, 1.9% at 18-20 weeks, and 1.3% at or beyond 21 weeks.

The CDC shows that 76% of all abortions continue to be surgical abortions (67.4% first trimester, 8.6% at second or third trimester). Most of the rest of the abortions (22.6%) were first trimester "medical" (chemical) abortions using drugs like mifepristone (RU-486) and misoprostol. An additional 1.5% were chemical procedures performed at 8 weeks or more.

Just a handful of abortions employed rarely used chemical or surgical methods like instillation or hysterotomy.

Overall, though data show first trimester surgical abortions still dominate the industry, they also show abortions being performed earlier and earlier, with more and more using chemical rather than surgical methods.

Significant Single-Year Shifts

C DC figures for 2014 show in 28 reporting areas, and another 20 showing increases. For the most part, the number of abortions rose or fell by modest amounts. However a handful of states saw big drops or increases. Unless noted otherwise, all increases/decreases are from 2013 to 2014.

Shifting Numbers

Why are the abortion rate and abortion ratio important? When the abortion rate drops, it means fewer women in the state are having abortions. A declining ratio means pregnant women are more often choosing to give birth instead of aborting their babies.

National decreases have been deep and sustained, providing encouragement to pro-lifers everywhere. Both long and short term statistics show not only fewer women becoming pregnant but fewer abortions among those women who did become pregnant.

There are some cautionary notes found in the most recent state of abortion data from the CDC.

Over the long term, numbers of abortions, abortion rates and ratios are down in virtually every state. Most states showed drops in most years going back over the past two decades or more. While most of the decreases were modest, a few states had profound declines.

It is also true some states saw increases over the numbers in the CDC's report for 2013. Generally, these changes were slight, only a few dozen or at the most a couple of hundred more. In some cases, however, there appear to have been significant increases in just a year's time.

While the general trend speaks for itself, the larger moves up or down call for some explanation and educated examination.

BIG DROPS AND SIGNIFICANT INCREASES

The number of abortions in Texas dropped by a significant number - 9,020. Abortions fell by 2,278 in Illinois and 2,030 in Ohio. In New York, there were 1,335 fewer abortions while in Tennessee, there were 1,843 fewer abortions.

Some of this is simply a function of being a large state with a large volume of abortions from the beginning, but there are other reasons that will be discussed later. It is also important to note that a few smaller states saw diminishing numbers that were significant for them.

For example, Montana reported 152 fewer abortions, significant given their smaller population. But Montana also experienced a substantially lower abortion rate (down 0.9 abortions per thousand women aged 15-44, while the national drop was just 0.3) and lower abortion ratio (down 13 abortions for every thousand live births) in 2014.

Rhode Island reported only 261 fewer abortions. However this was huge given their smaller size and population. In addition, their abortion rate (again, the number of abortions per 1,000 women of reproductive age) fell 1.3, more than four times the national rate drop. Rhode Islands, abortion ratio (the number of abortions for every 1,000 live births) was down 25, nearly double the national ratio drop.

A look at the abortion rates and ratios show that some of the bigger states drops were for reasons more than just their size. New York's rate drop was just 0.4, a hair over the national 0.3 drop. However their abortion ratio dropped by a huge 143 abortions.

Illinois' abortion rate drop (0.9 fewer abortions per thousand women of reproductive age) was three times the national rate drop. Its abortion ratio fell 17. Ohio's rate drop (-0.9) was also three times the national rate drop and its ratio fell 15.

Tennessee and Texas saw huge drops in their abortion rates (drops of 1.5 in the abortion rate of Tennessee, and 1.8 for Texas) as well as significant drops in the abortion ratio (a decline in the abortion ratio of 26 for Tennessee and 28 for Texas).

Why bodily autonomy–"My body, my choice"– doesn't justify abortion

bortion is justified, many of its defenders argue, because women have a right to control their own bodies. "My body, my choice," signs and bumper stickers proclaim. The bodily autonomy argument takes a few different forms. None, however, are successful.

Some people think that the unborn (the human embryo or fetus) is a mere part of the woman's body. But science, of course, has established that the unborn—though physically dependent on and inside of the mother—is a distinct, self-developing individual with his or her own DNA, brain, arms and legs, etc.

Abortion attacks and kills the body of someone else.

Other people believe that even though the unborn is a distinct human organism, a pregnant woman should be able to decide what happens in or to her body. Whereas many arguments for abortion contend that the human being in utero is not a "person" with intrinsic value and rights, this argument holds that abortion is permissible regardless of whether or not the child is a valuable person. The Sovereign Zone argument

Trent Horn helpfully distinguishes between two variations of this approach. The first version, which he calls the "Sovereign Zone" argument, claims that a woman has an absolute right to do whatever she wants with anything that is inside her body. And the unborn child—even if she is a human person—is currently within that sovereign zone.

But sovereignty cannot be absolute. Consider an analogy: May we do whatever we want with anything that is on our private property? May we attack or kill innocent people who are passing through or seeking refuge? No, we must respect the rights of other people. "Mere ownership," acknowledges pro-choice philosopher Mary Anne Warren, "does not give me the right to kill innocent people whom I find o my property." And so it is with pregnancy.

May a pregnant woman ingest drugs that she knows will cause her child to be deformed or disabled? Clearly not. And if knowingly harming the child is wrong, killing her (through abortion) is even worse. Bodily autonomy is important, but there are obvious limits to that autonomy when someone else's body is also involved.

The Right to Refuse argument

The second, more sophisticated version, which Horn calls the "Right to Refuse" argument, was first introduced by moral philosopher Judith Jarvis Thomson in 1971. It contends that a woman has a right to refuse to let the unborn child use her body to survive. Just as a person is not obligated to donate an organ to save the life of someone else, the pregnant woman is not obligated to provide her uterus (and the sustenance and protection it affords) to her child.

This argument has enormous problems. Abortion, in the vast majority of cases, is not merely the withholding or withdrawing of "life support" from the unborn child – it is the intentional and active killing of that child, often by dismemberment. This killing violates the child's right to life (the right not to be intentionally killed) and right to bodily integrity. Indeed, "if people have a right to bodily integrity and so do not have a duty to donate a kidney," writes philosopher Christopher Kaczor, "then people in utero have a right not to have their bodily integrity fatally violated through abortion."

Moreover, even if abortion were not intentional killing (i.e., if it were simply a refusal to aid the child by removing her from the womb), abortion would still be wrong because a pregnant woman does have an obligation to allow her baby to live and grow in the womb. Here's why.

First, the father and mother, except in cases of rape, willingly engaged in an activity that caused the creation of a new, dependent human being. So they bear responsibility for the resulting child.

Second, parents have special obligations to their dependent offspring that they do not have to others. Fathers, for example, must pay child support even if they did not intend or desire to become fathers. Parents may not abandon their children or refuse to provide for their needs (though they may relinquish those obligations through adoption).

Indeed, more generally, "we are by nature members of communities," explains ethicist Patrick Lee. "[O]ur flourishing involves being in communion with others. And communion with others of itself—even if we find ourselves united with others because of a physical or social relationship which precedes our consent—entails duties or responsibilities." Parental obligation may not require extraordinary acts (like donating a kidney), but it does require basic, ordinary care, such as the nourishment and shelter provided during pregnancy. If unborn children are valuable members of the human family, like born children, then the same parental duties that apply after birth are present beforehand as well.

Third, the purpose of the uterus is to gestate the unborn child—it is where that child belongs. All human beings, during their prenatal stages of development, rely on it for care and protection. "The uterus exists for the unborn child rather than for the mother," notes Stephanie Gray. It is reasonable to think that a child has a right to live in her natural environment.

Finally, even apart from the other reasons, a moral obligation seems to arise when we alone are in a position to provide ordinary care (food and shelter) to someone who needs it to survive.

"Suppose you live in a cabin far out in the wilderness, cut off from civilization by extreme distance and weather for much of the year, say, nine months," writes Mathew Lu, a philosophy professor at the University of St. Thomas in St. Paul. "One day you return to the cabin to discover that an infant has been left at the door without explanation. ... Do you have an obligation to care for the infant, who will surely die if you do not take it in?"

Most people would say yes. "[W]e have a general obligation to protect the vulnerable, and a special obligation towards those we contingently encounter," Lu concludes. Bodily rights do not justify abortion

The right to control one's body does not justify the intentional killing of others. Nor does it nullify our obligations to the youngest and most vulnerable members of the human family. Indeed, the autonomy argument turns common sense and justice upside down. The unique nature of pregnancy – the bodily dynamic between an unborn child and her mother – is not, as the argument supposes, a reason to think that killing or neglect is permissible. It is, instead, a reminder that human beings are connected to and dependent on each other.

"The so-called right to abortion has ... sown violence and discord at the heart of the most intimate human relationships," observed Mother Teresa of Calcutta. "It has portrayed the greatest of gifts – a child – as a competitor, an intrusion, and an inconvenience. It has nominally accorded mothers unfettered dominion over the independent lives of their physically dependent sons and daughters."

This "unconscionable power," Mother Teresa said, must be rejected. Both mother and child deserve respect, protection, and care.
