Right to Life - LIFESPAN applauds the United States Supreme Court decision in *NIFLA v Becerra*, which was an effort to deny pregnant women an opportunity to seek options other than the death of the child they carry via abortion, by forcing the pro life pregnancy clinic to refer clients to abortion clinics. The court determined, rightly so, that such laws were unconstitutional because they violated the free speech rights of the pregnancy help center, forcing them to proclaim a form of government mandated speech.
