The Birth Privilege of Brian Sims

hile not one major network has covered the story, thanks to social media, most people are aware of Pennsylvania State Representative Brian Sims' disgraceful harassment of a peaceful, prayer, pro-life witness in front of a Philadelphia Planned Parenthood. In his eight minute tirade, which he filmed and posted online, proudly showcasing his bullying of "an old white woman," the elected official assails her for her "white privilege." Sims is also white, but apparently he handles his "white privilege" in a morally superior fashion. Or at least that's his self-perception.

Cambridge English Dictionary defines white privilege as "the fact of people with white skin having advantages in society that other people do not have."

But what about "birth privilege"? Would that not be defined then as "the facto of people who are allowed to be born having advantages in society that other people (those denied birth) do not have?"

Unlike 61 million babies, Sims was allowed to live and grow inside his mother's womb until he was ready to breathe his own air. He was small, vulnerable, completely dependent, and completely human right from the moment of conception when his unique combination of DNA, never to be repeated again, came into existence.

He didn't become human, like he didn't become white. He always was.

He wasn't his mother's body, some extension of her like a tooth or birthmark. He was, genetically, an entire different human being within her body. He was and is her child.

Everyday Sims enjoys the privilege of being born, enabling him to experience liberty and pursue happiness, to seek public office, to speak out for those he feels are under-represented. But not all are so lucky. Birth privilege is perfectly summed up in a now famous statement made by President Ronald Reagan: "I've noticed everyone who is for abortion has already been born."

Those with birth privilege are in the position of power and strength over the weak and defenseless, the pre-born. So doesn't that make abortion the ultimate form of bullying?

Sims, a former football player, a youngish lawyer, and an empowered public official, clearly bullies the lone, powerless, older woman. He berates her verbally, mocking her because of her age, race, and faith. He attacks her character by asking how many children she had clothed that day. He calls her a hypocrite. And when she tries to walk away without comment, he follows. And this blatant act of bullying was such a source of pride, he publicized it himself!

Of course, Sims is comfortable lording his physical presence and social status over someone less formidable



than he. After all, he advocates for abortion, which does the exact same thing: the strong and empowered refuse to recognize the dignity of those smaller and powerless, and they then proceed to destroy them.

Once we lose respect for the most vulnerable human life, it should come as no surprise that no one is off limits. Not babies. Not the elderly. Not innocent prayerful women. No one. Nothing is sacred.

We can only pray that Brian Sims, like many one-time abortion supporters, repents and has a conversion of heart. Perhaps then, he can use his birth privilege to make this world one in which no human life is ever again bullied to death.



Legislative Update NRLC Expresses opposition to the Equality Act (H.R. 5)

Editor's Note: This letter was sent on May 9 by NRLC

Dear Member of Congress:

The House of Representatives is expected to take up the Equality Act (H.R. 5) next week.

H.R. 5 contains language that could be construed to create a right to demand abortion from health care providers, and likely would place at risk the authority of state and federal government to prohibit taxpayer-funded abortions.

Historically, when Congress has addressed discrimination based on sex, rules of construction have been added to prevent requiring funding of abortion or nullifying conscience laws. Unless such a rule of construction is added to the Equality Act, National Right to Life urges you to oppose the bill, and will include a House roll call on this measure in our scorecard of key pro-life votes of the 116th Congress.

Section 9 of the Equality Act would amend the Civil Rights Act of 1964 by defining "sex" to include "pregnancy, childbirth, or a related medical condition." It is well established that abortion will be regarded as a "related medical condition." See 29 C.F.R. pt. 1604 App. (1986) and *Doe v. CARS Protection Plus, Inc.*, 527 F.3d 358 (3d Cir. 2008).

H.R. 5 goes on to expand this anti -discrimination provision by stating that "pregnancy, childbirth, or a related medical condition shall not receive less favorable treatment than other physical conditions," and would add "establishments that provide health care" to the list of covered "public accommodations."

What these provisions will mean, taken together, is that health care establishments and individuals providing healthcare will be required to provide abortion as a "treatment" for pregnancy.

H.R. 5's new definition of "public accommodations" includes any "establishment that provides health care, accounting, or legal services." The bill has an additional rule of construction that the term "establishment" "shall be construed to include an individual whose operations affect commerce and who is a provider of a good, service, or program" and "shall not be construed to be limited to a physical facility or place." These provisions would apply to individual health care providers who object to abortion, including those with religious objections (indeed, the bill explicitly overrides the protections contained in existing federal law under the Religious Freedom Restoration Act, 42 2U.S.C. 2000bb et seq.).

These pro-abortion requirements may also apply to non-physical entities like federal and state governments that determine health care coverage under Medicaid. H.R. 5 does include a reference to Pub. L. 88 -352, title VII, §?703, which prevents employers from being forced to offer abortion coverage. However, there is no language to thus protect individual health care providers. Also, there is no language applying to the authority of federal or state governments (non-physical entities) to prohibit taxpayer-funded abortions, as under the Hyde Amendment. The

pro-abortion National Partnership for Women and Families explains, "women would be able to challenge denials of reproductive health care."

To summarize: The bill as written may be construed to create a right to demand abortion from health care providers and to destroy conscience protections for health care providers.

Again, unless a rule of construction is added to the Equality Act that would ensure that the legislation will not require funding of abortion or nullify conscience laws, National Right to Life urges you to oppose the bill, and will include a House roll call on this measure in our scorecard of key pro-life votes of the 116th Congress.

Words of Wisdom

he wonders of the Internet and stories you've forgotten you saved hidden away on your hard drive.

I was researching my response to yet **another** puff piece hailing abortionist Willie Parker when I ran across a column I read awhile back. It was by Ross Douthat, a columnist for the New York Times, and the title of his superb piece was "Looking Away From Abortion."

Bless his heart, Mr. Douthat began his column with an excerpt from an essay that appear in "Mortal Lessons: Notes on the Art of Surgery," a magnificent book written by Dr. Richard Selzer published in 1976.

The title of the essay is "YOU SAW AND YOU KNOW."

What Selzer saw is as good of an example of the shock of recognition as you will **ever** find. He tells us that after a garbage truck left his neighborhood, Dr. Selzer found "a foreignness upon the pavement."

But the "it" is not an "it" at all. A bag containing the remains of aborted babies' had fallen off the garbage truck and broken open. They had

Accidentally got mixed up with the other debris instead of being incinerated or interred. "It is not an everyday occurrence. Once in a lifetime, he [the hospital director] says."

It was very important to the hospital director that Selzer understand what had happened - and to himself as well, it appears.

It mattered to him that Selzer know that "aborted fetuses that weigh one pound or less are incinerated. Those weighing over one pound are buried at the city cemetery."

Why the need for the meticulous detail? Selzer speculates that it is an attempt to offer a rationale - an assurance - the contrary to your lying eyes, the world has not gone crazy. The hospital director's explanations are to assure us so that

Now you see. It is orderly. It is sensible. The world is not mad. This is still a civilized society...

But Selzer **did** see, in the only way that matters.

"All at once you step on something soft. You feel it with your foot. Even through your shoe you have the sense of something unusual, something marked by a special 'give.' It is a foreignness up on the pavement. Instinct pulls your foot away in an awkward little movement. You look down and you see... a tiny naked body, its arms and legs flung apart, its head thrown back, its mouth agape, its face serious. A bird, you think, fallen from its nest. But there is no nest here on Wood side, no bird so big. It is rubber, then. A model. A joke. Yes, that's it, a joke. And you bend to see. Because you must. And it is no joke. Such a gray softness can be but one thing. It is a baby, and dead.

As he ponders what he has seen and heard - and what it means - Selzer concludes

"Now you see. It is orderly. It is sensible. The world is not mad. This is still a civilized society... But just this once, you know it isn't. You saw, and you know."

And once you see and you know, you can never stop fighting to save unborn babies, their mothers, and our culture.



Michigan Legislature votes to ban dismemberment abortion

he Republican-led Michigan State House and Senate voted to ban dismemberment abortions today. House Bills 4320 and 4321 and Senate Bills 229 and 230 would modify the state's existing partial-birth abortion ban to include dismemberment abortions, often referred to as dilation and evacuation abortions. Dismemberment abortion is one of the most common but also most gruesome second-trimester abortion procedures, as it involves ripping the arms and legs off an unborn baby's body with a pair of forceps. The bills include an exception if the mother's life is in danger.

The Senate voted 22-16 in favor of both bills, while the House voted 58-51 in favor. Every Democrat voted against banning dismemberment abortions.

If signed into law by Democratic Gov. Gretchen Whitmer, the legislation would make dismemberment abortion a felony. However, Whitmer has previously promised to veto pro-life laws that arrive at her desk, telling Planned Parenthood last month it has a "powerful backstop in a veto from my office."

"If she refuses to sign it, we'll find 400,000 people who will and bypass her veto!" Right to Life of Michigan vowed immediately following the vote.

Today's vote comes at a time when top Michigan Democrats have been ramping up their attacks on prolife, pro-family values.

In March, state Attorney General Dana Nessel, a lesbian and feminist who has been accused of being anti-Catholic, announced that taxpayer-funded adoption agencies with religious objections to placing foster care children into homes of homosexual "married" couples will no longer be able to cite their faith as a legitimate reason to opt out of providing that service. Nessel is also investigating the Michigan-based Church Militant website, a staunchly conservative Catholic organization, because the far-left Southern Poverty Law Center labeled them "anti-LGBT."

If Roe v. Wade were to be overturned, Nessel, who has added her name to a lawsuit challenging the legality of pro-life "heartbeat" legislation, has said she wouldn't enforce a state abortion ban.

House Bills 4320 and 4321 were approved by the Michigan House Judiciary Committee with a 7-5 vote. They previously passed the House's Families, Children, and Seniors Committee by a 5-4 margin on May 1. At that hearing, veteran pro-life activist Dr. Monica Miller, a Michigan resident, testified in support of the legislation. She also testified before the Senate.

Holding up photographs of dismembered babies to lawmakers, Miller said that the "cut-to-pieces" babies she found in trash bags in dumpsters behind abortion clinics on the state's east side were Michigan's "dark secret." Democrats serving on the committee did not ask Miller any questions during or after her testimony, despite aggressively challenging other pro-life experts who appeared in support of the legislation. Footage of Miller's powerful remarks has been viewed on YouTube more than 355,000 times.

In 2017, 1,777 dismemberment abortions took place in Michigan. Of those, 98 percent occurred in the second trimester, between 13 and 24 weeks of pregnancy. From 2013 to 2017, the state averaged 26,200 abortions per year.
