The Deaf Community of Detroit is Supporting Life & Wee Care

common question in the Deaf community is, "Why did you learn American Sign Language?" or "What got you interested in working with the Deaf community?" Everyone has a unique story! The same can be said for how people get involved in the Pro-Life movement.

- I was unmarried and pregnant. People pressured me to abort my baby. I chose to keep her. I gave her life and can't imagine not having her with me now.
- My wife and I agreed to abort our child, and I have lived in sorrow and guilt ever since.
- My parents stood-up for life. My grandparents fought for, even to the point of being put in jail during demonstrations. I know this is the basic right for all humans, If I'm too passive or afraid to stand-up for life, then I'm too afraid. I need to do something.

The last example is my own journey. My position as the Pastoral Minister with the Deaf Community in the Archdiocese of Detroit prompted my involvement locally (I can't ride on my ancestor's shirt-tails forever). I work at Saint John's Deaf Center which has two locations where Catholic Deaf congregate: Eastpointe and Redford. Over the past two years, I have encouraged them to participate in 40 Days for Life campaigns on Eight Mile in Detroit, LIFE CHAIN, Spiritual Adoption, and provided complimentary activities and education. It is motivating to instruct myself and my community about life issues and then... watch out!



From October 2018 to June 2019, we supported a Spiritual Adoption campaign. We prayed for babies in danger of abortion, and each month we learned how the babies

were developing in utero. We don't know the babies for whom we prayed, but we hope they were spared from abortion and will have a life of love. At the end of our "9month pregnancy of prayer," we hosted a Baby Shower with a white cake for our "spiritual babies" inscribed: *Welcome, Babies! We love you!* Donations were generous; I was deeply moved. This is the second time we have contributed to LIFESPAN's Wee Care. The St. John's Deaf Center does care!



Deaf children are at higher risk for sexual assault than their hearing peers. Language deficiency is common, therefore when a trauma occurs, the words are hard to find to tell someone. The ordeal is suffered alone and in silence often for many years. I am blessed that people in my community have told me their stories of unexpected pregnancies, difficult situations, abuse, and abortion. I have been able to pray with them, encourage them, ad see them stand-up and support life.

The coordinator of the 40 Days for Life campaign on Eight Mile in Detroit, Ed Hull and I talk periodically about plans and collaboration. He has spoken to our men's breakfast club about pro-life topics; that was another moment of grace. When Ed and I feel like there is *so* much to be done, we come back to the truth: *We can't do everything*. *We need to do something. Let us do our small part and trust that it has an impact.*

Thank you to the faithful people who have gone before us fighting for life. The Catholic Deaf community of Detroit is becoming generous with their time and treasure to support life, too. Thank you LIFESPAN and Wee Care! Every child has a right to life!

Man Charged in Murders of 9-Month-Pregnant Woman and Her Unborn Baby

erence Sample has been charged with kidnapping and two counts of murder in the deaths of McKayla Winston, his nine-month-pregnant girlfriend, and her unborn baby.

The 21-year-old Winston and her unborn baby "were found dead off a stretch of desolate roadway in Holmes County on July 1," The Clarion Ledger reported. "She had gone missing four days earlier."

The due date for her first child was July 4.

Last Thursday Sample, the son of a justice court judge in nearby Attala County, appeared in court in Holmes County for a preliminary hearing, according to reporter Justin Vicory:

> The man charged with kidnapping and killing a pregnant Mississippi woman acted after he learned she planned to keep the baby and not give it up for adoption, the Holmes County district attorney said Thursday before a packed courtroom

The 33-year-old Sample had a paternity hearing scheduled on July 3.

District Attorney Akille Malone-Oliver presented her case before Yazoo County Judge Bennie Warrington. According to Vicory's story

"Oliver pointed to witnesses and recovered phone communications from the night Winston went missing as proving she met with Sample, and then went missing shortly afterward."

Mississippi Bureau of Investigation Captain L.A. Oliver said witnesses confirmed seeing Winston and Sample and their vehicles at the same location on the same night. One of the witnesses had called and talked to Winston while she was with Sample, Oliver told the court. He said Winston planned on showing Sample pictures of her sonogram."

"Winston's car and phone were discovered in the same location the next day. Her keys were still in the ignition. Her shoes were also found outside the vehicle. Investigators also recovered what appeared to be blood in Sample's white SUV and on his clothing. "

"Oliver also testified that while the case was still a



missing persons case, Sample initially told investigators he hadn't spoken to Winston in three weeks to a month. That turned out to be untrue when investigators discovered the messages in Winston's phone. "

Sample's defense attorney, Richard Carter, said prosecutors were on a "fishing expedition," Vicory reported. "There's not one single piece of physical evidence to detain my client and hold him without bail."

District Attorney Malone-Oliver countered there was multiple circumstantial facts buttressing her case.

"There's substantial evidence the two were together through their location and communications... Witnesses spotted his vehicle and Makayla's at the same time period... He first denied contact with Makayla, but that was proved to be false...There's the possible DNA and article of clothing."

"We know that he was upset once he realized she was not going to put the baby up for adoption," she said.

At the end of the hearing, Judge Warrington ruled there was enough probable cause to hold Sample on the charges.

A Warped Vision for the **Future of Abortion**

coalition of nearly 80 pro-abortion groups, including Planned Parenthood and NARAL recently released a "Blueprint for Sexual and Reproductive Health Rights and Justice" that outlines their vision for the future of abortion: no restrictions, no religious exemptions and funded by the government.

In part, the document recommends 1) ending the Hyde Amendment, 2) ending the Helms Amendment, 2) removing conscience protections for health care providers from refusing to participate in an abortion by removing the Weldon amendment 3) eliminate the HHS Office of Conscience and Religious Freedom, 4) remove parental-notification requirements in a minor's abortion decision, 5) increase the availability and awareness of "self-managed abortion (SMA), and 6) require Congress to create a "Reproductive Health Care Provider Service Corps" to increase abortion access in "underserved areas".

Someone Cares - NYPD officers serve as pallbearers for funeral of discarded fetus

group of New York Police Department officers made sure a fetus discarded on a Brooklyn street months ago got a proper funeral – to the mournful sound of an NYPD bagpipe.

For Saturday's service, six officers carried the tiny casket into the Basilica of Our Lady of Perpetual Help in Brooklyn's Sunset Park neighborhood.

The funeral was organized by the Life Center of New York anti-abortion group, with Roman Catholic parishioners attending.

Life Center members gave the fetus a name: Monica. It was found last February in a bag by a tree in Brooklyn's East New York neighborhood, surrounded by bloodied clothing.

The medical examiner said the fetus was about 20 weeks old. Burial was at Resurrection Cemetery on Staten Island, in a section for abandoned remains.

Sacramento Center Uses "Lyft" to Save Babies and Serve Pregnant Women

egan" walked up to an abortion clinic to see people praying during 40 Days for Life on a Wednesday, but did not interact with them. She scheduled an appointment for two days later on a Friday and thought, "I wonder if there's any hope for me."

That's when she Googled "pregnancy help" and found Sacramento Life Center. She called the pregnancy center to tell them she was at the abortion clinic, and did not have a ride to the center.

Fortunately for Megan, the center had a solution: Lyft, a popular transportation network company that matches passengers with vehicles via its mobile app.

"No one in her life was supporting her to have the child, but knowing the Life Center and all the resources were here changed her mind," said Marie Leatherby, executive director of the Sacramento Life Center.

"Many of our clients are on the margins and if we had a no-show, it was due to transportation issues," Leatherby said. "The bus system in Sacramento is horrible, it takes people hours to get here."

When Leatherby heard about a nearby hospital implementing a Lyft program for their patients, she decided that was exactly what her pregnancy help center needed.

"The very day we said 'Let's do it, let's sign up,' we had someone who needed a ride to an appointment," Leatherby said. "And so we were like 'Okay, this is a gift from God.'"

Lyft's business program allows organizations to schedule rides for people to reach a location that the business chooses. The business plans, schedules, and pays for the ride. This program has allowed the Sacramento Life Center to schedule in advance for clients to be picked up for their appointments, or they can schedule for clients to be picked up last minute.

The Lyft program has been helpful for many clients, including women who have no transportation due to homelessness, women who may need to get multiple children on the bus, or women who have to carry large bags of diapers, baby clothes, and other resources home. Sacramento Life Center served about 1,800 clients in 2018 with pregnancy testing, ultrasound scans, options counseling, material assistance, STD testing, and more. Since starting the Lyft program, they've been able to offer round -trip rides to 2-3 clients a week at no charge to the client. Rides normally cost the Sacramento Life Center \$20-25



round trip per client, and the center has applied for a grant to fund the program.

"It's a really dignified way to help women feel like they matter, that they're important enough to bring them in when they don't have transportation," Leatherby said. "A lot of our clients are not licensed or don't have cars, and it's just one more thing that we can (do to) relieve a little bit of stress when they're in a stressful situation." - NRL News, June 27, 2019

A labor-induced abortion is not very "natural" at all, abortion doulas concede

ne way of doing abortions is by induction, or inducing labor. The baby is usually first injected with poison, such as digoxin or potassium chloride, killing him or her. Labor is induced, usually with prostaglandins or Cytotec.

The woman goes through labor and "gives birth" to her dead child. All third trimester and many late second trimester abortions are done this way.

Often when the mother is aborting due to fetal anomaly (a disability or illness in the baby), she chooses to do it by induction because she wants to hold, photograph, or see the baby afterwards .

In their book, abortion doulas Mary Mahoney and Lauren Mitchell, who have seen many abortions, describe abortion by induction:

Some clients are under the impression that labor inductions would be more "natural" or easier or safer than the surgical abortion. Many think of their own birth experiences with other children, and they feel more comfortable doing that than they do dealing with the drama of having a surgical abortion. It's a rude awakening when they realize that a labor induction is not very "natural" at all. Clients are given medications to start labor and IV's with fluids. They are strapped to monitors – they can't move, they can't eat, and their contractions are often so bad that they choose an epidural. According to physician David Grimes, the



uterus is not evolved to deliver a pregnancy during the second trimester. Miscarriages usually happen in the first trimester, and babies are delivered in the third, at the end of the pregnancy. Labor inductions in the second trimester can be as long and arduous as any full-term birth but with more medications. In other words – not a natural birth process.

From the President's Desk


