2020 “MOVEMENT IN MOTION” Youth Bus Trip

**Rules of Conduct Agreement for
Jr. High and High School Students**

– ALL BUSES –

(including those high school seniors who are 18 years old at the time of the trip)

**FOR THE DURATION OF THE TRIP, I, _____ (STUDENT’S PRINTED FULL NAME),
AGREE TO:**

1. Be polite, respectful, and cooperative to my Chaperone, Bus Captains, other Chaperones and fellow students with whom I am traveling and people I will meet along the way. In addition, I agree to not engage in any way with people who are pro-abortion anytime during the March, scheduled activities, downtime, etc.
2. Ask a question when a direction is not clear.
3. Refrain from swearing and/or using inappropriate language and/or gestures and public display of affection (PDA) which includes piggyback rides and horse play. Also, I agree to refrain from any types of physical harm to others (including throwing snowballs, hitting, etc.) and from taking anything that doesn’t belong to me from another Marcher on the trip, from the host church or school, etc.
4. Stay with my Chaperone and my group whenever I am off the bus during ALL SCHEDULED ACTIVITIES. *Permission may be given by Chaperones to groups of students when at museums for instance that they can tour around without the Chaperone. This will depend on the Chaperone and on the groups. Chaperones will determine if appropriate.*
5. Leave “no trace behind” wherever I go—clean up after myself, be respectful of other people’s property, etc.
6. Look out for my fellow travelers and alert my Chaperone if someone is ill, injured, not eating, upset, etc.
7. Keep my cell phone on and charged at all times during the trip so I can communicate with my Chaperone and others in my group.
8. Not connect my phone to the Wi-Fi on the bus during the trip as this interferes with the Bus Captains and Chaperones who need the connection to fulfil their leadership roles.
9. Always wear my *LIFESPAN* beanie hat for identification whenever I am off the bus during ALL SCHEDULED ACTIVITIES.
10. Not use headphones or I-Pods when off the bus. Polite use of these items will be allowed during the bus ride to and from DC and at the host church. Polite use means that I will be respectful of those around me and will not be listening to or playing anything that is offensive.
11. I will comply with the designated quiet time on the bus and at the host church without complaint. I understand and accept that the length of the quiet time hours could be extended if the Bus Captains feel it is necessary.

IF I DO NOT FOLLOW THESE GUIDELINES, I will be: 1) warned, 2) separated from the group with a phone call home, and 3) in extreme cases, will be required to return home at my or my family’s expense.
