## **Abortion Gravy Train Hits Turkey Week Snag**

hen pro-lifers counted their blessings this Thanksgiving, they could add something else to the list: the Fifth Circuit Court of Appeals. In another win for President Trump's legacy on judges, the full Fifth Circuit gave the green light to three states to defund Planned Parenthood in Medicaid. Texas and Louisiana had been fighting to cut ties with the abortion giant for years -- only to be slapped down by the courts. Now, thanks to four new Trump judges, the bench had just enough common sense to give state leaders that right.

The victory was even sweeter because it didn't just overturn the Fifth Circuit's three-judge panel, but it specifically rolled back another decision that stopped Louisiana from doing the same. Now, thanks to the 11-5 ruling, both states (and Mississippi, since it's in the same jurisdiction) are free to zero out Planned Parenthood dollars.

Of course, this all started back in 2015 when David Daleiden's undercover videos exploded on the scene, outing Planned Parenthood's secret organ harvesting ring. The hours of footage confirmed a gruesome truth: America's biggest abortion business was selling pieces of aborted babies for profit. Nationwide, states started scrambling to distance themselves from the group's shop of horrors.

Some of the most damning evidence came from Planned Parenthood's Gulf Coast branch in Texas, where Director of Research Melissa Ferrill was caught on tape admitting that the scheme "contributes so much to the bottom line of our business here." She brags about her staff's "skill" in procuring "intact fetal cadavers" and reminds Daleiden that their location is one of the country's largest. She also admits to Daleiden that Planned Parenthood has managed to hide the illegal sales with clever accounting tricks. "We had two levels of invoicing for them," she explains, before launching into the elaborate cover-up.

Testimony like hers horrified Texas leaders, who flew into action to stop the group from getting a penny of the state's health care money. Leaders decided that, based on these videos, Planned Parenthood was "not qualified to provide medical services in a professionally competent, safe, legal, and ethical manner" under the Texas guidelines for Medicaid providers. As far as they could see, there were "numerous violations of generally accepted standards of medical practice." Not to mention, others pointed out, Planned Parenthood employees were lying and scamming the state.

Now, after three tries in court -- including a 7-7 deadlock in the Fifth Circuit in 2017 -- Texas is one step closer to its goal of cutting Planned Parenthood completely out of the funding picture. Of course, FRC legal expert Katherine Beck Johnson points out, the case could still have a ways to go, since Monday's ruling was a decision on whether Medicaid patients could sue over Texas's decision. Eleven judges said they don't. In the majority opinion, Judge Priscilla Owen pointed out that Medicaid beneficiaries have the right to "obtain services from the qualified provider of her choice," but said that doesn't mean a "beneficiary may contest or otherwise challenge a determination that the provider of her choice is unqualified."

Of the six judges Trump added to the Fifth Circuit, four agreed (a fifth recused, and the sixth wasn't on the court in time to hear the case). Katherine applauded the outcome, saying, "Medicaid patients should not and now cannot use the courts to undermine Texas's correct determination that Planned Parenthood is not a qualified health care provider." If the abortion industry doesn't agree, guess what? They can take it up with the U.S. Supreme Court, where another three of the president's justices will be waiting!

## A Pro-Life Template

The 2020 Presidential Election did not go in favor of the pro-life candidate and President Trump is by no means perfect. However, to step back and look at the big picture, The Trump Administration was the most actively pro-life administration since legalization of abortion. In terms of the Right to Life, the Trump Administration left a great template for future pro-life Presidential campaign platforms and administrations, both in domestic and foreign affairs. President Trump appointed 3 justices to the Supreme Court purported to be pro-life and over 200 pro-life judges to the Federal bench. This just may tip the judicial scales against Roe v. Wade, or at least allow greatly increased state restrictions on abortion, in the next few years. Executive orders allowed states to defund Planned Parenthood, defunded a portion of Planned Parenthood's Federal subsidies, required medical care for babies who survive abortion, and added religious freedom rules to the Affordable Care Act which protect the conscience rights of employers and religious organizations. President Trump was the first president ever to speak at the March for Life and Vice President Pence was an annual fixture at the March. Internationally, the Administration restored the Mexico City policy to prevent U.S. foreign aid from funding abortion, defunded the UN Population Fund, and signed the Geneva Consensus Declaration with 32 other UN member states. This declaration states that there is no

international right to abortion and no international obligation to fund abortion.

## **COVID-19 Vaccinations and Abortion**

he rumor mill has been working overtime since the announcements of the apparent incredibly fast success of Project Warp Speed and possible COVID-19 vaccines. Many prolife people are rightfully concerned about using any vaccination that is not ethically created and are wondering if any of the inoculations contain the cells of aborted babies. The basic science behind vaccines is that a weakened strain of a disease is created in a laboratory and then administered to the body. The use of tissue from aborted babies enters the process of vaccine development in two places. The first is in the "cell culture" the weakened disease is grown in. These cell cultures are derived from a "cell line" that has been cultivated in laboratories for years and can continue growing for an extremely long time. Different vaccines are grown in all sorts of things like monkey kidney cells, chicken eggs, insect cells, yeast, or synthetic growth media. Sadly, others are grown in cells derived from aborted babies. For example, the WI-38 cell line used in Barr Lab's adenovirus vaccine was developed from the lung of an aborted female baby in 1962.

While none of the living cells from the aborted baby end up in vaccines using the cell lines, the cell lines are continually used to produce the vaccine, and a non-zero amount of biological components of the cells are present in the vaccine.

The second use of fetal cell lines in vaccine creation is in laboratory testing of some of them. It is important to know that the substance used for testing does not end up inside the actual vaccine; thus, there is a marked distinction between those vaccines grown in fetal cell tissue and those that were tested using fetal cell tissue.

Now that the basic science is out of the way, it is time to look specifically at the new COVID-19 vaccines. Currently there are only two that have successfully completed Phase III trials: Pfizer's and Moderna's vaccines. Both are fetal tissue free and grown in a non-cell substance, which is good news. However, it must be noted that both were tested on cells from the HEK-293 cell line derived from the kidney of a child aborted in the Netherlands in 1973. Even though **Pfizer** and **Moderna** do not use fetal tissue inside their COVID-19 vaccines, there are some companies that do. There are others that have vaccines in development with no use of fetal cell lines at all. A complete list of a COVID-19 vaccine candidates is maintained by the Charlotte Lozier Institute with information about their use of fetal cell lines.

The debate over the ethics of these vaccines is not new. Many past and current vaccines involve the use of fetal cell lines (many of which have alternatives).

For decades, prolife people have opposed developing new cell lines or using the tissue of aborted babies. Many people will try to justify abortion and the further trafficking of fetal tissue with the "promise" of saved lives. However, whether it is with stem cells or vaccines, there is always an ethical alternative or the ability to create one. There is no need to take the life of one person to save the life of another.

However, the fact remains that some vaccines exist that use fetal cell lines and have no current ethical alternatives. Is it ethical to use those vaccines? Prolife people disagree. The cell lines were derived decades ago, and though their source is unethical, we can't unkill those children. On the other hand, taking advantage of unethical methods promotes further abuses, in this case with the development of new cell lines. There's a meaningful difference between a vaccine requiring use of fetal cells and one that only uses them for testing, but how meaningful is that difference? The risks are another ethical consideration, balancing the risk of the disease vs. the vaccine, and ways you fit into that balance.

You have to think about these ethics now, before any potential pushes begin to make these vaccines mandatory or connected to pandemic restrictions. Right to Life of Michigan will speak out for the conscience rights of people who have ethical objections to taking a vaccine developed through the use of unethically obtained tissue from aborted babies.

If informed consent is supposed to be a cornerstone of the practice of medicine, then it is past time for the entire healthcare industry to only use tissue donated with the informed consent of every person involved. We should refuse "donations" taken through unjust violence.




