### **Nonsensical Statements Abound at Planned Parenthood**

**Editor's Note:** PAY CLOSE ATTENTION TO THE DEFINITION OF PREGNANCY - this is deliberate on the part of Planned Parenthood. Words mean something!!!!

first-trimester surgical abortion, says Planned Parenthood to its prospective clients, uses suction to "take a pregnancy out of your uterus." This description is literally nonsense. "Pregnancy" isn't a thing in the womb that you can remove. Pregnancy isn't a thing at all. It's a state or condition of a woman during which she carries her developing offspring. Virtually everyone understands this. Every dictionary says it.

Is it possible that an organization called Planned Parenthood doesn't know what pregnancy is?

The more plausible explanation is that Planned Parenthood and others in the abortion movement have a serious problem acknowledging reality. And this problem seems worse now than ever.

#### How Planned Parenthood describes unborn humans

"An abortion ... kills the life of a baby after it has begun," wrote Planned Parenthood in a 1952 pamphlet.

That was then. After it began performing abortions, Planned Parenthood didn't want to call unborn humans "babies" anymore. After all, most people think that killing babies is wrong.

What about "embryo" and "fetus"? These are scientific terms for human beings during the prenatal (embryonic and fetal) stages of their development. Although the terminology may sound foreign or clinical (and thus is sometimes used in a dehumanizing way), it accurately acknowledges the existence of an individual member of our species. That's a fact of biology that's not in dispute.

But Planned Parenthood doesn't like to concede even this. Instead, the organization often refers to embryos and fetuses with words and phrases like "tissue," "uterine contents," and "products of conception." As descriptions of living human organisms (human beings), these are highly misleading and dehumanizing euphemisms.

Sometimes, though, Planned Parenthood takes euphemism to a whole other level.

#### Planned Parenthood: Babies don't exist

Terms like "products of conception" at least acknowledge that something exists that is acted on in an abortion. That's why the abortion is performed in the first place – there's something in the uterus that the abortion practitioner tries to remove.

Calling an unborn child "the pregnancy" is different

because the word "pregnancy" means the mother's condition rather than the entity inside her womb. It's a way of pretending, as absurd as it is, that only the pregnant woman exists – there is no one with whom she is pregnant.

Likewise, Planned Parenthood vigorously employs terms like "women's health care" to describe the intentional killing of individuals who are not women. Planned Parenthood thus rhetorically subsumes these individuals under their mothers so that their fate falls within the domain of the mothers' health.

The group has recently extended this approach even beyond abortion. In the current debate in Congress over legislation to require equal treatment for newborn babies who survive abortion, Planned Parenthood, which opposes the bill, complains that such care would restrict "women's access to reproductive health care."

The legislation has no effect whatsoever on women's health. Their health care doesn't require the denial of health care to infants who are already born. So what on earth is Planned Parenthood talking about?

Instead of arguing for its position that abortion survivors shouldn't receive ordinary medical care – instead of calling them some dehumanizing label – Planned Parenthood is pretending that those newborn babies don't even exist. They are merely part of women. Only women and their health care exist.

This is the current state of Planned Parenthood's rhetoric.

#### Denying reality doesn't make it go away

In a 1995 essay, feminist writer Naomi Wolf, a supporter of abortion, criticized the abortion movement for its "lexicon of dehumanization" and its "reliance ... on a political rhetoric in which the fetus means nothing."

"Clinging to a rhetoric about abortion in which there is no life and no death," she wrote, "we entangle our beliefs in a series of self-delusions, fibs, and evasions."

Twenty-four years later, the rhetoric to which the abortion movement clings is even more evasive — and perhaps more desperate. It's a textbook example of Orwellian doublespeak. The purpose of doublespeak is to use language to obscure reality.

The reality Planned Parenthood aims to obscure is no mystery—it's the reality of the helpless human beings whom the organization routinely dismembers and kills. (The organization calls this process of tearing off arms and legs a "gentle" procedure "to empty your uterus.") Planned Parenthood wants everyone to pretend that those humans simply aren't there.

But they are. Denying reality doesn't make it go away. - National Right to Life News, April 1, 2021



The early years of LIFESPAN were filled with organizational meetings, determining priorities of action, and also working under deadlines and ever-changing challenges created by our opposition. In

Margaret was the catalyst that keep us moving and pushing forward, no matter the difficultly or what seemed to be an impossible task. She recruited her husband, her children, or neighbors and the workers in Oakland County grew. It was hard to say no to Margaret. As her obituary pointed out "she lived her life just as she admonished her children and friends to do: 'Look around, see what needs to be done, and do it'". The LIFESPAN organization we have now is because of so many people like Margaret who saw we needed a "voice for the preborn" and made one.

Margaret was an Irish mother to the core. She and John were blessed with nine children: Jim, Kathy, Jack, Patrick, Tom, Dave, Molly, Tim and baby Joseph (deceased). She has 18 grandchildren and 3 great grandchildren. As Alzheimer's stole her memory, one thing that could stimulate a reaction was a visit from her grandchildren or an announcement of a new baby in the family. Pro-life to the end.

I dedicate these words below to Margaret. I paraphrase words from Congressman Henry Hyde that Margaret heard so many years ago --it is pertinent today and to her eulogy.

When we stand before God and terror will rip your soul like nothing you can imagine. I really think that those in the pro-life movement will not be alone. I think there'll be a chorus of voices that have never been heard in this world but are heard very beautifully and very loudly in the next world and I think they will plead for everyone who has been in the movement. They will say to God, 'Spare them, because they loved us, 'and God will look at us and say not, 'Did you succeed?' but 'Did you try?" - Henry Hyde

# 100 Years of a World with Legal Abortion

The world recently passed the 100th anniversary of the Soviet Union becoming the first country to legalize abortion on November 18, 1920. The Soviet abortion rate eventually rose to 3 out of every 4 pregnancies. Vladimir Lenin and the Communist Party focused on three justifications for legalized abortion: 1) Women are dying from illegal underground abortions. 2) The State was protecting the health of women from dangerous conditions or life-threatening pregnancies. 3) The State expected the gradual disappearance of abortion once it was safe and legal. Quite interesting that the perverse propaganda in support of abortion 100 years ago and today remains identical! This legal slaughter of the innocents has spread throughout the globe since 1920. Currently, only 26 countries fully protect the preborn, 39 countries protect the child except in cases of rape or when the mother's life is at risk, and 55 countries protect babies with broader exceptions for the mother's health. Most of these pro-life leaning countries are in Latin America, Africa, and Muslim-majority regions in Asia. This leaves 81 countries, essentially Europe, India, East Asia, North America, and Communist states, which promote abortion on demand. Even among this group, the vast majority protect the preborn after the first 10-14 weeks of the pregnancy. The United States and Canada join China and few others in allowing the killing of the preborn throughout the pregnancy. To make matters worse, these abortionist regimes promote abortion imperialism and

continually threaten the enshrine abortion as an international "right" at the United Nations. The 2021 UN Commission on the Status of Women recently met in March. The European Union and United States led the charge for far-reaching pro-abortion and anti-family policies and attempted to bully states in Africa, Asia, and Latin America into compliance. The abortion agenda and transgender agenda were often explicitly linked together by EU and US diplomats. This attempt to enshrine abortion as an international right was defeated for now. ## The Assisted Suicide Juggernaut Continues in the U.S.

S ince Oregon passed the first physician-assisted suicide law in 1997, 8 more states and the District of Washington, D.C. passed assisted suicide laws by 2020. They are:

- **California** (End of Life Option Act; approved in 2015, in effect from 2016)
- Colorado (End of Life Options Act; 2016)
- District of Columbia (D.C. Death with Dignity Act; 2016/2017)
- Hawaii (Our Care, Our Choice Act; 2018/2019)
- Maine (Death with Dignity Act; 2019)
- New Jersey (Aid in Dying for the Terminally Ill Act; 2019)
- New Mexico (Elizabeth Whitefield End of Life Options Act; 2020)
- **Oregon** (Death with Dignity Act; 1994/1997)
- Vermont (Patient Choice and Control at the End of Life Act; 2013)
- Washington (Death with Dignity Act; 2008)

So far in 2021, 13 more states have proposed assisted suicide bills and 4 states with assisted suicide laws are facing bills to expand their assisted suicide laws.

These 13 states are **Arizona**, **Connecticut**, **Indiana**, **Iowa**, **Kansas**, **Kentucky**, **Massachusetts**, **Minnesota**, **Nevada**, **New Mexico**, **New York**, **North Dakota** and **Rhode Island**. Most of these states have been repeatedly hounded for years to pass an assisted suicide law.

The 4 states with bills expanding their assisted suicide laws are **California**, **Hawaii**, **Vermont** and the state of **Washington**.

The expansions range from expanding "qualified medical providers" from doctors to a range of non-doctors including nurses to eliminating so-called "safeguards" such as 15 day waiting periods, in person requests and even to allow electronic prescribing and shipping of lethal overdoses. *Compassion and Choices* (the former Hemlock Society) and other assisted suicide supporters have long portrayed assisted suicide "safeguards" as "burdensome obstacles."

#### CONSCIENCE RIGHTS AND CENSORSHIP

Conscience rights for health care providers has been a very real problem since the 1974 *Roe v Wade* U.S. Supreme Court decision legalized abortion in the U.S. The legalization of assisted suicide in several states has made this even worse for nurses, doctors, pharmacists and other healthcare workers. Even healthcare institutions have faced discrimination problems.

The Christian Medical and Dental Association even compiled a long list in 2019 of "Real-life examples of discrimination in healthcare."

Now we are seeing censorship. A March 28, 2021 *Wall Street Journal* op-ed titled "Big Tech Censors Religions, Too" stated that:

In January, Bishop Kevin Doran, an Irish Catholic, tweeted: "There is dignity in dying. As a priest, I am privileged to witness it often. *Assisted suicide, where it is practiced, is not an expression of freedom or dignity.*" Twitter removed this message and banned Bishop Doran from posting further. While the company reversed its decision after public op position, others haven't been so lucky." (Emphasis added)

#### CONCLUSION

Back in 2014, I wrote a blog "Should a Pro-Life person Become a Nurse" about a worried pro-life student nurse who wrote me asking "what area of nursing can I move into that does not demand that I do things that I absolutely will not do?"

I wrote her back and told her that I had that challenge in several areas I worked in over 45 years but was able to live up to my ethics despite some difficult situations and that I never regretted becoming a nurse.

However, conscience rights are not a luxury but rather a necessity.

This is why some of us nurses in Missouri worked so hard to get a conscience rights law passed in 1992 after the Nancy Cruzan starvation and dehydration death that, although not as strong as we wanted, is still in effect today. And I was thrilled when the Trump administration announced a new Conscience and Religious Freedom Division in 2018 to enforce "federal laws that protect conscience and the free exercise of religion and prohibit coercion and discrimination in health and human services."

Society has long insisted that health care professional adhere to the highest standards of ethics as a form for society. The vulnerability of a sick person and the inability of society to monitor every health care decision or action are powerful motivators to enforce such standards. For thousands of years, doctors (and nurses) have embraced the Hippocratic standard that "I will give no deadly medicine to any one, nor suggest any such counsel." Should that bright line to separate killing from caring now be erased by legislators or judges?

Without a strong resistance movement, the assisted suicide movement will only keep expanding. So far, much of the public has been shielded from the real truth by euphemisms and false reassurances from assisted suicide supporters, a mostly sympathetic mainstream media and often spineless professional and health care organizations.

We all must educated ourselves to speak out before it is too late.

#### From the President's Desk

My Dear Pro-Life Brothers and Sisters,

I believe we, pro-life advocates, are in deep trouble with this new administration in Washington, D.C. Like so many of us, I do not have answers as to how to combat an administration who has all three chambers of our government willing to pass laws that destroy human life. How we got here and what these people are trying to accomplish is for another day. What we do have to do is figure out how to survive the madness in D.C. Our tax money is already, again, paying for abortions worldwide. Planned Parenthood is receiving 600 million dollars of our tax money every year and increasing, to kill babies in the womb. The Hyde Amendment, which stopped our taxes for paying for abortion, is being threatened - THEY want to abolish it. This was passed in the 1980s and was a hard-fought amendment by Congressman Henry Hyde - one of the last true Statemen our country has seen.
