Pro-life women react to pro-abortion valedictorian: 'Nothing is restored' by abortion

exas high school valedictorian Paxton Smith quickly became a pro-abortion media darling after making a speech about how she is "terrified" that she might not have the ability to abort her child (due to a Texas 'heartbeat bill' restricting abortion) should she become unexpectedly pregnant. The underlying idea in Smith's speech is that such an occurrence would ruin her entire life, though millions of women's lived experiences have demonstrated the opposite. In her graduation speech, Smith said in part:

I am terrified that if my contraceptives fail, I am terrified that if I am raped, then my hopes and aspirations and dreams and efforts for my future will no longer matter. I hope that you can feel how gut-wrenching that is. I hope you can feel how dehumanizing it is to have the autonomy over your own body taken away from you.

I cannot give up this platform to promote complacency and peace when there is a war on my body and a war on my rights. A war on the rights of your mothers. A war on the rights of your sisters. A war on the rights of your daughters. We cannot stay silent.

But pregnancy — no matter the circumstance — does not end aspirations or dreams or a future. There is a strong likelihood that some mothers in the audience hearing Smith's speech actually experienced unplanned pregnancies, chose life, and were there that day to see those children graduate. Ending someone else's future for the sake of their own was not an option for them.

Smith's speech dehumanizes the human beings killed by abortion by ignoring their existence entirely. And yet, these children are the casualties of a sexual revolution that has told men and women they have a right to sex without the natural, biological result: children. Countless millions upon millions of human beings have been eradicated and women have been harmed as a result of this "war."

This is a truth that some women — like pro-life activist Toni McFadden, who had an abortion as a young woman — know all too well. In response to Smith's speech, McFadden wrote a Facebook post to her young daughters. She stated in part:

- I believed the very lies that Ms. Smith relayed in her valedictorian speech. When I found out I was pregnant I felt that my dreams, my goals, and my aspirations were being stripped from me.

- Knowing what I know now, they were simply feelings. Feelings change but truth does not.

- As an immature teenage girl, I believed the lie that ending the life of my child would restore my dreams, my



goals and my aspirations.

- After consuming poisonous pills to end the life of my baby, your sibling, that is not what happened. Nothing was restored. It was all a lie. The regret settled in, but I quickly pushed it down to survive.

- There is nothing natural about taking the life of your own child. I do not care how empowering someone like Ms. Paxton may make it sound. The reality is I had no right to take the life of my innocent child for my own selfish gain.

- The last thing I would ever want for my beautiful girls is to believe that lie.

- What makes you a powerful woman is unapologetically being who God created you to be. It's standing in truth even when the world is trying to convince you to live in lies.

Pro-life activist Jennifer Christie, who gave birth to her son Joshua after he was conceived during a brutal rape, also had some words in response to Smith's valedictory speech. In the text of her post, Christie wrote:

Paxton urges us, 'We cannot stay silent.'

Women. These lies -

Your dreams won't come true if you have a baby. You won't ever see the world if you have a baby. You don't have the time, temperament, money for a baby.

If you're pregnant? You ALREADY have a baby.

This is me not staying silent.

"There is a war being waged," she powerfully added in her Facebook video. "We stand defiantly on the mountaintop shouting about how we love ourselves and freedom and choice, unaware that beneath our feet is not rock and silt, but bone and blood."

Reasons to oppose assisted suicide by telehealth

n May 19, the Hospice News reported that a bill will be introduced in the US Senate to extend the use of telehealth that was initiated during the COVID-19 pandemic.

Last year I reported that the assisted suicide lobby was using the COVID-19 crisis to implement assisted suicide by telehealth.

This was not a new plan. The 2019 New Mexico assisted suicide bill and the 2020 bill to expand assisted suicide in Hawaii included assisted suicide by telehealth provisions.

In June 2020, Wesley Smith reported that assisted suicide by telehealth was happening. Quoting from an article titled: "Dying Virtually," published in The Conversation, Smith stated:

> [Dr. Carol] Parrot says she sees 90% of her patients online, visually examining a patient's symptoms, mobility, affect and breathing.

"I can get a great deal of information for how close a patient is to death from a Skype visit," Parrot explained. "I don't feel badly at all that I don't have a stethoscope on their chest."

After the initial visit, whether in person or online, aid-indying physicians carefully collate their prognosis with the patient's prior medical records and lab tests. Some also consult the patient's primary physician.

I understand the benefit of expanding telehealth services but assisted suicide is not a form of health care.

Assisted suicide by telehealth means that a person with difficult health issues who feels like a burden on others, or is experiencing depression or existential distress, could be assessed, approved and prescribed a lethal drug cocktail by telehealth without ever being examined by a physician.

Considering how common medical misdiagnosis is, assisted suicide by telehealth may lead to abuse of the law.

The language of the legislation is everything.

Language referring to "specialty consultations" (assisted suicide requires consultations), or end-oflife care (the assisted suicide lobby defines assisted suicide as end-of-life care) requires clear definitions to prevent its use for assisted suicide.

Imprecise language within the legislation may enable assisted suicide doctors to do assisted suicide assessments and prescribe lethal assisted suicide drugs, without meeting or physically assessing the person.

Assisted suicide is not health care.



Assisted suicide does not treat or cure a disease or condition, but rather it causes death.

The main goals of the assisted suicide lobby is to normalize assisted suicide by redefining it as end-of-life care and to expand the availability of assisted suicide. Assisted suicide by telehealth achieves the second goal. Telehealth may also lead to out-of-state assisted suicide deaths.

Medical error is the third leading cause of death in the US. Assisted suicide by telehealth will exasperate the problem.

Statements that are literally nonsense abound at Planned Parenthood

first-trimester surgical abortion, says Planned Parenthood to its prospective clients, uses suction to "take a pregnancy out of your uterus." This description is literally nonsense. "Pregnancy" isn't a thing in the womb that you can remove. Pregnancy isn't a thing at all. It's a state or condition of a woman during which she carries her developing offspring. Virtually everyone understands this. Every dictionary says it.

Is it possible that an organization called Planned Parenthood doesn't know what pregnancy is?

The more plausible explanation is that Planned Parenthood and others in the abortion movement have a serious problem acknowledging reality. And this problem seems worse now than ever.

How Planned Parenthood describes unborn humans

"An abortion ... kills the life of a baby after it has begun," wrote Planned Parenthood in a 1952 pamphlet.

That was then. After it began performing abortions, Planned Parenthood didn't want to call unborn humans "babies" anymore. After all, most people think that killing babies is wrong.

What about "embryo" and "fetus"? These are scientific terms for human beings during the prenatal (embryonic and fetal) stages of their development. Although the terminology may sound foreign or clinical (and thus is sometimes used in a dehumanizing way), it accurately acknowledges the existence of an individual member of our species. That's a fact of biology that's not in dispute.

But Planned Parenthood doesn't like to concede even this. Instead, the organization often refers to embryos and fetuses with words and phrases like "tissue," "uterine contents," and "products of conception." As descriptions of living human organisms (human beings), these are highly misleading and dehumanizing euphemisms.

Sometimes, though, Planned Parenthood takes euphemism to a whole other level.

Planned Parenthood: Babies don't exist

Terms like "products of conception" at least acknowledge that something exists that is acted on in an abortion. That's why the abortion is performed in the first place – there's something in the uterus that the abortion practitioner tries to remove.

Calling an unborn child "the pregnancy" is different because the word "pregnancy" means the mother's condition rather than the entity inside her womb. It's a way of pretending, as absurd as it is, that only the pregnant woman exists – there is no one with whom she is pregnant.

Likewise, Planned Parenthood vigorously employs terms like "women's health care" to describe the intentional killing of individuals who are not women. Planned Parenthood thus rhetorically subsumes these individuals under their mothers so that their fate falls within the domain of the mothers' health.

The group has recently extended this approach even beyond abortion. In the current debate in Congress over legislation to require equal treatment for newborn babies who survive abortion, Planned Parenthood, which opposes the bill, complains that such care would restrict "women's access to reproductive health care."

The legislation has no effect whatsoever on women's health. Their health care doesn't require the denial of health care to infants who are already born. So what on earth is Planned Parenthood talking about?

Instead of arguing for its position that abortion survivors shouldn't receive ordinary medical care – instead of calling them some dehumanizing label – Planned Parenthood is pretending that those newborn babies don't even exist. They are merely part of women. Only women and their health care exist.

This is the current state of Planned Parenthood's rhetoric.

Denying reality doesn't make it go away

In a 1995 essay, feminist writer Naomi Wolf, a supporter of abortion, criticized the abortion movement for its "lexicon of dehumanization" and its "reliance ... on a political rhetoric in which the fetus means nothing."

"Clinging to a rhetoric about abortion in which there is no life and no death," she wrote, "we entangle our beliefs in a series of self-delusions, fibs, and evasions."

Twenty-four years later, the rhetoric to which the abortion movement clings is even more evasive — and perhaps more desperate. It's a textbook example of Orwellian doublespeak. The purpose of doublespeak is to use language to obscure reality.

The reality Planned Parenthood aims to obscure is no mystery – it's the reality of the helpless human beings whom the organization routinely dismembers and kills. (The organization calls this process of tearing off arms and legs a "gentle" procedure "to empty your uterus.") Planned Parenthood wants everyone to pretend that those humans simply aren't there.

But they are. Denying reality doesn't make it go away.

Birthing People

By now everyone should know that the proposed budget from the current administration DOES NOT contain funding for the Hyde Amendment. That piece of legislation, included in every federal budget since its passage in 1976, is estimated to have saved the lives of more than two million unborn children. The administration has not commented on its absence in the budget bill, but the following quote might provide an explanation as to why.

This is part of the language in the public health section on maternal health:

"The United States has the highest maternal mortality rate among developed nations, with an unacceptably high mortality rate for Black, American Indian/Alaska Native, and other women of color. To help end this high rate of maternal mortality and race-based disparities in outcomes

"among birthing people," (emphasis added) - reads the 2022 White House fiscal year budget proposal. \$200 million dollars would be allocated for this purpose.

A reading of the full proposal shows that the language seems to bounce back and forth among "maternal", "women" and "motherhood", so it is difficult to be positively certain what the term "birthing people" is designed to convey. There are some who interpret this as embracing of the "cancel culture" evident in today's society. There are others who see it as embracing inclusivity of all


Prayer and Fasting

Dead Baby Bald Eagle Will Be Buried in Sacred Ceremony, But Babies Can be Killed in Abortions

merica has come to the point where baby animals are treated with more dignity and respect than baby humans.

In Colorado, for example, a five-week-old bald eaglet died last week after the tree it was living in split down the middle, according to CBS Denver. Local news outlets noted the baby bird's death and mentioned plans for its funeral.

Meanwhile, this same state allows unborn babies to be aborted for any reason up to birth. The hundreds of viable, late-term babies who are killed there every year never make the news, and few mourn their deaths. In the case of the eaglet, park officials at Standley Lake Regional Park said the bird's body will be cremated and buried "with a sacred ceremony in a blessed burial site located in Rocky Mountain Arsenal and National Wildlife Refuge," according to CBS Denver. The refuge was created for eagle burial by the Cheyenne and Arapaho Tribes of Oklahoma, Oglala Lakota and Southern Ute.

"Our hearts are heavy," park officials wrote on social media. "We mourn with all of you today and understand how painful it has been to watch the tragic events transpire at this nest over the last year."

Yet, there is very little mourning outside the pro-life movement for human babies who are intentionally killed in abortions. In Colorado, there are no limits on abortions, and the state boasts one of the few openly practicing lateterm abortionists, Warren Hern.

Colorado reported 171 abortions at 21 weeks or later in 2019, according to the Colorado Department of Public Health and Environment. However, a department official admitted that the number is almost certainly an undercount, and pro-lifers estimate the number is closer to 300.

Each of these babies was precious, unique and valuable. Evidence suggests most of them probably were healthy, capable of feeling pain and able to survive outside the womb. Abortion lobbyists admit that most late-term abortions are done on healthy mothers carrying healthy babies. According to research by the pro-abortion Guttmacher Institute, "most women seeking later terminations are not doing so for reasons of fetal anomaly or life endangerment."

The situation in Colorado is just one example of



society's mixed-up priorities. Another came out of New Jersey in 2019 when two pro-abortion lawmakers introduced legislation to protect unborn cows from being slaughtered. The same lawmakers have 100-percent pro-abortion voting records from Planned Parenthood, because they support aborting unborn babies for basically any reason without restriction.

A good society protects the vulnerable, but America is not doing that as long as it continues to allow the killing of babies in the womb.




