# Stop the Abortion Amendment!

A committee called Reproductive Freedom for All is working to amend the Michigan Constitution. Led by Planned Parenthood and the ACLU, this committee's amendment would create a new unlimited and unregulated right to abortion in our state.

This radical proposal is not about reproductive freedom, which already exists.

This poorly-worded amendment would repeal dozens of state laws, including laws unrelated to abortion. It could affect any law related to pregnancy and abortion and does not exempt minor children.

### The following state laws are at risk:

- Parental consent for abortion
- Ban on school employees helping children have abortions
- Laws requiring parental consent for medical treatment related to pregnancy, including sterilizations and hormone therapy
- Late-term abortion bans
- Screening for women being coerced to have abortion
- Health and safety requirements for abortion facilities
- Requirement that only doctors perform abortion
- Conscience protections for doctors/nurses who object to abortions
- Ban on tax-funded abortions
- Michigan's original 1846 and revised 1931 abortion ban
- Bans on statutory rape and incest
- Prostitution ban
- Ban on human cloning

### If They Say... You Say...

### A Guide to Talking About the Reproductive Freedom for All Abortion Petition

They Say: This amendment gives people the fundamental right to birth control without interference from the government.

They Say: This amendment ensures that women will not be prosecuted for having a miscarriage/abortion.

**They Say:** All individuals should have the right to access reproductive care.

**They Say:** Michigan citizens should have the constitutional right to abortion care and reproductive freedom.

They Say: "We believe that it is imperative to enshrine in our constitution that the right to comprehensive reproductive care, including the right to an abortion, remains in the hands of patients and their doctors." (From Michigan Voices Executive Director)

**They Say:** This amendment allows reasonable health regulations and standard of care.

You Say: There are no Michigan laws against birth control. There are no plans for future Michigan laws that would interfere with women having access to birth control.

You Say: There is no history of women being prosecuted in Michigan for either of those circumstances. The court case In re Vickers proves this point. In 1963, the Michigan Supreme Court heard In re Vickers, a case involving a woman who received an abortion and the doctor who performed the abortion. The court ruled that one who performs an abortion has committed a felony and the person receiving the abortion is not guilty and cannot be charged with aiding or abetting.

You Say: This amendment takes away the rights of the parents who have the responsibility to give consent in any other medical procedure. If abortion is healthcare and it's considered a medical procedure, what makes it different from all other medical procedures that parents are informed on?

You Say: All women have the right to reproductive care in the state of Michigan. Women have access to prenatal care, postpartum care, infertility care, and birth control. Pregnancy help centers provide care for women who are not able to see a doctor. Abortion is not reproductive care as it harms women mentally and physically, and it guarantees that out of the two patients involved, one will die.

You Say: With this amendment, non-physicians will be able to perform abortions, completely taking doctors out of the small picture they were already in. This new amendment will allow for doctors to not be involved whatsoever. Most abortions happening in the U.S. are done by the abortion pill, or a medical abortion. These pills can be bought online and shipped to your house without any consultation with a doctor to assess for ectopic pregnancies. Abortionists are also encouraged by abortion facilities to not connect with their patients as they are trying to fit as many women in the workday as possible. There have been countless stories of women going in for an abortion and reporting that the doctor didn't even make eye contact with them, ask them how they are feeling, or answer their questions when they had doubts.

You Say: The amendment specifically says any health regulation must "not infringe on that individual's autonomous decision-making." In other words, if someone wants to do anything related to abortion, sex, or anything related to pregnancy, they can do it. If a woman wants to have an untrained person provide them an abortion with rusty tools from a cheap abortion business, there's nothing health regulators could do about it—they couldn't even investigate it.

They Say: This amendment allows for restricting late-term abortions unless there is a health concern.

**They Say:** This amendment stops the government from prosecuting women who experience miscarriages.

**They Say:** This amendment allows the state to restrict/ regulate abortion after viability.

They Say: This amendment removes restrictions placed on abortion providers that are medically unnecessary and not based on best clinical medicine.

They Say: This amendment protects the rights of the LGBTQ community by allowing them to get the care that they need.

They Say: Signing our petition gives Michiganders the chance to have their voice heard and vote on the future of their reproductive freedom. You Say: The amendment creates broad exceptions to any late-term abortion bans, specifically mental health. Any person could claim not having a late-term abortion would impact their mental health, so no abortion would ever be restricted. In addition, there is no definition for what health means.

You Say: Millions of Michigan women had miscarriages when abortion was illegal in the state before Roe v. Wade, and they were not investigated for having miscarriages. This amendment is written so poorly that it would forbid even investigating infanticides or situations where babies were left to die following botched abortions.

You Say: This amendment changes the definition of fetal viability to no longer mean when the baby can survive outside the womb. The language within the amendment states that viability is when a baby can survive outside of the womb without "extraordinary medical measures." This means that an infant in the NICU who is only there for a few days could be considered not viable, allowing infanticide at the discretion of the mother and doctor.

You Say: Abortion is currently the only "healthcare" procedure that has constitutional protection. People do not have a constitutional right to get knee surgery. Abortion facilities receive one or more additional waivers to safety regulations and were exempt from regulations for years until 2012 when policies changed. The state puts safety regulations and restrictions on all medical facilities and most medical procedures. Physicians are required by the doctrine of informed consent to tell their patients all information relating to the procedure or diagnosis to ensure that the patient can make an informed decision. Michigan requires that abortionists provide written material that lists alternatives to abortion because they relate to pregnancy.

You Say: This radical abortion, anti-Michigan amendment harms children along with their parents by allowing unregulated clinics and schools to handout steroids and hormones to minors without consent from parents. These hormone treatments have permanent consequences that the parents should know about—including sterilization. This amendment eliminates parent's fundamental rights to care for the safety and wellbeing of their children.



## Noonan: Abortion has released a kind of poison into the air

eggy Noonan's "The End of *Roe v. Wade* Will Be Good for America" preliminarily assumes that the leaked first draft of Justice Samuel Alito's opinion on Mississippi's abortion law is what the final version will essentially look like" *Roe* (and *Casey*) are overturned! As many have pointed out, that may or may not be true, although pro-lifers fervently pray that it is.

While Noonan covers numerous aspects of *Roe's* awful impact on our culture, what I find most inspiring is her explanation for why she is pro-life:

I am pro-life for the most essential reason: That's a baby in there, a human child. We cannot accept as a society - we really can't bear the weight of this fact, which is why we keep fighting — that we have decided that we can extinguish the lives of our young. Another reason, and maybe it veers on mysticism, is that I believe the fact of abortion, that it exists throughout the country, that we endlessly talk about it, that the children grow up hearing this and absorbing it and thinking, "We end the life within the mother here," "It's just some cells" — that all of this has released a kind of poison into the air, that we breathed it in for 50 years and it damaged everything.

Yes, *Roe* changed everything. *Roe* undermined the moral obligation mothers — and fathers! — have to their unborn children. Like acid, Roe ate away at the foundations of our culture making abortion seem to be an acceptable "solution."

Yet, in season and out of season, pro-lifers are the eternal optimists. Why? Because we believe the better angels of our nature will not –cannot–be forever silenced. As a nation, we are better than turning a blind eye to almost 900,000 abortions a year would have you believe. Reminding our fellow citizens of this tragedy is among the most important tasks you do, day in and day out.

Noonan's conclusion is immensely powerful:

And if Roe is indeed overturned, God bless our country that can make such a terrible, coldhearted mistake and yet, half a century later, redress it, right it, turn it around. Only a thinking nation could do that. Only a feeling nation could do that. We're not dead yet, there are still big things going on here.

### Reproductive Freedom for All (RFFA) constitutional amendment petition in Michigan

 The Coalition of Citizens to Support MI Women and Children is comprised of Right to Life – LIFESPAN, Michigan Catholic Conference, Michigan K of C, Lutherans for Life, Protect Life Michigan, Right to Life of MI, Save The 1, and others. For a full list go to: www.supportmiwomenandchildren.org

- The RFFA amendment would:
  - 1. Remove parental consent for abortions and other medical treatments on minor children.
  - Remove protection for women being coerced into an abortion.
  - 3. Remove Partial-Birth Abortion ban.
  - Remove Born-Alive Infant Protection Act which requires medical treatment for infants who survive abortion
  - 5. Remove informed consent requirement for women seeking abortion.
  - 6. Remove the 24-hour waiting period for abortion.
  - 7. Remove conscience protection for medical professionals.
  - 8. Remove ultrasound requirement.

### **Pro-Life FDA? Agency Says Prenatal Tests 'Often False'**

n April 19, the U.S. Food and Drug Administration released a statement regarding non-invasive prenatal screening tests (NIPS) — news flash, they don't work.

NIPS tests are used to check if babies in utero have genetic abnormalities. Typically, the tests use a sample of blood from the pregnant mother and the results indicate a possibility that a child will be born with a health condition. These results are non-conclusive but women are trusting them and terminating perfectly viable pregnancies.

The FDA's Center for Devices and Radiological Health director, Jeff Shuren said, "While genetic non-invasive prenatal screening tests are widely used today, these tests have not been reviewed by the FDA and may be making claims about their performance and use that are not based on sound science."

Shuren noted that NIPS tests are often false and it's likely that parents may make inaccurate decisions about the future of their preborn baby. The NIPS tests are regularly marketed as "'reliable' and 'highly accurate,' offering 'peace of mind' for patients," according to the FDA's statement. In reality, they just screen for potentials and possibilities. They are not conclusive.

Surprisingly, the FDA's release affirmed the sanctity of life (other than using the word "fetus" to describe an unborn baby). "The FDA is aware of reports that patients and health care providers have made critical health care decisions based on results from these screening tests alone and without additional confirmatory testing. Specifically, pregnant people have ended pregnancies based only on the results of NIPS tests," the report concluded.

The Blaze News reported on the FDA's statement, writing on April 20 that "The New York Times reported in January that more than a third of pregnant women in America have sought the services of NIPS providers. The report revealed that as many as 80% of the screening results for rare genetic conditions were false positives, which led some women to consider seeking abortions when they had healthy babies."

Thanks to NIPS tests, women are killing their babies because they may have something like Down syndrome or DiGeorge syndrome (an abnormality that can cause developmental delays and defects) without even confirming their child has said conditions. God Forbid they have a child that isn't perfect.

Pregnant mothers have used the results of the NIPS



tests to aid their decision to terminate their baby's life "without understanding the limitations of the screening tests" and that their child may not actually have anything wrong with it.

NIPS tests promote the idea that babies with potential health issues have less value than those with normal results. The left has a tendency to diminish the life of the unborn and end said life when it's inconvenient. NIPS testing, and the media who promote them, want you to believe that aborting your perfectly healthy child, or even minorly "defect[ed]" child is perfectly acceptable.

These tests are a disaster. They do nothing except provide women with an "excuse" to abort their babies. Luckily, as The Blaze reported, Congress is working to give the FDA reigning jurisdiction over these tests to provide more transparency on the tests' efficacy. Let's pray that more people stop killing their babies when they don't want them. Kudos to the FDA for actually affirming all life.

### **Returning to the States the Issue of Abortion**

y now everyone has heard about the leak of the possible Supreme Court decision on *Roe v Wade*.

We have also heard all the threats, vitriol, protesting and even vandalism at pregnancy help centers coming from those who oppose the probable outcome of *Dobbs v Jackson*.

There are a couple of things to understand here. If the probable decision had not been leaked but announced, as is customary, in June, the protests and vandalism would have been the same. Those protesting, who in 1973, cheered and praised the members of



the court that found for abortion then, are now saying the Supreme Court needs to be changed, we need 12 or 15 or 17 justices (in other words "packing the court" with justices of their choosing). The difference is clear. The current court has recognized that *Roe v Wade* was erroneously rendered, there is no constitutional right to abortion, and the issue must be returned to the various states so the residents of those states can vote for what they want their abortion laws to be. That is how a democracy should function. The people decide how they will be governed and not a court that finds provisions in our constitution that are not there.

Members of our US House of Representatives and US Senate will offer impassioned speeches (trying to impress their constituents) and try to "codify" or make permanent laws, which permit unlimited abortion. They will focus on "reproductive rights", women's autonomy, the hard cases of rape, incest, genetic defect, poverty, etc., never once mentioning that a baby is killed in an abortion. The speeches will be entered in the Congressional Record, but it is not likely that any laws will be passed. In their efforts to achieve their goals, they claim that this decision will impact birth control, transgender education, same sex marriage, prison terms for women who miscarry, and on and on. These "red herrings" are LIES! NONE OF IT IS TRUE AND THE LEAKED DECISION SAYS, THREE TIMES, THAT THE DECISION DOES ONLY ONE THING AND THAT IS RETURNS THE ISSUE TO THE STATES.

The next consideration hits close to home. If *Roe* is overturned, the issue will return to each individual state. That is why, in anticipation of this, the abortion supporters in Michigan have launched a petition drive to amend the Constitution of the State of Michigan to allow for unlimited and unrestricted abortion in our state. It would undo all provisions pertaining to parental rights, waiting periods, conscience protection for health care workers—every common sense, protective laws enacted since 1973. They want to have a new law in place so that they can "get the jump" on a reversal of *Roe v Wade*. The leak of the decision may well give them an extra "boost" in trying to collect enough signatures to get the issue on the November 2022 ballot. **THIS IS WHY YOU MUST NOT SIGN THE ABORTION PETITION, NAMED THE REPRODUCTIVE FREEDOM FOR ALL**. The wording on the petition is vague and does not even say the word abortion, but that is its focus.

Please share this information with everyone you know. Show it to your pastors, people in your book club, your friends and family. It will be much easier to prevent this measure from getting on the ballot than having to defeat it in November.

### From the President's Desk

Dear Friends,

I feel like I found a time capsule, opened it and time stood still. I'm back in the seventies. The pro-abortion crowd is at it again. 
