

We were advised by Outfront Media, our billboard company, that our "Do Not Sign the Petition" billboard, referring to the Reproductive Freedom for All petition, was vandalized sometime over the 4th of July weekend. The billboard on the Lodge Freeway near Schaefer Road had been covered up. When Outfront's installer uncovered the billboard a couple of days later, he discovered that the billboard had been vandalized by drawing a mustache on the photo of the baby. He took down the billboard.

In response to this vandalism, Outfront Media has graciously offered to provide us with three digital billboards for one week for our "One Person Can Change the World" July Campaign even though this was in no way their responsibility.

Despite the *Dobbs* victory nationally, Michigan sits on the precipice if the Anything Goes Abortion Amendment passes in November. Do not regret sitting out of the most important moral battle of our times, BECOME INVOLVED TO-DAY!

Confused about the Current Status of Abortion in Michigan?

You aren't alone! Under current Michigan State Law, abortion is illegal in the vast majority of cases, yet abortionists continue to kill in our state. This is due to a court injunction which prevents Act 328 of 1931, also known as MCL 750.14 & 750.15, from returning to effect post-*Roe*. MCL 750.14 defines that anyone who provides a drug or substance or uses an instrument with intent to perform an abortion is guilty of a felony. Despite pro-abortion propaganda, this means the

abortionist is committing a felony and not the woman seeking an abortion. MCL 750.15 states that anyone providing, advertising, or selling a substance intended for procuring an abortion is also guilty of a misdemeanor. MCL 750.14 does allow abortions deemed necessary to preserve the life of the mother. The full law may be easily found at http://www.legislature.mi.gov/. The court injunction was issued by Judge Elizabeth Gleicher of the Michigan Court of Claims in Oakland County in response to suit filed by Planned Parenthood. Gleicher previously served as the losing attorney representing Planned Parenthood in a 1997 case in which the Michigan Supreme Court once again ruled there is no right to abortion found in the Michigan State Constitution. This echoed the ruling of the Michigan Supreme Court back in 1973. With Attorney General Nessel refusing to defend our state law, the State Legislature stepped in to appeal this decision to the Michigan Court of Appeals. In a separate action, Governor Whitmer also filed suit against the existing law arguing

What an emotional month this has been! Never in my lifetime did I think that *Roe v Wade* would be overturned! I am still in shock and speechless when it comes to describing my joy.

And, never in my lifetime, did I ever think that Pregnancy Centers would have all their windows broken and graffiti painted all over their buildings! Five local Pregnancy Centers (that I am aware of) have been vandalized - Dearborn Heights, Redford, Clinton Township, Southfield and Jackson. Shards of glass have covered their baby supplies and the group responsible has threatened that much worse violence is to come.

We cannot arrive early, depart late, or work weekends (that seems to be when they attack). We have the police keeping an eye on the building and as I said - we pray! Please pray with us!!

Throughout all of this, we have continued to help our precious babies - nothing will stop us and we continue to rejoice in the Supreme Court's decision!

Age Doesn't Determine Value

n 1973, the point of viability – the ability to keep a baby alive outside the womb – was about 28 weeks. Most infants at this age weigh slightly over two pounds.

Today, viability is 22-24 weeks gestation. The average weight of these babies is approximately 15.17 ounces at 22 weeks, 1.10 pounds at 23 weeks, and 1.32 pounds at 24 weeks.

Babies have survived even earlier.

It's rare but not unheard of that some infants have survived at 21 weeks.

A website has been documenting the births of very premature babies from around the world. Titled, The Tiniest Babies, it is sponsored by the University of Iowa Health Care and the University of Iowa Stead Family Children's Hospital.


The records date back to 1936, with the most recent entry from 2021. The information has been provided by lay media and medical journals. Or it has been submitted directly by a patient or family member with verification from the health provider.

It is well established that the gestational age is more important than the infant's weight when making a prognosis for survival. The registry supports this analysis. There were three babies born at 21 weeks who survived to go home from the hospital, compared with 26 babies born at 22 weeks. The youngest was born at 21 weeks 2 days.

The lowest weight of the babies was 212 grams, or 7.48 ounces which is less than a half-pound (.47). This baby was 24 weeks 6 days old when born.

Dr. Robin Pierucci, MD is a clinical neonatologist and medical director of a 50-bed neonatal intensive care unit (NICU). If you want to read an eye-opening piece regarding the unique challenges of caring for very premature babies, Dr. Pierucci has written a layman-level article on the topic.

At these early stages of development Dr. Pierucci has observed something that many of us are oblivious to. "I have witnessed that our personalities are present far earlier than many are aware. Even when born at a time when the internal physiology is more fetal than not, many premature babies arrive with an intact attitude."



Think about that for a moment, just over halfway through pregnancy babies can cop an attitude!

In this context, the Bible passage of Psalm 139:13-15 really comes to life. "For you created my inmost being; you knit me together in my mother's womb. I praise you because I am fearfully and

wonderfully made; your works are wonderful, I know that full well. My frame was not hidden from you when I was made in the secret place..."

Just how early did our personalities come to life? At this time, only our Creator knows.

The US Supreme Court's past obsession with viability when making sweeping life-or-death decisions has been disproven by the progression of science. Viability should never have been a determining point. Viability is only a measurement of man's ability to sustain life outside the womb, not a pronouncement of humanity.

As the window to the womb opens wider and wider, allowing more and more people to peer in, the prevailing consensus is that these are babies, and they need to be protected.

From the President's Desk

Dear Friends,

It has been over a month since the Supreme Court decided the *Dobbs vs Jackson Health*. I allowed myself to celebrate for twenty-four hours only. 
