HHS gives \$750k in COVID funds to Guttmacher to 'increase access' to abortion

Editor's Note: Your Tax Dollars at Work!!!

In another initiative to push abortion, the Biden administration has directed \$750,000 in funds to the Guttmacher Institute, the former research arm and “special affiliate” of the nation’s largest abortion business, Planned Parenthood.

The Department of Health and Human Services has announced a \$6 million total initiative to bolster research into abortion and family planning. The grants and guidelines were announced at a meeting of the Biden administration’s reproductive task force, following through on the Administration’s promises to promote and increase access to abortion.

The nearly \$1 million in taxpayer funds comes from Congress’ recent COVID spending, justified by the Biden administration due to the claim that the abortion industry experienced “service disruptions due to the Covid-19 pandemic and shifting policies and priorities,” The Federalist reports.

In its grant description, the Guttmacher Institute pledged to use the funds to find ways of advance its pro-abortion agenda. “This work will result in data and findings readily available for policy makers, clinical providers, and program planners to leverage when designing programs and policies to increase equitable access, especially for those most in need of publicly funded [sexual reproductive health] services,” the Guttmacher Institute’s grant says, as reported by **The Federalist**.

The grant comes on the heels of a Guttmacher Institute report that found, in the 100 days since *Roe v. Wade* was overturned as of October 2, at least 66 abortion facilities across 15 states have stopped committing abortions. With the new grant money, Planned Parenthood’s research arm will be able to analyze data and methods that can stem the losses and support the abortion giant’s bottom line.

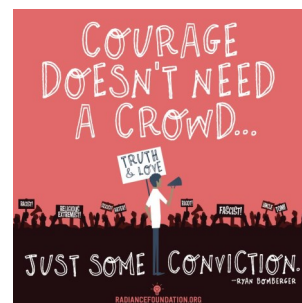
“They will tell you that many of the pregnant women in these states will just go to a clinic in a neighboring state to have their abortions. Some will. But something they aren’t anxious to admit may be



way more important — with the abortion clinic closed in their home state, many women will change their minds about seeking abortion and will choose to let their babies live,” said Dr. Randall K. O’Bannon, NRL Director of Education & Research, according to **NRL News**.

In the aftermath of *Dobbs v. Jackson*, the Biden administration has committed to pro-abortion activism and is employing federal agencies to challenge, roll back, and get around state pro-life laws. Shortly after the landmark Supreme Court decision, President Biden issued an executive order designed to expand the abortion pill; create an interagency task force to promote more abortion; provide increased incentives for federal employees, military members, and veterans to obtain abortions; and provide millions of dollars in federal grants to family planning groups. The president also marked Women’s Equality Day with a speech lamenting the *Dobbs v. Jackson* decision and issued a flurry of initiatives led by the Department of Health and Human Services to push abortion.

City of Greensboro in North Carolina admits pro-lifers' arrest violated First Amendment rights

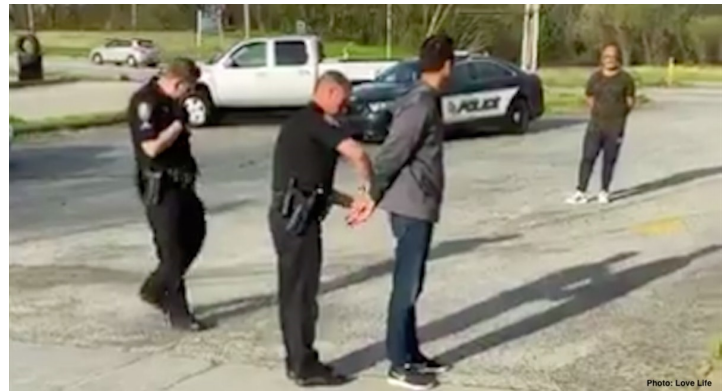

The city of Greensboro, North Carolina, has publicly acknowledged that it violated the First Amendment rights of a group of pro-lifers by arresting them outside an abortion facility in April 2020.

The group of Christians with the group Love Life were praying outside an abortion facility in March and April 2020, during the height of the Covid pandemic when they were arrested for violating public health orders. Despite the fact that the pro-lifers had followed mandates, including masking and limiting their group to less than 10 members, they were told that their First Amendment rights were not allowed at that time. They were also told that their arrest was due to the fact that they arrived in the city by car instead of on foot, and that they arrived from outside the county — though these restrictions weren't noted anywhere in public health mandates.

After the arrest, the group sued the city with help from attorneys from Alliance Defending Freedom (ADF). A settlement was reached in February, with the city agreeing to pay all of the pro-lifers' legal fees. Now, the city is admitting its error, agreeing that the pro-lifers had in fact been arrested for the "exercise of constitutionally protected First Amendment rights." It has also promised to guarantee future protections for the pro-life advocates should there be any more public health emergency mandates. In return, members of the group have agreed to forgo seeking further damages against the city.

"According to Greensboro officials, praying while walking was not allowed because of COVID-19. Clearly, this case was never about public health and safety; it was about the government silencing people because it didn't like what they had to say," said ADF Senior Counsel Denise Harle, director of the ADF Center for Life. "That said, we commend the city for finally agreeing to respect the free speech rights of Love Life members and acknowledge their

freedom to pray and speak in the public square, just like every other citizen's."

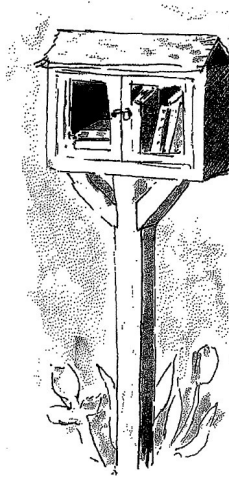

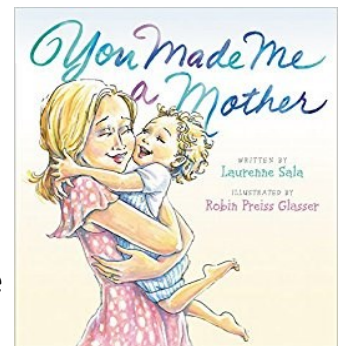

Survey of post-abortive women shows their emotional trauma

- T**he pro-life group Heartbeats conducted a survey of post-abortive women. They asked the women what they experienced after their abortion(s).
- 92% experience an emotional deadening, either feeling less in touch with their emotions or feeling a "need to stifle their emotions."
 - 86% have an increased tendency toward anger or rage (48% reported they became more violent when angered).
 - 86% fear others learning of the abortion and have a greater sense of fear in general.
 - 82% feel intense feelings of loneliness or isolation.
 - 75% said they are less self-confident.
 - 63% experience denial, the average period of denial that they reported was 5.25 years.
 - 56% experience suicidal feelings.
 - 53% increased or began using drugs and/or alcohol to deaden the pain.
 - 28% attempted suicide.
