



Throughout December and January, our educational church notes will share the key takeaways from Jason Negri's excellent talk at our Pro-Life Legislative Luncheon on effectively combating the push to legalize Physician-Assisted Suicide. Speaking of the Legislative Luncheon, the 2024 attendance was incredibly disappointing for a tremendous educational event. In 2025, we will return to an earlier morning event with a continental breakfast. This will allow us to offer very inexpensive tickets in case cost was an issue for guests this year. It is an educational event and not a fundraiser. We simply seek to break even while offering an informative program.

Even when elections go well, there remains a massive amount of work and prayer to achieve a society that values life. One example is voters in solid red Missouri choosing via referendum to promote abortion and overturn pro-life laws passed by their legislature. Another is closer to home. These notes originally were to announce our first ever restaurant fundraiser on December 18. We were all set and received official approval from Buddy's Pizza in Livonia. Over a week after being approved, Buddy's then cancelled the fundraiser without explanation. Whether Buddy's management is pro-abortion or simply scared of pro-aborts, we encourage our members to **no longer patronize** Buddy's Pizza.

#### December 7-8: Right to Life – LIFESPAN Everyone Needs a Medical Power of Attorney



Jason Negri, an expert on end-of-life issues, spoke at *LIFESPAN*'s 2024 Pro-Life Legislative Luncheon. His first focus was to safeguard yourself and your loved ones by documenting a Medical Power of Attorney as well as a Will and Financial Power of Attorney. A Medical Power of Attorney establishes your desire not to be deprived of food and water when incapacitated and safegurds this by naming a person you trust as the Patient Advocate who will make medical decisions on your behalf rather than simply defaulting to attending medical personnel. #### December 14-15: Right to Life – LIFESPAN Physician-assisted Suicide as Default Option?

End-of-life expert Jason Negri raised six main reasons physician-assisted suicide (PAS) is a bad idea we will cover in the next month The first is coercion. The mere availability of PAS makes it the default option for many patients and doctors. Along with coercion, if PAS becomes the new "standard of care" at the end of life, insurers and the medical profession will have no reason to continue to spend resources on effective palliative care. #### December 28-29: Right to Life – LIFESPAN Physician-assisted Suicide & Elder Abuse

Elder abuse is a growing problem, and the next reason legal physician-assisted suicide (PAS) is a bad policy. In Oregon, the state where PAS is most widespread, many patients fill a prescription for PAS pills, but never take them. Two people must witness consent to PAS and one witness cannot financially benefit, but one witness CAN financially benefit from death due to PAS. Nothing stops a close friend or romantic interest of a beneficiary from serving as the witness who does not financially benefit.
