



# The Abortion Accounts of 26 Women Weep with Pain and Regret and Remorse

When there is even an ounce of honesty in them, any series of accounts of women who have undergone abortions will accomplish exactly the opposite of what proponents of "telling your story" believe it will. Instead of "de-stigmatizing" abortion, what we learn makes the average person even more skeptical of abortion, even more convinced it is a horrible "choice."

A perfect example is a story in New York magazine (https://nymag.com/news/features/abortion-stories-2013-11/) which provided thumbnail sketches of the reasons 26 women had their abortion or abortions.

The overwhelming takeaway from Meaghan Winter's story for me was sorrow. Abortion's ugly truth is everywhere.

I was very much impressed with Winter's introduction. Take this paragraph, for example:

"And yet abortion is something we tend to be more comfortable discussing as an abstraction; the feelings it provokes are too complicated to face in all their particularities. Which is perhaps why, even in doggedly liberal parts of the country, very few people talk openly about the experience, leaving the reality of abortion, and the emotions that accompany it, a silent witness in our political discourse. Even now, four decades after Roe, some of the women we spoke with would talk only if we didn't print their real names."

Again, I completely understand that the whole point is that the more often women tell their stories, in theory the less "stigma" will attach. But it's not stigma that is running roughshod in many of their hearts but deep, DEEP regret. Which is why if you take the time to read all the stories, you come away aching for almost all of these women.

I will just cite three stories + a closing quotation from a fourth.

Right out of the box is "Nicole, 19."

Her story is so illustrative. She's convinced herself that by aborting their baby, it will show her boyfriend how much she loved him. It's clear she doesn't want the abortion.

The boyfriend goes back and forth—and forth and back. Nicole describes herself as "hysterical, and he said, 'Okay, you don't have to go back' [to the abortion clinic]. I was so happy. Then he said, 'We drove all this way. Stop crying, act like a woman.'"

She's tired and gives in. And then some of the most



remarkable 62 words you are likely ever to read:

"When I had the ultrasound, I asked for the picture and a nurse said, 'Seriously?' A month later, he said he regretted it too. When I cry about it, I cry alone. He thinks it would make me sad to talk about, but I don't want our baby to think we forgot. I've never heard of anybody else having an abortion here."

"But I don't want our baby to think we forgot." My eyes welled up the first time I read this, and they are again, now.

Another woman ("Red, 30") tells of not aborting her first unplanned pregnancy ("I decided I couldn't abort a baby based on a stupid decision I made").

The next time she does abort, even though the boy-friend wanted to get married. (She doesn't want to be "tied" to him "forever.") So she and her mother go [where else] to Planned Parenthood.

She writes,

"I told them I already had a baby. The doctor acted like it was assembly-line work. I told Steve I miscarried. We dated another year. The secret was devastating. People might be more understanding if I'd had an abortion when I was living in a car in an abusive relationship. This time, I was on birth control, with a full-time job, a boyfriend. People might think I should've kept it, but I couldn't."

One other story ("Heather, 32"). She'd already had two unplanned pregnancies "and it never, ever, occurred to me to terminate those pregnancies." Now she's had two abortions. Heather writes of the first abortion that

My Mom, Eva Louise Beaton passed away February 3, 2022 at the age of 94. I lived with her for almost six years after my father passed away so that I could take care of her. After she died, I was in charge of packing things up, donating items to family, St. Vincent de Paul, Salvation Army, and Habitat for Humanity. So once all the furniture, clothing, pictures, dishes, silverware and mementos were gone, there was one last very special item that I needed to figure out what to do with and that was her beautiful satin wedding gown from 1951.

I had it cleaned and pressed thinking that I would surprise my niece who was getting married this June with the dress that she could wear for her wedding. Turns out, it wasn't really her style and she had other plans so I still had to figure out what to do. I happened to mention it to a friend of mine at a birthday party for her mother and husband. My friend said that her niece worked for a hospital that had a program called Angels Above Baby Gowns that accepts wedding gowns and when she told me what they did with them, I almost started crying. She said they use the gowns to make tiny outfits for babies that are stillborn, miscarried or have died shortly after birth to present them to their parents as a respectful expression of love. I knew my Mom was smiling when I dropped the gown off and could hear her say, "Grandma Eva loves you little ones"... In Your Honor, your daughter, Colleen

### **Pray for Ohio**

In depressing news, Ohio's Issue 1 was defeated 57%-43% on August 8 by voters. The result somewhat surprises with how "red" Ohio has voted in recent elections. Issue 1 would have required 60% of affirmative votes to pass any future amendments to the Ohio State Constitution. This is a prudent policy under any circumstance (The Founders required <sup>3</sup>/<sub>4</sub> of states to ratify amendments to the U.S. Constitution), but it was proposed under the specter of an upcoming November ballot issue to amend the Ohio Constitution to promote abortion for all 9 months without limits. Sound familiar? Issue 1 passed with the support of the major urban and suburban counties of Ohio and pro-Issue 1 Ohioans were vastly outspent by the dishonestly named One Person One Vote group of abortion activists. One Person One Vote spent \$15.9 million on ads with \$13.7 million coming from outside Ohio. A group of wealthy pro-abortion coastal elites seeks to impose their will on a Midwestern state. Sound familiar? Yet this does not absolve ordinary Ohioans of actively making the choice to vote for Evil. It now seems a fait accompli Ohio will join Michigan in voting to kill babies in the womb all the way up to birth, but we must pray for a miracle that our brothers and sisters in Ohio may be delivered of this result in November! God Save America!

# How do you respond to those who say that taking mifepristone is "safer than taking Tylenol"?

ditor's note. Chemical abortions ["medication abortions"] now account for the deaths of over 50% of the babies lost to abortion. There are many reasons for the huge increase but likely at the top is the blatant lie that "medication abortions" are "safe" and, indeed, "safer than taking Tylenol."

We asked Dr. Randall K. O'Bannon, NRLC's Director of Education & Research, to address this defense of the first of the two drugs that make up medication abortions.

Considered in terms of deaths per dose, it simply isn't so. What you have here is a not-so-clever statistical sleight of hand. Advocates try to get you to compare the number of deaths from a relatively lightly used product with one that is used billions of times by people every year.


We are told that about 150 American die from Tylenol use every year, usually by overdose or simply taking too much over an extended period of time. At the same time, the FDA tells us that there have been 28 deaths that we know of among American mifepristone patients since the drug was approved in 2000.

So, 28 deaths from mifepristone in twenty years against 150 deaths from Tylenol in just a single year's time? Sounds like mifepristone is safer.

But wait. That's 150 Tylenol deaths against a backdrop of 25 billion doses of Tylenol in a year. We're told that there have been only 5.6 million total chemical abortions with mifepristone in the U.S. since that 2000 approval. That is less than a thousandth of the sales of Tylenol in a single year.

Note what this does to your risk factor.

Using the minimal figures provided by the FDA, your risk of dying from taking mifepristone is about 1 in 200,000. Not large, but not negligible. And



remember that your risk of a complication putting you in the emergency room is closer to one in 10.

But your risk of death from Tylenol is actually something like one chance in 166.7 million, even including those who overdose and fail to follow the manufacturer's instructions.

This means that your risk of dying from mifepristone is about 833 times your risk of dying from Tylenol!

The statement that mifepristone is safer than Tylenol is clearly false.

"I just had to shut my conscience down. The doctor was grotesque. He whistled show tunes. I could hear the vacuum sucking out the fetus alongside his whistling. When I hear show tunes now, I shudder. Later, he lost his license."

Then

"A few months ago, I got pregnant again. My inlaws have been helping us out financially, so we have no choice but to involve them in our decisions. They gave us \$500 cash to bring to the clinic. I felt very forced. I felt like I was required to have an abortion to provide for my current family. Money help is a manipulation. I'm crazy in love with my daughters—imagine if I did that to them? It's almost too much to open the door of guilt and shame because it'll all overcome me. In the waiting room, there was a dead silence that's hard to describe. Everyone was holding in her emotions to a heartbreaking degree."

Heather ends,

"Truly pro-life people should go light on the judgment, because shame motivates abortions."

Pro-lifers already do go "light on the judgment." The pro-lifers I know — and I know many — are a tender-hearted lot. More than a few have experienced an abortion in their extended families.

But whether or not they have a personal experience, they have the same objective: to help a post-abortive woman heal, not to further hurt her. How could going "heavy" on the judgment possibly help anyone or accomplish anything?!

Over and over again, the stories weep with pain and regret and remorse.

Perhaps the most revealing comment of all came from "Alex, 24," who began her story

"I'm pro-choice, but for some reason I still hold a stigma for people who've had multiple abortions, and yet I've had multiple."
