

# Michigan Legislature Introduces Sweeping “Reproductive Health Act,” Threatens to Remove Longstanding Protections for Women and Children

*By Right to Life of Michigan*

On August 30, Governor Whitmer announced the re-introduction of the previously failed “Reproductive Health Act” (RHA), which in the past has included the removal of informed consent, abortion clinic regulations and parental consent for abortion.

On September 6th, the RHA was formally introduced in the Michigan House by pro-abortion Democrat legislators. The bill package calls for the repeal of many longstanding health and safety regulations related to abortion, regulations which continue to enjoy the broad support of Michigan citizens, including the majority of those who voted for Proposal 3. The “Reproductive Health Act” includes removing the following: Abortion clinic licensing regulations, informed consent provisions which include a 24-hour waiting period, the Medicaid funding ban, partial-birth abortion law, born alive infant protection law, humane disposal of fetal remains, abortion reporting, and more. It also redefines “abortion” in state law as a medical treatment and removes the term “elective.”

Finally, it codifies into state statute the language of Proposal 3 creating a statutory right to abortion (in addition to the constitutional right) and allows for civil penalties for entities who infringe on those rights.

Previously introduced RHA bill packages from 2019 and 2021 called for the repeal of parental consent related to a minor child seeking an abortion as well. While the removal of parental consent is not currently in the package, the proabortion leadership has stated its intentions of eventually repealing the law.

Now is the time to take immediate action by reaching out to your state legislators, no matter their political affiliation, and tell them to vote NO on the “Reproductive Health Act.”

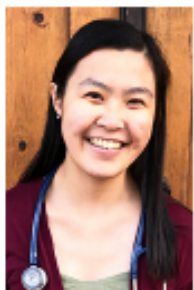

## Mom With Brain Cancer Refuses Abortion: “Killing My Baby Wouldn’t Have Saved Me”

Just over a year ago, 30-year-old mother Tasha Kann was diagnosed with a brain tumor called Anaplastic Astrocytoma Grade III, a rare and malignant form of cancer. Tasha was approximately 20 weeks pregnant with a healthy baby girl.

Doctors informed Tasha that her best chance of survival and more time was to abort the child and immediately begin chemotherapy and radiation. However, Tasha didn't want to end her baby's life, even if it meant her own life would come to an end sooner.

“I didn't know what really to think. I guess in my mind, brain cancer, I thought I would die. To be honest, I thought I would anyways. So I thought I would just keep my baby alive,” said Tasha.

Tasha believed that there was a safer route, not only herself, but for her baby as well.

According to Tasha's GoFundMe, “After much research and many prayers, Tasha decided her best outcome from this disease would be to continue her pregnancy and fight it as naturally as possible, refusing chemo and radiation.”

Gracey Joyce Kann was born last October. She was as healthy and cute as could be, and the Kann family fell in love with her.

Tasha's cancer had been growing from her central nervous system and is diffused into three lobes of her brain. It is now



considered to be a Gliomatosis Cerebri, which is highly aggressive and very resistant to treatment. Surgery is not an option, and the prognosis lessened from years to months for Tasha. The prognosis was 12 months, and Tasha is now at 14 months.

In a new interview with Fox News, Kann recalls her journey.

Kann said she still vividly recalls the moment that a group of three doctors entered her hospital room and stood at the foot of her bed.

**T**hese summaries were received from some of the youth we sent to the Protect Life Michigan Life Advocate Intensive Training in August 2023.

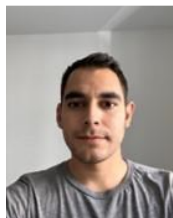

and listening to their various Outreach stories was truly inspiring. Engaging with people on the streets about abortion during Outreach went much smoother this year, thanks to my familiarity with the arguments.

The event significantly improved from the previous year, and I thoroughly enjoyed spending time with my old friends and with the people I met during the event. The shared passion and experiences created an atmosphere of unity and enthusiasm, and whether sharing stories, discussing strategies, or simply enjoying each other's company, every moment was memorable.

After the event, I experienced a strong surge of enthusiasm in advocating for the pro-life movement. From what I've experienced, I highly recommend other students to participate in this event because it might change your life for the better. The Life Advocate Intensive was a grounding and educating experience to prepare us to protect our preborn children.

The training started with inspirational speakers providing honest guidance reminding us why the unborn need our help, how we can help, and

why our strategy is the most effective way to protect them. Following that session, a lecture on apologetics taught us techniques to connect with people on abortion, develop a common ground, and calmly guide them to reach the life-protecting message to stop abortion through their own understanding. This helped prepare all of us for the Abortion Victim Photography outreach in downtown Grand Rapids. We then debriefed and discussed our conversations.

The following two days followed a very similar structure, guiding us each time to be more effective during our time on the streets. This training taught us how to best protect the unborn, and helped bring up a deep purpose as to why we are doing this. The Protect Life Michigan Life Advocate Intensive training was an incredible experience. After being invited by Luis, I recruited a few of my girlfriends from church and asked if they'd be interested in joining me at this event. We truly had no idea what was in store for us when we walked in and were greeted by the PLM team.

The event was intense in every sense of the word. I'm comfortable saying that we all felt unprepared and unworthy to be advocates for life at the beginning but left with tons of factual information about the atrocity of abortion and skills that equipped us to effectively communicate these facts to others. Along with the intellectual impact the weekend had, our hearts were pulled in every direction. I distinctly remember conversations I had with my friends at the end of each day: "I think I just need some time to pray" or "It's going to take me a while to process everything that happened today/this weekend" or "I don't understand how people can ignore what abortion is". However, these seemingly unsettling emotions pulled us close together. Completing the day's more serious work gave us time to grow in fellowship, make new friends, play games with each other, and simply enjoy being around others who also are passionate about saving the preborn.

A group of us, many that *Right to Life - LIFESPAN* sponsored, grew particularly close and our group text remains active today. It's amazing to see the way that God works through ordinary people to achieve the perfect will he has for the world. I'm incredibly grateful to Lynn Gura and to *LIFESPAN* for sponsoring me during this event and I'd encourage your team to continue sponsoring other young people so they can have similar experiences as what I did. Over the course of the 3 days of training, they saw...

- **62 Students** trained and deployed to lead outreach.
- **310 conversations** with pro-choice people.
- Of those, **57 people verbally** confirmed that they became more pro-life
- And **45 people** verbally confirmed that they are now pro-life (opposed to abortion in all cases)
- They also reached **19,849 people** with the reality of abortion.
- **19 students** signed up to intern with them next summer

How do we counter the lies of the pro-aborts and progressive liberals trying to change everything we hold dear in this Country - especially protecting human life from those who do not see the preborn child as a human being?

I do believe this is the question for the next 10 years and beyond for those of us in the pro-life movement.

I recently spent time with a family member who is an atheist, a progressive liberal, and a radical pro-abortion advocate. She

does very little reading and her go-to stations are CNN, ABC, NBC, and CBS. She had no use for Newsmax or Fox News. At one point in a discussion, I asked if she believed in abortion up to nine months. Her comment was "only a woman should have a right to choose"! I then commented; "Do you believe she has a right to abortion in the 8-9 months?" Her answer was "that is not happening and of course she would not agree to that". It became so obvious to me that she had no idea what was happening, and she chose to keep it that way because it was easier for her. She wants abortion rights and nothing else matters - especially truth.

It started me thinking about how many others are like her. I soon realized no matter how much time I spent trying to educate her, the only thing that matters was her freedom to do what she wanted regardless of truth.

This family member is a part of the 40% in our country who will never change their minds. Just as there are 40% who believe abortion is wrong and working hard to overturn the laws that allow killing of are preborn citizens. This has been a pretty consistent statistics over the 52 years of this movement (give or take a few points change throughout these years).

So how do we reach the 20% that could be educated in the truth? That is the million-dollar question. These are the people that are reachable.

We reach them by doing what we have done for the past 52 years - we speak out with the truth, no matter what the consequences. You may be laughed at, criticized, told you are exaggerating, spit upon and maybe arrested - don't let that stop you from trying. You may never know the person you reach or the minds you change just by speaking out. I do not advise wasting your time and effort on those who you can't change. Spend this time speaking to your children, grandchildren, and their friends. These are the reachable demographic at this time in our country. Spend it when they are in middle school and high school because if they don't know the truth by that age they will certainly be influenced adversely in college. Give a baby feet pin (available at your LIFESPAN Chapter). Challenge them to find out when human life begins. Or just listen to them about what lies they are getting and give them the truth.

If we don't do it, who will?

"I told them absolutely not," Kann said referring to the abortion.

More than a year after her diagnosis — defying the doctors' predictions — she is still alive.

"I was a little scared, but I never lost hope," Kann said of her diagnosis. "I knew I had to be strong for my baby."

When making the decision about her care, Kann said her faith was the biggest factor.

"Aborting my baby was never an option to me because it goes against God's will," she said.

"I had many deep conversations with Jesus that week in the hospital, and knew that if I held onto the Lord and his promises, he would keep my baby safe."

Kann has no regrets as she now fights her own medical battles.

"Every single day, I look at my beautiful baby and think about how easy it was for them to tell me to abort — like she was nothing," Kann told Fox News Digital.

"If I had listened — like most patients do, because they trust their doctors and don't do their own research — my baby wouldn't be here," she said. "It's a miracle from God that we are both here."

Kann is now getting expensive immunotherapy that will cost over \$100,000 for the year.

"The oncologist said she doesn't know how it's possible I'm still alive," Kann said. "How can there be any other answer than our Lord and Savior Jesus Christ?"

Tasha Kann's story shows how abortion **does not** have to be a necessary choice for women. Instead, Tasha chose to research her options and decided to save her baby, who is now eight months old. By doing so, she protected herself from treatment that could have resulted in her death, and she protected her baby from abortion. Her community and family has always been and always will be there to support her. And she is not giving up.
